a. New Orleans & Company and FQMD "General Operating Funds" (Shall incorporate the former New Orleans Tourism & Marketing Corporation contract income for general operations) expiration date: 1/22/2020

Was not renewed due to financial impact of COVID-19

b. City of New Orleans, Convention & Visitors Bureau (New Orleans & Company) and FQMD expiration date:12/31/2020 for expenditures of the Hotel Assessment

Was not renewed due to financial impact of COVID-19

c. French Quarter Museum Association expiration date: 12/31/2020

The Board Chair is extending the terms of the existing CEA until 6/30/2021 or until a new CEA can be negotiated.

2. Resolve next steps with Louisiana Civil Service enrollment requirements Was completed this year

V. Discuss 2021 committee goals

1. Reintroduce the French Quarter Economic Development District sales tax for supplemental safety with the funds coming to the FQMD through a ballot initiative in April

- 2. Work on state funding through the Lt. Governor's office
- 3. Work towards permeant state funding through the legislature
- 4. Explore grant opportunities for additional funding
- 5. Negotiate a new Cooperative Endeavor Agreement with the French Quarter Museum Association

Ms. Rosenberg made a motion to adopt these committee goals for 2021. Ms. Cooper seconded the motion, and the motion was approved.

VI. Update on the French Quarter Economic Development District

The French Quarter Economic Development District has called a special meeting to approve the Notice of Intent to reintroduce a sales tax of .00245% for programming for POST Certified proactive patrols and homeless assistance programs embedded within the New Orleans Police Department.

VII. New Business

The FQMD Board Chair is sending a Letter Agreement to the Mayor today to extend the terms of the expiring Cooperative Endeavor Agreement for six months or until the Supplemental Police Patrol Program account is exhausted, whichever comes first, to keep the SPPP running.
