2. Public Comment

No public comment was received.

3. Approval of previous meeting notes

Mr. Zumbo moved to approve the previous meeting notes. Mr. Watters seconded motion and it was approved.

- 4. Discussion of the French Quarter Economic Development District
 - a. Report on ballot language approved by City Council for April 24th election:

"Shall a .245% increase in the sales tax be levied within the boundaries of the French Quarter Economic Development District ("FQ EDD") (with the exception of such a levy on hotel rooms) to be collected on the sale at retail, the use, the lease or rental, the consumption and storage for use or the consumption of tangible personal property and sales of services within the boundaries of the FQ EDD for a period of five years, beginning May 1, 2021 and ending April 30, 2026 (an estimated \$2 million reasonably expected at this time to be collected as a result of the levy per year) for the purpose of funding POST Certified supplemental police patrols and homeless assistance services, with the initial \$2 million collected in any year dedicated to supplemental police patrols and any additional revenue to be divided between additional patrols and public

safety programs (including homeless assistance), and administered by the French Quarter Management District for fiscal and operational oversight of the FQ EDD Trust Fund and services provided by such fund and subject to quarterly budget and expenditure reports to the City Council, to facilitate economic development within the FQ EDD?"

Ms. Frankic will research other items that will be on the April 24th ballot.

- b. Creation of Key Performance Indices for Supplemental Police Patrol Program (SPPP)
 - Public Budget Process per Local Government Budget Act, R.S. 39:1301
 - Annual Legislative Audit
 - Within 90 days of revenues collected, FQMD reserve a minimum of one month of budgeted operating expenses to protect City General Operating Fund from hours worked by Patrol Officers and NOPD Fulltime Coordinator
 - Monthly SPPP Account Income & Expense Report and Balance Sheet presented at Board Meetings, and Revenue collected to personnel deployed reported
 - Quarterly reports to FQEDD (City Council)

Mr. Watters moved that the discussed Key Performance Indices for fiscal oversight be recommended the Board of Commissioners for inclusion in the Cooperative Endeavor Agreement that will govern the French Quarter Economic Development District Trust Fund.

- c. Creation of new SPPP Budget
 - The Committee Chair, Vice-Chair and Executive Director will work on drafting for the committee to discuss at the next meeting. Ms. Frankic will inquire of the City how long after the 2015 election were sales tax revenues used to pay for the Louisiana State Police
- 5. Review of public relations firm research and discussion of recommendation to Board of Commissioners
 The committee discussed if there is a need for a public relations firm for voter education related to the French Quarter
 Economic Development District Sales Tax referendum. The Chair and Ms. Cooper will provide additional details on scope
 of work from Gamble Communications and The Ehrhardt Group to present to the full board of commissioners. Ms. Frankic
 will verify that this is a qualifying expense under the enabling legislation, revised statute and/or attorney general's opinions.
- 6. New Business

The Chair reminded members of the 50% attendance rule and that the Vice-Chair would be calling to discuss attendance with the members that have fallen below that threshold.

Ms. Frankic will circulate the commissioner appointing dates to the Board at the request of Mr. Watters.
