## 4. Update on the French Quarter Economic Development District

## a. Discussion of Cooperative Endeavor Agreement

Ms. Frankic reviewed the attached work plan noting progress made over the past month by the FQMD committees and technical updates to the ballot language by the City Council at the request of the State Bond Commission. Mr. DeBlieux reported that the draft Cooperative Endeavor Agreement (CEA) was sent to the City and FQMD is awaiting their response. The committee discussed the need to have the CEA approved by the mayor and council and before the voters well before the vote.

# b. Discussion of voter information campaign

Ms. Frankic reported that the Finance & Development Committee recommended against hiring a Public Relations firm to avoid any perceived conflict with the state constitution and revised statute that forbids using public funds to lobby a position on a referendum. This includes use of the website or any apps paid for by FQMD being used to advocate for or against a ballot item. The committee discussed working with the administration and stakeholder groups to host joint informational townhall meetings.

# 5. Discussion of Louisiana State Legislature funding strategy

Mr. Bilbe and Ms. Cooper will meet next week to discuss a plan for working with the State Legislature to secure operating funding for FQMD.
