2. Public Comment:

Ms. Mulla McGovern moved to **Approve the July meeting notes**. Mr. Zumbo seconded the motion, and the motion was approved.

4. Motion – Consider approval of a Motion recommending authorizing the Board Chair to execute a revised tripartite cooperative endeavor agreement that shall govern the collection and disposition of the .245% French Quarter Economic Development District special sales tax.

The committee reviewed the Attorneys' recommended revisions for the previously FQMD Board approved cooperative endeavor agreement. Ms. Frankic reported that she was assured in writing by both a City Attorney and the Council's Attorney that they would not be requesting additional edits. She also reported that the Board's attorney provided the following guidance: The edits that Adam [Swensek] sent on Friday evening are fine with me. As is typical, they have included language that is unnecessary, but it is not violative of the law and does not add/pose any additional liability [to FQMD].

Ms. Cooper moved to Recommend to the Board of Commissioners authorizing the Board Chair to execute a revised tripartite cooperative endeavor agreement that shall govern the collection and disposition of the .245% French Quarter Economic Development District special sales tax. Mr. Zumbo seconded the motion and it passed unanimously.
