- F. Assure Patrol Officer carry a FQMD provided, GPS enabled, smart phone to be reachable by Constable Pincus, the Eighth District Commander, and FQMD.
- G. Provide schedule of patrols with times, and Patrol Officer names to FQMD on a weekly basis.
- H. Collect and review all trip sheets and provide to FQMD with disposition data points to include:
 1. Business Checks
 2. Citizen Contacts
 3. Subjects Moved
 4. Arrests
 5. Apprehension
 6. Citations and Summons issued
- I. Attend monthly meetings of FQMD's Security & Enforcement Committee Meeting to provide brief report.
- J. Call weekly with FQMD's leadership, including Executive Director, and/or Security & Enforcement Committee Chair and/or Vice-Chair, and/or Board of Commissioners Chair and/or Vice-Chair to review data points, patrol plan amendment, hot spots, public feedback, etc.
- K. Priorities for Zone 6 patrols include: providing a visible police presence to deter aggressive panhandling, inebriants, and illegal sales, with a goal of fostering a clean and safe environment for the community.
