2. Public Comment:

No written public comment or request for live comment were received at the conclusion of the reading of the agenda.

3. Approval of previous meeting notes

Mr. Caputo made a motion to approve the previous meeting note. Mr. Bilby seconded the motion, and it was approved.

4. Committee Chair's Comments

The French Quarter Management District is a state entity created by the Louisiana Legislature as a means for the residential and business communities to work together to protect, preserve, and maintain the world famous French Quarter as a safe, clean, vibrant and friendly neighborhood for residents, businesses, and visitors.

French Quarter

a. Presentation of 2022 Work Plan

- 1. Work with NOPD to reduce illegal guns within the district, including enforcement of Drug Free Zones
- 2. Understand who manages the bollards on Bourbon Street and the traffic barricades on Royal Street and work with them to make them operational or remove them.
- 3. Develop a list of actionable items from FQMD's French Quarter Physical Security Assessment
- 4. Oversee effective performance of the French Quarter Economic Development District Supplemental Police Patrol Program (SPPP) commonly referred to as the French Quarter Task Force
- 5. Work with the NOPD Eighth District to implement the expanded Royal Street Patrol and measure results
- 6. Locate and share credible data on the economic impact of the French Quarter
- 7. In conjunction with the Livability Committee, identify 1-2 action items from FQMD's Needs Assessment of Street Homelessness and implement them.
- 8. In conjunction with the Livability Committee, execute a plan to quantifiably improve lighting in the French Quarter

5. Presentation – Presentation on City Safety Coordination

a. Update on Supplemental Police Patrol Program Vehicle Procurement. To present: Brian Firstly, City Deputy CAO EMD

Mr. Firstley reported that the City buys vehicles through the State's Fleet program directly from the manufacturer. Vehicles coming out in 2023. Microchips are the hold up with the manufacturers. Ms. Cavett reported on the French Quarter Citizens effort to have four vehicles donated by New Orleans & Company.

Ms. Cooper reported action items from the FQEDD Agreement Monitors meeting.

b. Update on status of Bourbon Street Bollards. To Present Eric Smith, City CAO Analyst

Mr. Smith reported that the bollards are the maintenance responsibility of the Department of Public Works and maintenance has been a long-standing issue. The City is looking at a citywide program for crash rated bollards. The Department of Sanitation previously moved the barricades, but they have not been workable with the current bollard system. The City is looking at options for replacing the current system. Mr. Caputo

asked that the broken bollards be removed while the City figures out the long-term plan. <u>Mr. Smith will report</u> back next month.

- 6. Presentation Presentation of Eighth District Commander's Updates. To present Captain Hans Ganthier Captain Ganthier introduced himself as the new Commander of the NOPD Eighth District. Lieutenant Palumbo reported that in the last month there had been one homicide, cleared with a warrant, and one shooting. He said for property crime there was one burglary, 14 auto burglaries, lower than last year, 13 vehicles thefts, which is on par with previous years. There have been no carjackings in the French Quarter.
- Presentation Presentation of Eighth District Crime Statistics and the Supplemental Police Patrol Program.
 To Present: Sergeant Marc Boudreau

Sergeant Boudreau reported that the SPPP responded to 192 app calls, 1622 self-initiated calls, and 42 dispatch calls for service. The patrol officers made 3 arrests, 5 apprehensions, wrote 1 summons and 2 traffic citations, made 229 business checks, 435 citizen contacts, and moved 168 subjects. The officers patrolled 5083 miles and 88% of available shifts were filled. The SPPP is using 2 patrol vehicles on loan from the 8th District and utilizing officers take home vehicles. That means there are 119 shifts available at this time, 103 are permanent shifts by the pool of 27 officers and there are 16 new offices on a basis. There will be more shifts available once the New Orleans & Company vehicle donation is complete.

 Discussion – Discussion by Committee of the Supplemental Police Patrol Program App Request for Proposals

The City is required by procurement law to put out a request for bid for contracts. Committee Chair Cooper asked for two committee members volunteer to help her compile a list of capabilities for the app on behalf of the City, at the request of Mr. Smith. Mr. Smith asked that the list be ready by the February meeting. <u>Ms. Cooper will work with the volunteers to have a list of app capabilities to the committee at the next meeting.</u>

 Presentation – Presentation on the status of the expansion of the Royal Street Patrol. To present: Jane Cooper

Ms. Cooper asked Ms. Frankic to report on the Royal Street Patrol. Ms. Frankic reported that FQMD approved the CEA with New Orleans & Company for the expansion at the end of November. Since then, Superintendent Ferguson reached out to FQMD regarding concerns. 1. Officers will report into Orleans Parish Communications District when they came on and off of shift 2. If there is an arrest made, the non-NOPD POST certified officer would make the apprehension and call NOPD to complete the arrest 3. If there is a use of force by a non NOPD officer, that officer's agency would complete the investigation. FQMD met with him three times in the past month and have revised the

agreement to reflect those concerns and are awaiting the signed amended CEA from NO&Co. These three items have been included in the service agreement with Public Safety Services Corp, the company of Constable Matt Pincus, and should be executed shortly. Mr. Caputo asked if it is feasible for the patrols to be running by mid-February.

10. New Business– To consider and take action upon any other matters that may properly come before the French Quarter Management District Security and Enforcement Committee



1.0 The Supplemental Police Patrol Program

The French Quarter Supplemental Police Patrol Program (aka the "French Quarter Task Force" or "Program") is a program of the French Quarter Management District ("FQMD") that is operated, and made possible, through a cooperative endeavour agreement between FQMD, the French Quarter Economic Development District (FQEDD) and the City of New Orleans, including the New Orleans Police Department ("NOPD").

The Program uses off-duty NOPD officers ("Overtime Officers") to perform two types of patrols, Blue Light Patrols throughout the French Quarter ("Program Area") to provide a visual police presence on the streets of the French Quarter to deter crime and enhance public safety, and Traffic Enforcement Patrols to enforce the City's Oversize Vehicle and other traffic ordinances in the Program Area and assist the Blue Light Patrols when necessary. All Overtime Officers perform their duties under the supervision of the Commander of the NOPD 8th District.

Blue Light Patrols and Traffic Enforcement Patrols are conducted by Officers driving a small black vehicle or a Polaris ATV. Patrols are limited to the Program Area, depicted in Figure 1, and five (5) Patrol Zones. Zone 1 is the Lake side of the French Quarter. Zone 2 is the River side of the French Quarter. Zone 3 is the Down River section of the French Quarter. Zone 4 is the entire Program Area, i.e., the French Quarter. Zone 5 in Bourbon Street from Cnal St. to St. Ann St.



Figure 1 – Program Area and Patrol Zones

Under the Program, the SPPP Supervisor provides a monthly shift schedule to FQMD and FQEDD of the Overtime Officers that will work patrol shifts in the Program Area. These Overtime Officers report for duty at the SPPP Office located on the ground floor of the NOPD 8th District Station to receive shift assignments and instructions, obtain an iPad, and obtain vehicle assignment and a Body Worn Camera (BWC). Overtime Officers are required to follow the Post Instructions specific to the patrol identification number the Overtime Officer is assigned to work except when the 8th District Commander determines there is a need for a combined NOPD and SPPP activity for a specific day and time.

2.0 Supervision of Overtime Officers

The 8th District SPPP Supervisor shall supervise all Overtime Officers consistent with the instructions provided in the Program's Post Instructions and by the 8th District Commander.

Overtime Officers assigned to Blue Light Patrol are to supplement not replace the 8th District patrols in the Program Area.

The 8th District SPPP Supervisor shall require Overtime Officers to:

- Follow the Post Instructions for their assigned Shift ID number except when the 8th District Commander expressly directs otherwise
- Patrol in their assigned Patrol Zone
- Remain in the Program Area throughout their shift
- Not respond to routine calls for service
- Not respond to an emergency outside the Program Area
- Not transport an arrestee unless the Overtime Officer's arrestee is injured.

The 8th District SPPP Supervisor shall give additional direction and instruction to an Overtime Officer who is working a Patrol Shift for the first time.

The 8th District SPPP Supervisor shall make transportation arrangements through an on-duty NOPD officer whenever an Overtime Officer makes an arrest, unless the Overtime Officer's arrestee is injured and requires medical attention.

The 8th District SPPP Supervisor may determine that, due to severe weather, the use of a NOPD standard vehicle should be used for the patrol in lieu of a SPPP vehicle.

The 8th District SPPP Supervisor shall provide Overtime Officers working a Blue Light Patrol with information on hot spot locations in the Overtime Officer's assigned Patrol

Area in order for the Overtime Officer to place additional emphasis in such locations.

When the 8th District Commander determines the need for a combined NOPD and Task Force activity for a specific day and time, the 8th District SPPP Supervisor shall give additional directions and instructions to one or more Overtime Officers.

If no Overtime Officer is on duty, the 8th District SPPP Supervisor shall dispatch alerts from the Citizen Reporting App to an on duty NOPD Officer.

3.0 Overtime Officer Duties and Prohibitions

3.1 Overtime Officer Duties

Overtime Officers shall report for duty to the SPPP Office on, or before, the time scheduled for their Patrol Shift. An Overtime Officer working a Patrol Shift for the first time shall report for duty at least fifteen (15) minutes early to receive training on working in the Program Area. If an Overtime Officer scheduled for a Patrol Shift is unable to report for duty as scheduled, the Officer shall notify the SPPP Supervisor as soon as the Officer becomes aware of their conflict to provide adequate time to schedule a replacement for the Patrol Shift.

The Overtime Officer shall wear a NOPD supplied body worn camera ("BWC"). Per NOPD Policy, the BWC shall be turned on when patrolling and interacting with the public.

An Overtime Officer shall perform their assignments on their Post Instructions (specific to the patrol identification number the Detail Officer is assigned to work) and follow the instructions and/or directions for performing their Patrol Shift duties given them by the 8th District SPPP Supervisor.

When the 8th District Commander determines the need for a combined NOPD and SPPP activity for a specific day and time, a Overtime Officer may receive an alternate assignment, directions and instructions that supersede their Post Instructions.

Overtime Officers shall perform their SPPP work in the same manner as they would work their primary employment. The *NOPD Police Manual* and the *OPSE Policies and Procedures for Customers and Officers* shall guide their conduct and actions.

Overtime Officers are required to spend their shift continuously patrolling in their assigned Patrol Zone (*see* Post Instructions specific to the patrol identification number the Overtime Officer is assigned to work).

Each Overtime Officer shall be assigned to patrol in a SPPP vehicle that is a specially equipped mini-vehicle with GPS tracking, NOPD approved emergency lights, sirens, and NOPD decals. Each Overtime Officer shall patrol with the vehicle's blue light turned on. Each Overtime Officer shall pick up the key for their assigned vehicle at the SPPP Office and return the vehicle and its key at the end of their shift.

Each Overtime Officer shall use a special purpose iPad ("iPad") equipped to receive, in real time, citizen reports of a suspicious activity, crime in progress, etc., reported by a citizen through a special purpose mobile app. The use of the iPad and/or app shall not interfere with the Overtime Officer's primary communication through NOPD radio channels and other approved means.

Overtime Officers assigned to a Blue Light Patrol are to proactively patrol in their Patrol Zone throughout their shift to deter the commission of criminal activity including robbery, assault, prostitution, drug dealing, aggressive solicitation, pickpocketing, graffiti, curfew violations, and obstruction of a sidewalk, street or doorway. When an Overtime Officer makes an arrest, the Overtime Officer shall contact the 8th District SPPP Supervisor to arrange for an on-duty NOPD officer to transport the arrestee (unless the arrestee is injured and requires medical care).

Overtime Officers assigned to a Traffic Enforcement Patrol are to proactively patrol in the Program Area throughout their shift to enforce oversize vehicle, oversize bus and other traffic violations of the City's municipal ordinances. The Officers are to use the supplied measuring wheel to determine the length of a vehicle as well as the Oversize Vehicle Enforcement Guide in the SPPP training guide.

If, due to inclement weather, the 8th District SPPP Supervisor determines that use of a NOPD standard vehicle should be used for patrol, the Overtime Officer shall place a NOPD-approved FQMD decal on both sides of the NOPD vehicle to identify the vehicle as one being operated by an Overtime Officer.

The NOPD Police Manual and the OPSE Policies and Procedures for Customers and Officers shall guide the conduct and actions of all Overtime Officers.

Overtime Officers shall use the iPad to clock in and out. (See Section 6.0.) During their shift Overtime Officers shall document their activity using the iPad incident reporting screen. (See Section 7.0.) At the completion of their shift the Overtime Officer shall log out on the iPad and place it in a charging station in the SPPP Office.

3.2 Overtime Officer Prohibitions

Overtime Officers shall not:

- Leave the Program Area at any time during their shift, unless to provide emergency assistance
- Leave their assigned Patrol Zone unless directed to do so by the 8th District Commander or Shift Supervisor
- Respond to a routine Call for Service
- Respond to an emergency Call for Service unless it is for a matter in their assigned Patrol Zone
- Respond to a Traffic Accident
- Enter an Alcoholic Beverage Outlet (ABO) venue, per NOPD policy, unless a Call for Service was received by a 911 operator or the NOPD 8th District, or a situation requires immediate police intervention
- Transport or book an arrested person (unless the person the Detail Officer arrested is injured and requires medical attention)
- Perform an escort

4.0 Program Staffing

Patrol Shifts are scheduled seven (7) days a week as shown in Figure 2.

Six (6) shifts will cover 24 hours of standard Blue Light Patrols covering four (4) zones (zones 1, 2, 3 and 5), with a second shift covering zone 5 from 3pm-3am. Additionally, there are three shifts covering from 7:00am to 7:00pm that will Traffic Enforcement Patrols.

- Respond to Officer Needs Assistance in the Program Area
- Notify the 8th District Shift Supervisor to arrange for transport of an arrestee
- Participate in joint activity as directed by the 8th District Commander



Assigned Patrol Zone – Zone 4

The Program uses an electronic timecard system built into the "French Quarter Task Force®" App ("App")¹ that is loaded on each iPad. On arrival at the SPPP Office, the Overtime Officer shall be assigned an iPad and enter the provided access code.

The Overtime Officer shall open the App on the iPad and log on with their assigned user name and password. After logging on, officers do not need to enter their Detail Number on the screen.

7.0 Responding to and Documenting Incidents

The Program uses an electronic activity report system built into the App to document response to App Calls, Dispatch Calls, and Self-Initiated Incidents.

Each Overtime Officer shall patrol with the iPad on and set at the incident "home" page. An incoming App call will display on the home page. To respond to an App call, the Overtime Officer shall assign the App call to him/herself. See Figure 4.0.

An Overtime Officer working a Blue Light Patrol shall only respond to an App call in their assigned zone. However, an Overtime Officer working Blue Light Patrol may respond to an App call in another Patrol Zone when the Overtime Officers in the Patrol Zone of the App call are working other incidents.

An Overtime Officer working Traffic Enforcement Patrol shall only respond to an App call when the Detail Officers working Blue Light Patrol are working other incidents.




Figure 4 – Incident Home Screen

If an Overtime Officer accepts a Dispatch Call the Officer shall select the Dispatch "button" at the top of the screen. Once the Officer arrives at the Dispatch's call location the Officer shall select the On Scene "button".

If an Overtime Officer Self-Initiates responding to an Incident, the Officer shall select the Self-Initiated "button" at the top of the screen. Once the Officer arrives at the Incident location the Officer shall select the On Scene "button".

All Overtime Officers shall disposition each App, Dispatch, and Self-Initiated incident using the Incident Disposition screen. Figure 5.0 illustrates a typical disposition screen.



Supplemental Police Patrol Program Mission

• The Supplemental Police Patrol Program (SPPP) is an overtime program within the French Quarter that focuses on blue light patrols to deter violent crime. Officers working the blue light patrols are expected to take enforcement action for observed violations of state laws and municipal ordinances, including traffic violations. In addition to patrols, officers working this overtime are required to respond to App based calls submitted by residents and business workers of the French Quarter.

Supplemental Police Patrol Program Areas of Responsibility

- Zone 1 N Rampart to Dauphine, Canal to Esplanade
- Zone 2 N Peters to Royal, Canal to Esplanade
- Zone 3 N Rampart to N Peters, Dumaine to Esplanade
- Zone 4 Traffic Enforcement N Rampart to N Peters, Canal to Esplanade
- Zone 5 Bourbon St, from Canal to St. Ann

17271 MCS, 54-401 – Obstructing Public Passages

No person shall willfully obstruct the free, convenient and normal use of any public sidewalk, street, highway, bridge, alley, road, or other passageway, or the entrance, corridor or passage of any public building, structure, watercraft or ferry, by impeding, hindering, stifling, retarding or restraining traffic or passage thereon or therein.

Sec. 146-494. - Obstruction of sidewalks.

(a) It shall be unlawful for any person to obstruct or cause to be obstructed any public space parallel to any sidewalk including linear streets, public rights-of-way, public alleys or any entrance or window of any building so as to prevent the free and proper use thereof

(b) If any person by performance of any outdoor act or activities causes a crowd to gather, and if the crowd makes passage by pedestrians inordinately difficult or conducts activities which impede access to the public rights-of-way the department of police shall have the authority to order such person(s) to cease performance of their act or activities. The person(s) to whom such an order is given must obey the order immediately or be subject to arrest for violation of this section

Sec. 146-494. - Obstruction of sidewalks

- (e) Jackson Square clear lanes.
- (1) All artists, street entertainers, street vendors and other persons utilizing the Chartres Street, St. Ann Street and St. Peter Street malls surrounding Jackson Square under a permit from the city, hereinafter all referred to as "performers or vendors" shall endeavor to maintain "clear lanes" to facilitate pedestrian access to and around Jackson Square, as set forth below.
- (2) No performer or vendor shall conduct his performing or vending activity in the clear lanes around Jackson Square.
- (3) Performers and vendors shall encourage pedestrians who stop to view their performing and vending activities not to block the clear lanes established herein, and they shall cooperate with the effort of the department of police to maintain such clear lanes for pedestrian access in and around Jackson Square.
- (4) The clear lanes areas shall be the following:
- (a) Chartres Street Mall. The clear lanes shall be from the facades of the Cabildo, St. Louis Cathedral and Presbytere to a line 20 feet out from those facades.

(b)St. Ann Street Mall. The clear lanes shall be from the facades of the Pontalba building to a line 12 feet out from the downtown curb of the street.










- Sec. 154-1412. Obedience to traffic control devices.
- Any person operating a bicycle shall obey the instructions of official traffic control signals, signs, and other traffic control devices applicable to vehicles, unless otherwise directed by a police officer. Whenever authorized signs are erected indicating that no right, left, or "U" turn is permitted, no person operating a bicycle shall disobey the direction of any such signs, except when such person dismounts from the bicycle to make any such turn, such person shall then obey the regulations applicable to pedestrians.

Sec. 162-1644. - Number of passengers per vehicle.

It shall be unlawful to load more passengers in a pedicab than there is seating space available, except that children who are two years of age or younger and held in the arms of an adult may be carried in excess of the above. No pedicab shall be loaded with passengers in such a manner as to obstruct the view of the operator or otherwise interfere with the safe operation of the vehicle.

Sec. 162-1645. - Pedicab traffic laws.

All pedicab operators must obey all the same traffic laws as described in article XII, sections <u>154-1401</u> to <u>154-1424</u>, which will be enforced by the ground transportation bureau investigators, police, or any commissioned policing authority.



No person shall own and operate or permit any other person to operate an animal-drawn vehicle, a for hire vehicle, tour bus or tour vehicle, airport, limousine, taxicab, courtesy vehicles, commuter shuttle vehicles, or any other for hire passenger vehicle offered for hire and engaged in the business of transporting passengerswithout having an appropriate CPNC.....

Sec. 162-81 Drivers Permit Required

It shall be unlawful for any person to drive any vehicle regulated by this chapter without possessing a current driver's permit

Motorcycles Mufflers & Exhaust Systems



Sec. 154-1474. - Muffler and exhaust system requirements.

- (a) Every motorcycle and motor-driven cycle shall at all times be equipped with a muffler in good working order and in constant operation.
- (b) No person shall use a muffler cutout, bypass or similar device upon a motorcycle or motor-driven cycle on a street of the city.
- (c) No person shall modify the exhaust system of a motorcycle or motor-driven cycle in a manner which will amplify or increase the noise emitted by the muffler originally installed on the vehicle, and the original muffler shall comply with all of the requirements of this section.

Permits shall be conspicuously displayed and affixed to the front windshield, lower corner, passenger side and be clearly visible from outside the mobile food truck at all times during operation.

Nothing contained herein shall be construed to authorize the use of any permit:

- (1) In the Central Business District;
- (2) In the Vieux Carré;
- (3) In the Faubourg Marigny, except on both sides of Elysian Fields Avenue;

Vieux Carré, for the purpose of this division, means the area bounded by: Iberville Street, northbound side of North Rampart Street, Esplanade Avenue and the Mississippi River.




3)e. No vehicle, truck, truck-tractor, or trailor with an overall or combined length in **excess of 36 feet** shall be allowed in the Vieux Carré except as provided in <u>section 154-1524</u>.

(i)When traveling or parking on streets in the Vieux Carré, no motor truck, tractor, or trailer **shall drive or park on the sidewalk** or curb

154-1524 Whenever it shall be necessary to transport a single article which cannot be divided and which exceeds the total weight, width, height, or length allowable by this article, it may be done only after the issuance of a special permit by the director of the department of public work

As used in this section, Vieux Carré is defined as the area included within the downriver curb of Esplanade Avenue, the riverside curb of North Peters Street, the riverside curb of Decatur Street, between St. Louis Street and Dumaine Street, the downriver curb of Canal Street and the riverside curb of North Rampart Street.


Oversize Bus Ordinances

162-942

(a) It shall be unlawful for any bus having an overall **length longer than 31 feet** to use any street within the Vieux Carré, except as provided for in the rules and regulations promulgated under subsection (d) of this section.

(b) Those buses with an overall **length in excess of 20 feet and not greater than 31 feet** shall use the streets of the Vieux Carré as provided for in this section. For the purposes of this section, a bus shall be defined as any motor vehicle, excluding limousines, having an overall length in excess of 20 feet used for the purpose of transportation of passengers

Note: Buses over 36 ft can be cited under Section 154-1522
