1. Public Comment:

No public comment was received.

2. Approval of previous meeting notes

Mr. Caputo made a motion to approve the previous meeting note. Mr. Bilby seconded the motion, and it was approved.

3. Committee Chair's Comments

- a. Update on Homeless Needs Assessment action items
- b. Interfor recommendations

Ms. Cooper reported that the SEC 2022 goal of expanding the Royal Street Patrol had been met with the implemented. Matt Pincus of Public Safety Services Corp was welcomed to the meeting and will be reporting monthly.

Based on Eric Smith's report on the FQEDD sales tax, the remittances are expected to exceed the threshold dedicated to POST certified patrols. There will need to be a midyear budget adjustment to be presented to the City Council in July. The City is looking to FQMD to set 3-5 year goals for public safety. She will create a template with Ms. Frankic that will be sent out to the committee for their input on how to allocate funds for discussion at the April SEC meeting. Ms. Frankic referenced the Interfor Security Assessment and the Travelers Aid Society as data points for the committee to consider when discussing public safety goals. Ms. Cavett discussed traffic enforcement outside of the current 7a-7p shift. Ms. Cooper will be meeting with the Livability Committee chair to discuss their shared work around homeless assistance.

Ms. Cooper recognized Kevin Ferguson for making introductions to the new DDD president and senior management at Empire with whom she met in the past month.

4. Presentation – Presentation of Eighth District Crime Statistics and the Supplemental Police Patrol Program. To Present: Sergeant Marc Boudreau

Sgt. Boudreau reported that there was minimal staffing during the past month due to overtime limitation cap. He worked many shifts during this time and had the 8<sup>th</sup> district desk officer watch the app when no officer was patrolling for the SPPP and those app calls were sent to NOPD dispatch. Of the planned shifts with a three car schedule we had 448 planned shifts and filled 259 for 57%. The CEA demands 840 shifts 30% of those were manned. 146 app calls were received.

For his report on Uniform Crime Report (UCR) with French Quarter crime stats, he will add a tab with names of call signs. The recent murder on Bourbon Street apprehension was made by an SPPP officer.

The SPPP has four vehicles now, the two patrol vehicles that were being borrowed are no longer available. The officer are complementing the cars and people are remarking that they are happy to see them.

Ms. Cavett asked is Sgt. Boudreau could provide a map of the major crimes. Ms. Frankic offered to help him to create for next month's meeting.

5. Presentation – Presentation on the French Quarter Economic Development District Agreement Monitors meeting. To present: Jane Cooper

6. Presentation – Presentation on City Safety Coordination. To present: Eric Smith, City CAO Analyst  
a. Update on Supplemental Police Patrol Program Vehicle Procurement

Ms. Cooper reported for Eric Smith. EMD, the City's fleet maintenance department, is working on the RFP. Mr. Smith expects the Polaris RFP will go out this month.

b. Supplemental Police Patrol Program App Request for Proposals

The City Attorney has not provided a formal legal opinion so far. The City will proceed with procurement per City law.

c. Update on status of Bourbon Street Bollards.

The City has asked the engineering firm that installed the Bourbon Street bollards for a prove to remove them and fill in the tracks. The committee discussed not holding up the removal of the bollards for the filling in of the tracks, They are broken and an eye sore. Sgt. Boudreau said that the City is used mobile crash rated barriers for Mardi Gras and thinks they will be utilized for the special events upcoming.

7. Presentation – Presentation on the status of the expansion of the Upper Quarter Patrol, originally known as the Royal Street Patrol. To present: Matthew Pincus
  - a. Patrol Plan
  - b. Monthly Report

See attached report. Mr. Pincus reported that March 8<sup>th</sup> was the launch of the expanded patrols following Mardi Gras. They are using paper activity sheets and carry phones for tracking officers through the shift. They staffed 98 hours the first week, 213 hours the second week, and have 300+ hours scheduled starting the week of the 20<sup>th</sup>. The officers and neighbors seem happy so far. The patrol officers are introducing themselves to businesses and residents and are walking in pairs. They will patrol in the rain.

8. New Business– To consider and take action upon any other matters that may properly come before the French Quarter Management District Security and Enforcement Committee

Mr. Bilby stated that he is not seeing parking enforcement in the neighborhood. Ms. Cavett asked about preventative action ahead of French Quarter Fest with signs and yellow tape on the neutral round. Sgt. Boudreau will follow up with Parking Enforcement.

Mr. Simms raised concerns about businesses on Decatur Street between Iberville and Bienville Streets. He said there are three restaurants trying to open as bars and could affect crime in the area. The applications will go through the City Planning Commission. Ms. Cavett said that the standard restaurant definition is the issue. Addressing zoning would fall under the purview of the Government Affairs Committee.

9. Next meeting date: 18 April 2022

The next scheduled meeting of the committee is Monday, April 18<sup>th</sup> at 2:00pm.

10. Adjournment

Mr. Bilby made a motion to adjourn the meeting. Ms. Hegenberger seconded the motion, and the meeting was adjourned at 2:53 pm.

1. Monthly Key Performance Indices Report for

a. Trust Fund financials

Eric Smith reviewed the Agreement Monitor Meeting Monthly Report. The attendees discussed the need to look forward for midyear budget adjustment as collections are looking to exceed the budget for this year. The collections are looking to exceed the 2019 remittances. The parties agreed to follow the annual budget procedure for a mid-year budget adjustment with the CAO's office participating in a FQMD Security & Enforcement Committee meeting in April to ascertain possible public safety programming as allowed by the CEA to be considered for the adjusted budget, a FQMD Finance & Security in May to review the financials of those suggestions, and present a complied budget to the FQMD Board of Commissioners in June. The FQEDD could then hold a meeting prior to a July City Council meeting. Those estimated dates are as follows:

1. 2022/04/18 Security & Enforcement Committee
2. 2022/05/09 Finance & Development Committee
3. 2022/06/ Board of Commissioners
4. 2022/07/07 FQEDD (City Council)

These dates will be confirmed by the parties. Mr. Smith asked that the FQMD committees consider 3-5 year goals for security when presenting budget request items for consideration. Ms. Cooper and Ms. Frankic will create a template for SEC members to provide structure to suggestions.

b. Supplemental Police Patrol Program performance

Sgt. Marc Boudreau reviewed the Agreement Monitor Meeting Monthly Report. Overtime limits due to Mardi Gras duties and officers taking time off following the holiday impacted the ability to fill shifts. Sgt. Boudreau filled

shifts to help fill the gap and when there were no officers scheduled the desk officer monitored the app and transferred app calls for service to dispatch. He noted that the donation of the 4 cars was helping to attract additional officers to sign up. Word of mouth helps as well, and some old officers are resigning up because of the improved cars. Sgt. Boudreau is getting some new officers just out of the academy, and he is working with them to get them trained up properly to work these overtime shifts properly. The two loaner patrol cars are no longer available to the supplemental patrol program. The CEA calls for 30 shifts per day. The current schedule is 20 shifts per day. 3am -7am has two shifts instead of four, and 7am -11am and 11am - 3pm there are three shifts instead of four. 3pm-3am has four shifts scheduled. Zones 3 and 5 are always staffed and Zone 1 is mostly staffed when there are limited shifts filled. The zones are prioritized as residential and then by crime. Sgt. Boudreau will share the current 20 shift/day schedule he is using.

The agreement monitors discussed creating a new list of property owners that would authorize the officers move people from their property without having to call for each instance. Sgt. Boudreau suggested that property owners contact him directly to be added to this list.

Mr. Pendleton inquired that since the arrests are down significantly from historic numbers are there data points that can be provided as to what those arrests were for i.e. if they are offenses that are no longer illegal such as marijuana possession. Sgt. Boudreau and Eric Smith will look into the historic arrest dispositions to attempt to ascertain the difference between current numbers and historic numbers.

Mr. Pendleton asked that the officers be on the lookout for oversized vehicles that appear to be returning to the neighborhood. Sgt. Boudreau noted that 3 or 4 citations were written this past two weeks. Ms. Frankic suggested that Sgt. Boudreau work with the Mayor's Office of Transportation re: sending letters to Google Maps and Waze re: oversized vehicle prohibition in their wayfinding apps. Ms. Frankic will share the contact's information to with Sgt. Boudreau & Mr. Smith to follow up.

Ms. Cooper asked if the traffic enforcement officer could be speeding enforcement on Dauphine Street where there is a lack of stop signs. Sgt. Boudreau said he could look into capabilities and certifications of pool officers to see if anyone has the training for this type of enforcement.

## 2. Action items from the previous meetings

- a. Administration: Finance Department will have a more detailed report on collections next month.

The City's IT department is still having issues providing real time access to FQMD via BRASS so a shared file drive has been created, but FQMD does not see the files Mr. Smith has uploaded there. He provided a spreadsheet on collections to Ms. Frankic that the Dept of Finance will be monthly report with timely and delinquent collections. Collections are represented of taxes that were paid the prior month's sales. Mr. Pendleton asked what percentage of taxes are paid delinquent. Mr. Smith reported that it appears around 10% but is not broken down by how many months delinquent those remittances are.

- b. SPPP Supervisor: Report both the percentage of shifts obligated under the CEA as well as the number of shifts scheduled

- c. SPPP Supervisor: Investigate foot patrols as an option and what the impact on the KPIs would be if this option was engaged until vehicles were procured

Mr. Smith says that in reviewing the CEA, the wording of the patrol base patrol plan for each of the zones does not say that they are vehicular patrols. The duties are to provide on duty overtime NOPD officers for the blue light patrols, but the CEA doesn't say that all eight areas must be vehicular patrols. The patrol plan does not exclude foot patrols. The SPPP does not have the vehicles to meet the minimum of the required patrols. Sgt. Boudreau thought Zones 2 and 5 lend themselves best to foot patrols. Mr. Smith will get a legal opinion on if foot patrols can be utilized until enough vehicles can be secured to meet the minimum patrols shifts required in the CEA from the City Attorney, but it will take a few weeks. Mr. Smith noted that the Administration agrees with filling the shifts. Sgt. Boudreau said there have been officers waiting to pick up shifts as he has been waiting for additional cars. He thinks that there could be officers willing to work a foot patrol while the weather is nice. Sgt. Boudreau noted that heat and certification issues arise with using bicycles. Bicycle training takes a week to be get certified and is required for workers comp.

- d. Administration: Report on the status of the arrangement between NOPD headquarters and the Sheriff's office

Mr. Smith reported that Superintendent Ferguson's Chief of Staff clarified that only about 25% of Orleans Parish Sheriff's Deputies are POST certified as opposed to corrections officers. The Chief will determine if these officers would be paid by the City as overtime versus detail rates. They are exploring if OPSD could invoice the City like how the LA State Police used to.

- e. SPPP Supervisor: Update training manual for street closures  
Done.

- f. SPPP Supervisor: Get training on parking tickets / traffic violations  
Sgt. Boudreau is meeting with the head of traffic on Thursday, March 24<sup>th</sup>, at the 8<sup>th</sup> District station.

- g. Administration: Report quickly on ability for donation for parking enforcement to be actionable during remainder of Carnival.  
Not completed prior to Carnival. Not further action at this time.

- h. FQMD: At the Administration's request FQMD Board or Security & Enforcement Committee have an approved motion making recommendations to the City for the app capabilities  
Ms. Frankic reported that SEC has not approved a list of app capabilities as they had requested that the City put into writing this request of FQMD. Mr. Smith is working with the Legal Dept. on a written request; the app RFP will go out to bid with or without FQMD's input per city procurement law.

- i. FQMD: Provide a performance matrix for app maintenance

- j. Administration: Put together bid for Polarises  
EMD, the City's fleet maintenance department, is working on the RFP. Mr. Smith expects the Polaris RFP will go out this month.

- k. Administration: Put together procurement of SPPP patrol vehicles via Jefferson Parish Sheriff's Department Ford contract with FQIF allocation

Mr. Smith reported that the Ford procurement is proceeding but will be lucky to receive those vehicles in 6-7 months. EMD has certified mechanics for the Ford Escapes – the smallest vehicle Ford sells in the United States.

Mr. Pendleton asked to confirm that the City cannot procure used vehicles. Mr. Smith confirmed this. Ms. Frankic asked if the City could lease vehicles like the LA State Police used to lease Polarises during special events. Mr. Smith will ask if leasing vehicles until a full fleet for the SPPP is procured.

- l. Administration: Put together bid for SPPP patrol vehicles with FQEDD budgeted funds. The RFP will take a month to author. Mr. Smith will share when it is ready

- m. Administration: Complete donation of vehicles from New Orleans & Company Done. The vehicles are now patrolling.

- n. Administration: Provide real-time access to detailed invoices and remittances to FQMD See above item 2.a.

- o. Administration: Provide Dept. of Finance report on current month and delinquent remittance per month See above item 2.a.

### 3. Quality of Life and Traffic Enforcement

- a. Illegal party golf carts, loud vehicles

Ms. Frankic reported on request from FQMD's board meeting that the SPPP address the issue of illegal party vehicles playing loud music and parking on the sidewalks. It was noted that these golf carts with 4-5 rows are carrying children without seatbelts in unsafe conditions. Sgt. Boudreau noted that illegal vehicles are addressed in the training manual, and he will advise to take enforcement action as opposed to warnings on these violations the issue. Golf carts must have a license plate and seatbelts to be street legal.

- b. Enforcement of new 15mph speed limit See above item 1.b.

- c. Slow children at play signage

Mr. Smith said that the Department of Health was working on a full signage plan for the French Quarter in 2019. He will follow up with them now.

### 4. Schedule Quarterly report to the City Council

Mr. Fiore will confirm with Cm. King's scheduler if April 21<sup>st</sup> will work for the quarterly briefing to the FQEDD (City Council) prior to the regularly scheduled council meeting.

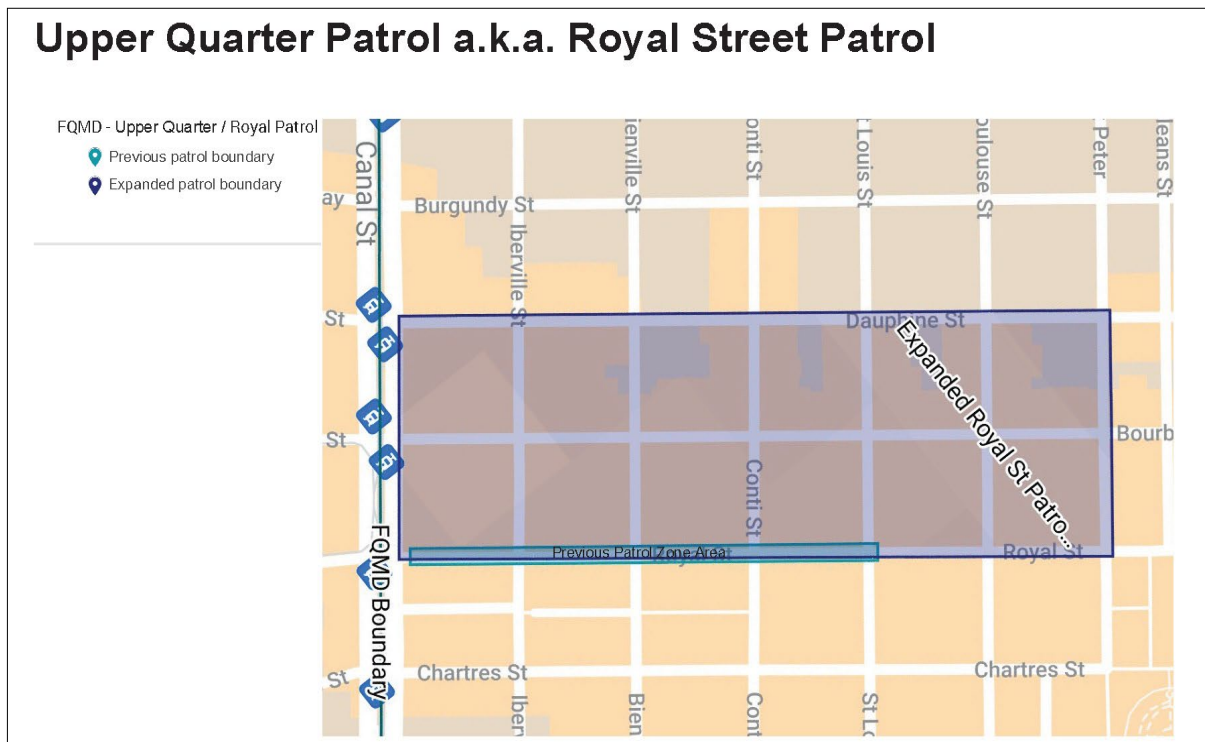
## Foot Patrols

*Effective March 8, 2022*

1) The Expansion of the Upper Quarter Patrol, originally known as the Royal Street Patrols.

The expansion of the Upper Quarter Patrol (UQP) is a program of the French Quarter Management District (FQMD) that is operated, and made possible, through a Security Services Agreement between FQMD and Public Safety Services Corporation.

This detail off-duty Law Enforcement Officers from various agencies to perform pro-active foot patrols coupled with vehicles utilizing emergency lights within the boundaries of the area represented below. These patrols will enhance police presence and help promote a greater sense of public safety.



## 2) Public Safety Services Responsibilities

- Utilize only Louisiana POST (Peace Officer's Standards and Training) certified law enforcement officers.
- Communicate patrol shifts to the New Orleans Police Department's (NOPD) Eighth District Commander via electronic mail.
- Assign and fill shifts to the best of their ability in an effort to satisfy the patrol shifts created by the FQMD.

- Attempt to fill any vacancies in scheduling created by absences or callouts.
- Review all activity sheets.
- Keep an accurate record of accounting of shifts worked as part of UQP.
  - Assure Upper Quarter Patrol Officers go 10-8 (Inservice) and 10-7 (Out of Service) with the Orleans Parish Communications Division.
  - When patrol officers report for their assigned shift, they shall text "Hello" to 504-386-3991 and the virtual dispatcher will guide the patrol officer through a series of questions to get them logged into the CAD system. Two of the text prompts include their agency of employment and badge number. Patrol officers should identify themselves by their agency and badge number "ex: constable 134" so the dispatch can find them in CAD.
  - Patrol officers who have access to the encrypted LWIN channels will be able to access channel NPDisp-8 to speak with the OPCD should they need assistance.
  - Assure patrol officers give the location of their assigned foot patrol.
- Assure Upper Quarter Patrol Officers be attired in uniform.
- Assure that if a Upper Quarter Patrol Officers detains a suspect, that the detaining officers will contact NOPD immediately to effect the arrest.
- Assure if force is used by UQP Officer, or if injuries are sustained by a detainee, the UQP Officer will notify FQMD, OPCD, and NOPD. If a detainee sustains injuries that require hospitalization during an encounter with an UQP Officer, the UQP Officer will relocate to the hospital for any corresponding guard duties. Outside of deadly force, all use of force incidents will be investigated by the respective agency of the UQP Officer.
- Assure UQP Officers clock in/out with the Quickbooks Time App.
- Assure UQP Officers carry a GPS enabled smart phone to be reachable by Constable Matthew Pincus, NOPD, and FQMD.
- Provide a schedule of patrols including officer's names to FQMD in a timely matter.
- Collect and review all activity sheets and provide them to FQMD.
- Attend monthly meetings with FQMD and provide a brief report.
- Call FQMD to review data points, patrol plan amendments, hot spots, public feedback, etc.

### 3) Supervision of Officers

A PSS Supervisor shall supervise all Upper Quarter Patrol Officers.

The PSS Supervisor shall require all patrol officers to:

- Walk in their assigned Patrol Zone
- Remain in the Patrol Zone throughout their shift
- Not respond to routine calls for service
- Not respond to an emergency outside of their assigned Patrol Zone
- Not to enter an Alcoholic Beverage Outlet (ABO), per their agency's policy, unless a situation requires immediate law enforcement intervention.
- Complete a pre-fashioned activity sheet at the end of each shift.

Per New Orleans Police Superintendent, Shaun Ferguson, Upper Quarter Patrol Officers will only be a visible deterrent. Unless otherwise instructed by the Superintendent of Police, working officers are not

allowed to enforce any State or Municipal Laws. Upper Quarter Patrol Officers are only allowed to detain suspects, at which time, they will contact NOPD for necessary paperwork and disposition of the incident. It is understood that the New Orleans Police Department is the lead law enforcement agency in Orleans Parish.

#### 4) Walking Patrol Staffing

Patrol Shifts are scheduled seven days per week as reflected in the below diagram.

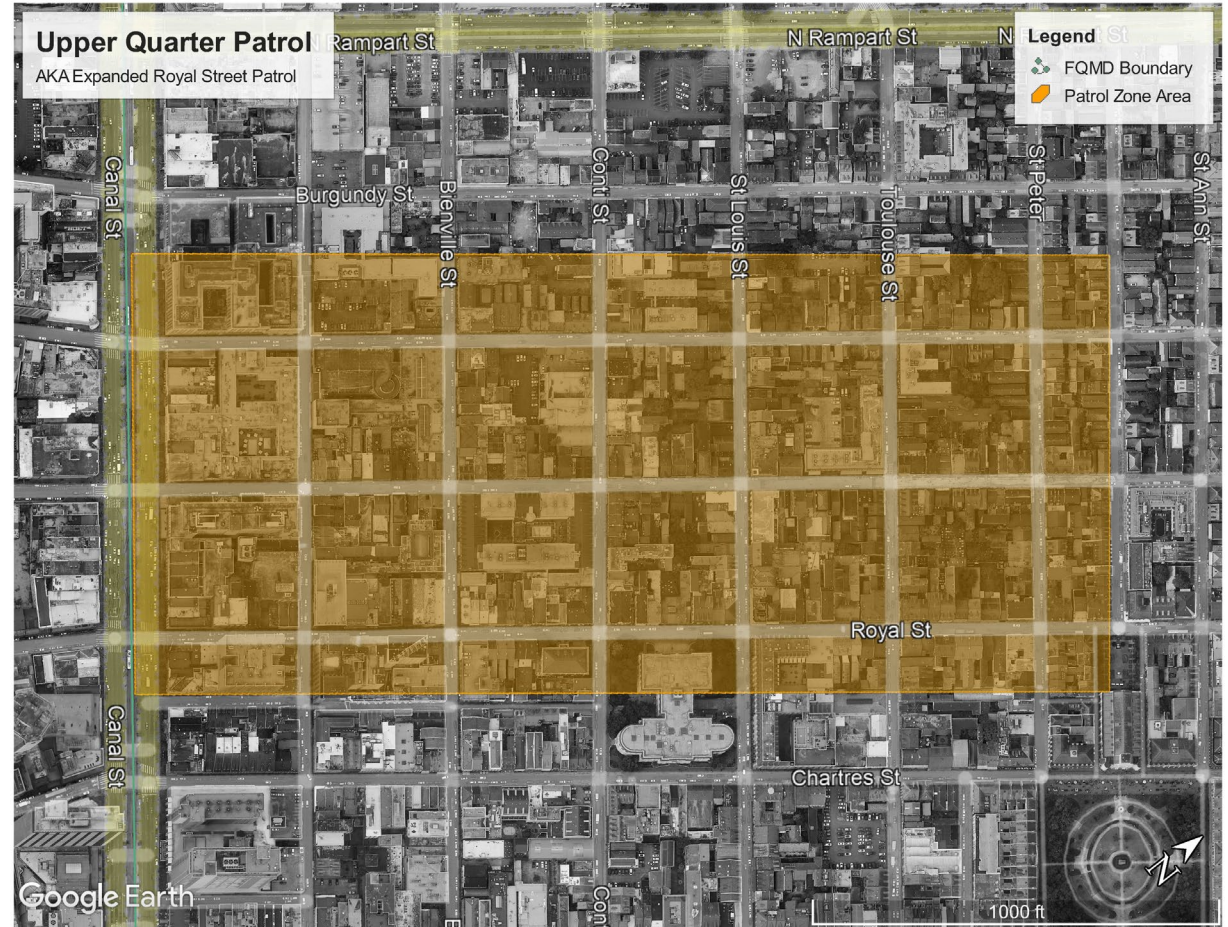
