**THIS CONTRACT** is made and entered into this 23<sup>rd</sup> day of December, 2014 by and between the City of New Orleans, represented by Mitchell J. Landrieu, Mayor (the "City"), and Empire Janitorial Sales & Services, LLC, represented by Charlie Lusco, President/Owner (the "Contractor").

**WHEREAS**, the Contractor, whose address is 1820 L&A Road, Metairie, LA 70001, submitted the lowest responsive bid in response to the City's Invitation to Bid for Bid Proposal No. 3010-01748 dated November 19, 2014 seeking a contractor to provide French Quarter and Downtown Development District Sanitation Services; and

**WHEREAS**, the City desires to award the Contract to the Contractor.

**NOW THEREFORE**, the City grants and confirms to the Contractor the contract to provide French Quarter and Downtown Development District Sanitation Services to the City under Bid Proposal No. 3010-01748 and the City and the Contractor, for good and valuable consideration, agree as follows:

**I. THE CONTRACTOR'S OBLIGATIONS.**

The Contractor will perform all obligations of the Contractor, and be subject to all terms and conditions set forth, in this Contract and in the following documents that are incorporated fully into this Contract: the Invitation to Bid for Bid Proposal No. 3010-01748 dated November 19, 2014; Addendum No. 1 dated December 9, 2014; and the Contractor's Bid dated December 16, 2014 (the "Bid").

**II. THE CITY'S OBLIGATIONS.**

The City will pay the Contractor at the rates set forth in the Contractor's Bid for the satisfactory performance of this Contract and will perform all obligations of the City, and be subject to all terms and conditions set forth, in this Contract and any incorporated documents.

**III. THE SURETY'S OBLIGATIONS.**

**A. Performance and Payment Bonds.** Travelers Casualty and Surety Company of America (the "Surety") intervenes in this Contract and binds itself as surety for:

1. The faithful performance of all work required of the Contractor by this Contract in the full sum of One Million Nine Hundred Seventy Six Thousand Seven Hundred Eighty Eight Dollars and Fifty Cents (\$1,976,788.50); and

2. The full payment by the Contractor of all payments to be made by the Contractor under this Contract the full sum of One Million Nine Hundred Seventy Six Thousand Seven Hundred Eighty Eight Dollars and Fifty Cents (\$1,976,788.50).

Each of these bonds is to be considered separate and distinct, and no payment made by the Surety under either bond shall in any way reduce the obligations of the Surety under the other.

**B. Acknowledgement of Contract.** The Surety represents and warrants that it has fully read and understands the terms of this Contract, including all incorporated documents.


**C. Survival and Validity of Bond.** The Surety's bond will remain in full force and effect, and will survive the termination of this Contract, but will become null and void if the Contractor: (1) well and faithfully performs all and singular the obligations assumed by the Contractor under this Contract; (2) fully secures and protects the City, its legal successor and representatives, from all loss or expense of any kind, including premises, including all costs of Court and attorneys' fees, made necessary or arising from the failure, refusal or neglect of the Contractor to comply with all of the obligations assumed by it; and (3) promptly delivers all the work required by the Contract to the City, free from any and all claims, liens and expenses. The obligations of the Surety will not be affected in any way by any modifications, omissions, or additions in or to the terms of this Contract, the plans or specifications, or in the manner and mode of payment.

#### IV. ADDITIONAL PROVISIONS.

**A. Entire Agreement.** This Contract, including all incorporated documents, constitutes the final and complete agreement and understanding between the parties. All prior and contemporaneous agreements and understandings, whether oral or written, are superseded by this Contract and are without effect to vary or alter any terms or conditions of this Contract.

**IN WITNESS WHEREOF**, the City and the Contractor and the Surety, through their duly authorized representatives, execute this Contract.



**SPECIFICATIONS**

**NOTICE:** These specifications are for a non-exclusive requirements contract (the "Contract"). The Contractor will perform only by and according to the specific instructions by the City of New Orleans (the "City").

The Contract is for requirements only. The City is not obligated to order, and the Contractor is not entitled to, any minimum orders or compensation. The City may engage the services of other Contractors for the provision of some or all of the services to be provided under the Contract. This contract is not exclusive. The Contractor has no right to receive City work assignments. The City has no obligation to assign work to the Contractor. This Contract engages the Contractor to perform work assigned hereunder at the stipulated price.

No additional costs will be incurred by the City except as bid described in the specifications.

The Contractors must receive an approved purchase order from the City's Department of Finance Purchasing Bureau prior to beginning all work or acceptance and processing of all orders. Only Purchasing Agent or authorized deputies have authority to place orders chargeable to city funds. The Contractor may contact Department personnel listed on purchase order to verify the authorization of the employee placing the call.

Claims against the City are payable only on invoices, reference City of New Orleans purchase order number, rendered to Bureau of Accounting, Room 3W02, City Hall, 1300 Perdido St., New Orleans, LA 70112.

The City reserves the right to cancel purchase orders within a reasonable period after issuance. Should a purchase order be cancelled, the City agrees to reimburse the Contractor for actual and documented costs incurred by the Contractor pursuant to the purchase order. The City will not reimburse the Contractor for any costs incurred after the receipt of cancellation, or for lost profits, or performance of services prior to issuance of a purchase order.

## 1. BACKGROUND

The City seeks to solicit bids from experienced service providers for a contract to provide daily sanitation services for the City of New Orleans in the French Quarter (“FQ”) and Downtown Development District (“DDD”) and other related areas (the “Services”) resulting from, but not limited to, special events (collectively and singularly, “Special Events”) in a timely, efficient, and cost effective manner.

The City will award a contract (the “Contract”) to the lowest, responsive and responsible bidder (the “Contractor”).

## 2. GENERAL SPECIFICATIONS

- 2.1 Definite regulations, laws, standards, and restrictions, including, without limitation, traffic safety, environmental, solid waste, and hazardous material handling and disposal regulation, apply to the specified work and location. By submitting a bid hereunder, Contractors acknowledge a comprehensive knowledge and understanding of such and all applicable Local, State, and Federal regulations, laws, standards, and restrictions, and commit a corresponding compliance in any contract awarded hereunder.
- 2.2 Contractors likewise confirm and acknowledge inspecting the Service Areas outlined in Section 3 and work sites, a close familiarity with conditions there pertaining and affecting the described work, and a complete understanding of and ability to provide the resources, systems, and organization needed to perform the described work.
- 2.3 By submitting a bid or bids hereunder, Contractors acknowledge that if it executes a Contract hereunder, the Contractor assumes all risk and responsibility to complete the work in and under any conditions encountered or created, without extra cost to the City.
- 2.4 The City will award one contract for all Service Areas. Contractors will bid on all Service Areas outlined in Section 3. The final comparison bid in the Service Areas calculates from unit prices applied to specified quantities across several services. The specified quantities enable the bid comparison only. They do not state, determine, or confirm quantities in later contract operations. Bid prices include all other costs required to perform the specified services, including administration, customer service, reporting, record keeping, overhead, profit, insurance, bonds, etc.

3.1 **Solid Waste Collection:** Once or twice per day curbside collection from estimated 4,062 eligible and occupied units, including providing and maintaining trash carts, collection and transportation of solid waste placed curbside, and disposal of collected solid waste.

- A. Section 138 of the City of New Orleans’ Municipal Code outlines collection eligibility, frequency, and scheduling for the following solid-waste:
- a. Commercial Units
  - b. Residential Units
  - c. Bulky Waste Collection from Residential Units
  - d. Dead Animal Removal
  - e. Christmas Tree Special Collection
- B. Exhibit E provides the most recent list of validated eligible service units with commercial/residential designation.
- a. Eligible Units: Small businesses, single-family dwellings and multi-family dwellings with four or fewer units are eligible for solid waste collection from the City if they generate no more than 35 gallons of solid waste at each regular collection.
  - b. Ineligible Units: The following buildings are not eligible for City of New Orleans' trash collection and must file a Litter Abatement application with the City’s Bureau of Treasury and secure private service.
    - i. Hotels, restaurants, or bars
    - ii. Properties containing more than four units
    - iii. Properties which generate more than 35 gallons of solid waste at each regular collection.
  - c. Annual Service Unit Growth: The City has historically experienced nominal growth in the number of **eligible units** in the Service Areas. Annually, the City will increase the number of estimated and eligible units by 1.0% for the purposes of payments associated with solid-waste collection and recycling collection.
    - i. At all times during the contract, the Contractor will be responsible for issuing a trash roll cart and servicing **all eligible and occupied service units** in the Service Areas. The City acknowledges that the makeup of the eligible and occupied service unit list will change based on additions, deletions, and vacancies.
- C. Public Information Plan: Not later than fifteen (15) business days after the Notice of Award, the Contractor will submit a proposed public information plan for City review. The plan will detail

the Contractor's proposed arrangements to inform City residents about the Contractor's solid waste and recycling collections services to begin January 1, 2015. At a minimum, the Plan will project repeated public notice by advance publication in the major New Orleans newspapers and placed at every household and small-business location in the Service Area. The notice must explain the trash cart distribution, general collection operations, route, frequency, and schedule information (if available) and the resident's related duties, including responsibility for lost carts absent a documented theft. The plan will outline the Contractor's customer service and complaint program and refer residents and business owners to the Contractor's customer service telephone and e-mail addresses. The Contractor shall also maintain and refer interested persons to a website for information about the Contractor's solid waste collections operations in the Service Areas. The Contractor will reasonably accommodate City comments to the plan. The Contractor will implement the plan and issue the related notice in the weeks prior to the cart distribution.

- D. Trash Roll Cart Distribution: According to the publicized notice, the Contractor will place collection carts at specified service units starting January 1, 2015.
- a. Design: Trash roll carts will be thirty-five (35) gallon capacity, black in color, with the City's logo and unique serial number imprinted on the cart. No other branding shall be applied to the cart. The City shall have final approval on proposed cart model and will provide City logo design for imprinting.
  - b. Maintenance: The Contractor shall be responsible for maintaining carts, ensuring they are in a serviceable condition. Contractor will proactively repair broken lids and wheels within five (5) business days of discovery or report.
  - c. Replacement: The Contractor shall be responsible for replacing any cart that is no longer in a serviceable condition. This includes, but is not limited to cracked carts, carts with holes, and carts where lid/wheels cannot be repaired.
  - d. Lost and Stolen Carts: If a collection cart goes missing, the Contractor will promptly report the fact to the City and commence a search. The unit owner is responsible for the loss unless it obtains and presents a police report for a reported theft. For theft cases so documented, and if the Contractor cannot located the collection cart and return it to service within ten (10) business days after reporting it missing, the Contractor will replace the first collection cart at the Contractor's cost and place it in service at the assigned location. Otherwise, the household or small business at the location my purchase a replacement collection cart at cost from the Contractor, which will place it in service at the assigned location.
  - e. Ownership: The Contractor will own the collection carts it supplies during the term of the Contract. At Agreement termination, the Contractor will promptly recover all collection carts, clean and service them, and deliver them to a designated City location without further compensation. Ownership of the roll carts will be transferred to the City upon delivery.

- f. **Tracking:** Contractor is responsible for maintaining a comprehensive database of each cart issued to a given service unit, including the cart service number.
- E. **Collection Schedule, Frequency, and Routes:** The Contractor will collect solid waste according to identified and numbered regular schedules and routes approved by the City in advance, and cause to project an orderly, safe, and dependable collection within collection’s equipment standards and tolerances. The Contractor will detail routes and schedules in the Service Areas and submit them for City approval with fifteen (15) business days of Notice of Award. It will cooperate with the City to obtain its approval. Absent compelling need, the Contractor will not depart from approved schedules and routes without specific City approval. The Contractor will immediately report and justify unapproved departures from regular schedules and routes to the City by e-mail. The Contractor may request, and the City may approve collection schedule and route changes at justified need. Except as provided for compelling need, the Contractor will follow an approved plan in all cases. The schedule and frequency guidelines for Service Area – FQ and Service Area - DDD are provided below:

- F. **Disposal:** The contractor is responsible for disposal of all eligible solid waste collections, including: residential and commercial solid waste, residential bulky waste, dead animals, public litter cans, organic waste, and all manual litter collection.
- G. **Ownership:** Title of the solid waste materials shall pass to the Contractor upon collection.
- H. **Temporary Services Suspension:** Except for compelling necessity, and only to the extent required thereby, the Contractor will not suspend services without specific City approval. The Contractor shall report suspended services to the City immediately. It will resume suspended services at the earliest opportunity, including weekends, earnestly attempting to restore and complete the contracted collection services with the least delay. In the purpose, the Contractor may work outside regular operating hours with city approval. If resumption of services is not within 12 hours, the Contractor shall advise the Director of the estimated time required before regular schedules and routes can be resumed. For the purposes hereof, “compelling necessity” applies when the Contractor may not collect solid waste safely or effectively. For example, conditions during thunderstorms and significant street flooding

present a compelling necessity to suspend collection services incidentally and temporarily without prior City approval.

- I. Bulky Waste: Solid waste not suitably collected in standard collection carts, generally by reason of excessive weight or size. The Contract does not provide for the collection of bulky waste from commercial units. City Code 138-43 lists the following bulky waste items that are acceptable for normal residential collections.
  - a. Tree limbs and branches less than four feet in length and 12 inches in diameter, neatly bundled.
  - b. Metal materials weighing 25 pounds or less.
  - c. Pipe less than one inch in diameter and less than four feet in length.
  - d. Manufactured items, including, but not limited to, furniture and appliances.
  - e. Bagged leaves, weeds, grass, small vegetation clippings and hedge clippings.
  - f. White goods.
  - g. Twenty-five pounds or less of construction and demolition solid waste generated by a resident and properly containerized and/or bundled.
  - h. Cardboard boxes.
  - i. Carpet less than four feet in length, rolled and tied.
  - j. Tires; maximum of four tires per scheduled collection.
- J. Dead Animal Removal: Contractor will promptly collect dead animals whenever found on public ways or property and otherwise at City direction.
- K. Christmas Tree Special Collection: Contractor will collect discarded Christmas trees as bulky waste, except that it will collect Christmas trees eligible for recycling according to the City's annual Christmas Tree Recycling Program.
- L. Collection Equipment: Contractor will provide an adequate number and proper type of vehicles and other ancillary equipment to perform the contract requirements.
  - a. The vehicle type used for waste collection under the contract shall be a fully enclosed leak-proof packer-type truck. Solid waste collection vehicles used in the French Quarter and Downtown Development District shall be 20 cubic yards or less in size. Equipment used for bulky waste may be open body trucks, dump trucks, and similar type equipment. When open body trucks are used, the Contractor will use care to see that no litter or scattering of waste occurs by providing a suitable covering or tarp. All vehicles used under that contract shall be model year 2012 or newer. The Contractor may request in writing to utilize earlier model vehicles for the first 6 months of the Agreement as a transition period until new vehicles are available.
  - b. The Contractor must clean any spillage of refuse resulting from collection, transfer and hauling activities. To that end, all of the Contractor's vehicles will be equipped at a minimum with brooms, shovels, and rake for cleaning any spillage.
  - c. All vehicles and other equipment shall be kept in good repair, appearance and in sanitary condition at all times. Each vehicle shall have clearly visible on front, rear, and each side the truck's individual Contractor number. The identity and telephone number of the

Contractor should be on each side of the truck. The City reserves the right for final approval of acceptable vehicle identification.

- d. All vehicles used in the regular collection services shall comply with size and weight restrictions and any other standards promulgated by any legislative authority having jurisdiction in the contract area. The Contractor shall maintain such standard, as from time to time amended or revised, during the course of daily operations during the contract period.
- e. The Contractor shall obtain an inspection at least once every twelve months on each piece of equipment by an authorized State of Louisiana inspection station. Each piece of equipment shall be State inspected prior to commencing service under the contract. The Contractor shall produce inspection certificates for City review at request.
- f. The City may inspect each piece of Contractor's equipment periodically throughout the Contract to assess its capability in fulfilling the requirements of the contract. The Contractor will remove any equipment the City finds deficient from the active fleet and operation immediately. The Contractor will not return removed equipment to active service until all needed repairs and/or modifications are complete. The Contractor shall have sufficient back up equipment to fulfill his responsibility under the contract.
- g. The Contractor will operate a suitable service facility to perform routine maintenance and repairs and will maintain a sufficient supply of replacement parts to insure continuous uninterrupted collection operations. After reasonable notice, the City may inspect the Contractor's facilities used in connection with the contract during working hours Monday through Saturday.
- h. The Contractor will enable GPS tracking on pieces of equipment designated in Section 12 – Post Bid Documents. Contractor shall provide access to a webpage viewer where the City can view location of all designated equipment during regular operating hours (4:00 a.m. to 12:00 a.m.). Upon request, Contractor will provide City with GPS location history and log for requested equipment.
- M. Equipment Operators: Each employee assigned to drive a vehicle shall, at all times, carry a valid driver's license for the type of vehicle being driven. Drivers must also have a Commercial Driver's License (CDL) as required by federal law). All engaged Contractor driver and machinery operators will hold and carry current required Licenses and permits, available to City inspection at request. The Contractor shall direct his employees to present their licenses to City representatives for inspection at request. Driver shall maintain cell-phone or radio communications capability with the Contractor and the assigned Supervisor.
- N. Supervisors: Contractor shall assign dedicated full-time supervisor(s) to the Service Areas to ensure that all collections have been completed and all customer requests and complaints have been resolved each day. Crews will return to an address, if necessary to provide service for the customer. Supervisor(s) will also report lost or damage carts, and carts in need of repair or replacement and assist customers by distributing and explaining program information. Supervisors will travel in a company vehicle, wear a company uniform, carry company credentials, and maintain cell phone or radio communication with the Contractor and

collection crews. Supervisors shall be dedicated personnel, prohibited from performing other field tasks (equipment operation, labor) while supervising Contractor operations.

- 3.2 **Recycling Collection:** Contractor shall provide single stream, curbside recycling services for all eligible units in Service Area – FQ and Service Area – DDD.
- A. Collection Schedule and Frequency: Contractor will collect recycling materials on Tuesday of each week. The collection shall occur between the hours of 4:00 a.m. and 10:00 a.m.
    - a. There will be no collection of recyclables on the following holidays: Thanksgiving Day, Christmas Day, New Year’s Day and Mardi Gras Day. Recyclables will be collected the following week.
  - B. Containers: Approved Containers are to be provided by the City on an individual eligible service unit request basis through the Department of Sanitation.
  - C. Items for Collection: The commodities to be collected by the Contractor (subject to Contractor’s right to change or limit the commodities to be collected upon thirty (30) days written notice to the City and public notice to residents) under this Contract are:
    - a. Paper products including office paper, newspapers and color inserts, magazines, catalogs, junk mail, paperboard boxes (including cereal boxes, freezer boxes, 12 pack soft drink boxes and other food/snack boxes), telephone books and corrugated cardboard.
    - b. Plastic food and beverage containers coded #1 through #7, plastic pots from plant nurseries
    - c. Small aluminum, steel and ferrous metal food containers and lids
  - D. Improper Set-Out: If the Contractor determines that the recyclables set out by residents are unacceptable due to insufficient preparation of materials, he/she shall follow the rejection procedure: The Contractor shall leave an “OOPS” card explaining why the material was not collected and the material will be left at the curb. If the resident does not remove the materials from the curb, it will be considered as solid waste and collected with the next regular garbage collection. The agent for the Contractor will record the address of the resident and the Contractor will keep it on file. Once the resident properly prepares the material for collection, the Contractor will pick up the recyclables.
  - E. Collection, Processing, and Marketing of Materials: The Contractor is responsible for the cost of collection, processing and marketing the collected recyclable materials.
  - F. Processing Facility: The Contractor shall transport the collected recyclable materials to a Processing Facility which shall be operated by or under contract with the Contractor. The Processing Facility must at all times meet all requirements of federal, state and local regulations.
  - G. Ownership: Title of the recycled materials shall pass to the Contractor upon collection.
  - H. Collection Equipment: Contractor will provide an adequate number and proper type of vehicles and other ancillary equipment to perform the contract requirements.

3.3 **Public Litter Can Collection:** Contractor shall collect solid waste from iron litter cans and solar-powered trash compactors. During regular collections, Contractor shall also be responsible for collecting and disposing of all debris within a two (2) foot radius of each public litter can.

- A. Containers: The City will provide and position at least 772 iron litter cans and solar-powered trash compactors throughout the Service Areas. The City will be responsible for replacing damaged containers.
- B. Collection Frequency and Schedule: Contractor responsible for the following minimum daily collections:

- C. Solar-Powered Trash Compactors: The City anticipates deploying 200 solar-powered trash compactors in the Service Areas in early 2015.
  - a. Solar-powered trash compactors have a compaction ratio range of 4:1 to 8:1 depending on the waste. **Therefore, the number of collections needed will be significantly reduced. As compared to an iron litter can that does not have compaction capabilities, the solar-powered trash compactors will require one collection to every four to eight collections for an iron litter can without compaction.** The increased capacity of the units has a direct impact on operational costs, significantly reducing the required equipment, labor, and fuel to service.
  - b. Solar-powered trash compactors have internal sensors within units and indicator panels on front of units showing unit fullness. Contractor will collect litter from all units where indicator is showing Yellow or Red.
  - c. Contractors will alerted to Yellow and Red units via email real-time and will have access to management system showing status of all cans real-time.
- D. Maintenance: Contractor responsible for relocation of iron litter cans that may have been displaced and replacing damaged/missing liners in iron litter cans.
  - a. Contractor responsible for replacement of liner bags in iron litter cans and solar-powered trash compactors.
  - b. Contractor will obtain City approval for liner bag types prior to use in Service Areas.
- E. Cleaning and Sanitizing: Contractor is responsible for keeping inside and outside of iron litter cans and solar-powered trash compactors free from debris and grime during service operation periods. While conditions in the Service Areas may dictate more frequent servicing to keep the units free from debris and grime, the City requires that the Contractor will at minimum, perform the following services:

- F. Disposal: Contractor is responsible for disposal of all solid-waste collected from iron litter cans and solar-powered trash compactors.
- G. Missing Containers: The contractor is responsible for reporting missing containers to the City within two (2) business days of discovery.

3.4 **Pressure Washing of Sidewalks and Designated Areas**: Contractor shall pressure wash sidewalks and designated areas in the Service Areas as outlined in Exhibit B. At the conclusion of regular pressure washing operations, all impacted sidewalks and designated areas should be free of debris and grime.

- A. Scheduling: Pressure washing operations should be completed prior to final pass of mechanical street sweeper and flusher in applicable areas to ensure that all debris pushed to street is completely collected.
- B. Pressure Washing Solution: Contractor will use biodegradable solution approved by the City for all pressure washing services in the Service Areas. Contractor will clean rinse all areas with water.
- C. Surface Cleaning: Contractor shall surface clean sidewalks listed below with Mosmatic 21" Commercial Stainless Steel Surface Cleaner (or equivalent as approved by the City) once per month. Monthly surface cleaning will remove persistent grime and restore the original appearance of the sidewalk. Contractor to provide the City with a schedule for surface cleaning and will notify the City of any changes to the schedule.

3.5 **Mechanical Street Sweeping and Flushing**: Contractor shall mechanically sweep and flush the designated streets in the Service Areas as outlined in Exhibits C and D. At the conclusion of daily mechanical street sweeping and flushing operations, all impacted streets should be free of debris.

- A. **Frequency and Schedule:** Contractor responsible for at minimum, the following daily services. Mechanically Street Sweeping and Flushing should follow solid-waste/recycling/public litter can collection operations during daily sequencing of sanitation services. Contractor shall perform a second flush in the Service Area – FQ (Commercial) zone between 10:00 a.m. and noon to ensure any remaining debris has been removed and remaining odors have been neutralized.

- B. **Flushing Solution:** Contractor will use biodegradable lemon scented deodorizer solution approved by the City for all flushing services in the Service Areas. Contractor will also obtain approval for deodorizer-to-water mixing ratio prior to use in the Service Areas. At the conclusion of the Contractor’s daily flushing operations, a discernable “lemon scent” should be evident in the impacted areas.
- C. **Ad-Hoc Incidents:** Contractor shall perform ad-hoc mechanical street sweeping and flushing at City’s request should an incident require. Contractor shall bill City for ad-hoc services at hourly rates submitted in the bid.

**3.6 Manual Litter Collection:** Contractor shall provide laborers to perform manual street and sidewalk sweeping. Contractor is responsible for ensuring streets and sidewalks remain free of debris.

- A. **Service Area:** Manual litter collection services limited to Service Area – FQ.
- B. **Schedule:** Contractor labor crews to operate in Service Area – FQ during regular operating hours (4:00 a.m. – 12:00 a.m.).
- C. **Equipment:** Contractor will provide laborers with equipment required to effectively remove litter in the Service Area, including, but not limited to: broom, scrapper, dust-pan, buggy, replacement trash bags for full public litter cans, and spray bottle and rags to ensure public litter cans remain free of debris and grime throughout regular operating hours.
- D. **Disposal:** Contractor responsible for disposal of all collected debris.

**3.7 Organic Waste Removal:** Although Carriage Company operators are primarily responsible for the removal of mule waste associated with their operations, and citizens are expected to keep their

premises clean, in the event that waste remains unattended, the Contractor shall remove all organic waste deposited on the streets, sidewalks, and/or public alleys and sanitize the area after removal. Organic waste may include, but is not limited to horse, mule, dog, cat, and human waste. Contractor is responsible for proactively monitoring Service Area – FQ to ensure Service Area remains free of waste.

- A. Service Area: Organic waste removal limited to Service Area – FQ.
- B. Schedule: Contractor labor crews to operate in Service Area – FQ during regular operating hours (4:00 a.m. – 12:00 a.m.).
- C. Response Time: Reports of organic waste directed to the Contractor shall be resolved within one (1) hour of reported time.
- D. Disposal: Contractor responsible for disposal of all collected organic waste.

**4. SPECIAL EVENTS:** Contractor shall provide the following minimum additional labor and equipment to support surge sanitation services associated with sanctioned City special events.

**4.1 Equipment and Labor:** Contractor shall provide lump-sum pricing for the following Special Events.

- A. Labor: Crew consists of ten (10) laborers and one (1) supervisor for an eight hour period. Half-Crew consists of five (5) laborers and one (1) supervisor for an eight hour period.
- B. Equipment: Includes licensed operator. Garbage Truck includes licensed operator and (2) hoppers.
- C. Disposal: Contractor responsible for disposal of all collected debris associated with special event.

- 4.2 **Annual Review:** The City will review special event list with the Contractor prior to August 1<sup>st</sup> of each year and determine if any changes are required for the upcoming year. The City will also finalize the dates for the next year's known events prior to August 1<sup>st</sup>.
- 4.3 **Event Changes:** Due to a number of factors, which may include but which are not limited to, weather, cancellations, changes in event size and scheduling, the Contractor may not be utilized for all events as listed.
5. **CUSTOMER SERVICE:** Contractor to develop robust plan to receive and respond to residents comments, inquiries and complaints.
- 5.1 **Office:** The contractor shall maintain and staff a permanent office of fixed address (office) within city limits through which they can be contacted, where service may be requested, and complaints logged and resolved.
- A. The Contractor shall equip their office with adequate telephone communications, fax machine, internet service and sufficient support staff to enable contact by the City and residents between the hour of 7:00 a.m. and 6:00 p.m. daily. Telephone contact must be available using a local (i.e. not long distance) phone call. The City shall be able to contact the Contractor via local cellular phone at all times.
  - B. The Contractor shall designate in writing not less than two (2) nor more than three (3) responsible person(s) in charge who shall be the primary point(s) of contact between the City and the Contractor for the purpose of receiving and responding to inquiries, complaints, and instructions from the City during working hours. The Contractor shall authorize the responsible person(s) to act as his agent, able fully to obligate the resources of the Contractor in immediately responding to the City's requests and in resolving complaints.
  - C. The Contractor shall staff his Office with at least one (1) responsible person in charge at all times who shall be present during all office hours during regular business days.
  - D. The Contractor shall not use answering machines or third party answering services as a substitute or equivalent to the requirements of this Section.
  - E. The Contractor shall maintain records on file with the City indicating the street address, mailing address, and telephone number of the Office, and the name(s) of the responsible person(s) in charge, and shall provide the City with not less than two (2) weeks advance written notice of any changes thereto.
- 5.2 **Personnel:** Contractor's employees and subcontractors will consistently demonstrate the utmost professionalism while servicing the City.
- A. The Contractor's employees shall be courteous at all times and shall work quietly and not use loud or profane language. The City reserves the right to request resource, personnel changes at its sole discretion.

- B. The Contractor's employees shall not solicit or request gratuities at any time. The Contractor will remove any employee from service hereunder who the City reasonably determines has solicited or requested gratuities. The contractor will fully cooperate with any relate City investigation.
- C. The Contractor's employees shall present a neat and clean appearance. During work on collection routes performed hereunder employees shall wear uniforms designated by the Contractor and approved by the City. Each employee also will have and use appropriate safety equipment. Contractor shall ensure that all employees and subcontractors wear safety vests that are reflective and identifiable as working under the Contract.
- D. The Contractor's employees shall follow the regular walks for pedestrians and shall not trespass or loiter on private property, shall not cross property to adjoining property, and shall not meddle or tamper with property which does not or should not concern them.
- E. During business hours, Contractor employees or subcontractors shall not take lunch periods, breaks or loiter on public property, including neutral grounds.
- F. In all cases during its work and operation hereunder, the Contractor will cooperate with law enforcement personnel.
- G. The Contractor will prepare a specific health and safety plan with regard to employees. The plan will include at a minimum health and safety training for the Contractor's employees.
- H. Contractor shall make employees available to attend annual fraud training as conducted by the City's Office of Inspector General.
- I. The Contractor shall comply with all provisions of the law regarding the employment of workers. The Contractor shall not employ persons under the age of eighteen years for work performed under the Contract.
- J. Supervisors shall have strong communication and public relations skills, be able to effectively deal with angry or difficult individuals, be able to successfully solve problems while protecting the City interest, and have the ability to establish positive relationship with City Sanitation staff and the general public.

5.3 **Systems:** The Contractor will establish, maintain, and operate a system to receive and respond to resident service requests, inquiries, and complaints. Residents will have the ability to access the system by telephone, email, facsimile, and postal mail.

- A. Between 7:00 a.m. and 6:00 p.m. daily, the Contractor will have resources available to receive and respond to service requests and complaints. Requests can be submitted via the NOLA311 system, phone, email, website, facsimile, or postal mail.
- B. After 6:00 p.m., the Contractor's telephone system will report operating hours and refer service requests, inquires, and complaints to facsimile, website, e-mail, and postal means. It will also refer emergencies to the City's 911 system.
- C. The City's NOLA311 customer relationship management system will serve as the database of record for all service requests and complaints.

- a. The City operates the NOLA311 customer service center Monday through Friday from 8:00 a.m. to 5:00 p.m. and is closed for City designated holidays.
- b. The Contractor will work with the City to obtain access to the NOLA311 system and train its customer service personnel on the system's processes and procedures.
- c. Service requests and complaints submitted via NOLA311 will be captured in the system and emailed to the Contractor real-time. The Contractor will have access to all service requests and complaints for their respective service areas.
- d. In scenarios where the resident needs to speak directly to the Contractor, NOLA311 operators will "warm transfer" the resident to the Contractor's staff.
- e. During Contractor hours of operation when the NOLA311 customer service center is closed, calls will be routed to a specified Contractor phone number via the City's interactive voice response (IVR) system. The Contractor shall be responsible for fielding calls and creating applicable service requests or complaints in the NOLA311 system.
- f. The Contractor is responsible for capturing all service requests and complaints in the NOLA311 system at the time they are submitted.
- g. The Contractor is responsible for resolving all service requests and complaints, capturing the resolution in the NOLA311 system.
- h. The Contractor will safeguard all service request and complaint information against unwarranted disclosure.

**6. INVOICING AND PAYMENT:** Contractor shall invoice the City within ten (10) calendar days following the end of each month for services rendered that month.

**6.1 Invoice Delivery:** Contractor's invoice shall be delivered electronically via email to Director of Sanitation for approval. Should a scenario occur where the Contractor is unable to deliver the invoice electronically or the City is unable to receive it, the Contractor will deliver the invoice by hand or US mail.

**6.2 Invoice Contents:** Line item summary of sanitation services with units serviced (if applicable) and associated costs. Invoice shall include the signature of Contractor's representative, verifying the accuracy of the invoice and charges.

**6.3 Payment:** The City shall pay the Contractor on or before sixty (60) calendar days from receiving and validating an invoice.

**6.4 Billing Disputes:** In the event of a dispute to any portion of the Contractor's invoice, the City shall pay the undisputed portion of the invoice, and give notice to the Contractor of the disputed amount. No payment will be made on the disputed portion until the parties resolve the dispute. Interest shall not accrue on disputed amounts. Additionally, Contractor agrees to provide any supporting

documentation that may be required by the City as may be required in conjunction with a given disputed amount.

**7. WORK PLAN, REPORTING, AND RECORDS:** In all cases, the Contractor will operate according to a comprehensive Work Plan approved by the City.

**7.1 Work Plan:** The Work Plan will detail the Contractor arrangements, methods, and plans to satisfy all Contract requirements. Contractor will establish an approved work plan, at least fifteen (15) business days before initial operations and will submit all proposed changes during the duration of the Contract to the Department Director for approval. The work plan, will at least include the following:

- A. A Public information Campaign Plan, notifying street locations and routes of street cleaning and sidewalk cleaning dates and times.
- B. Monthly Report Template.
- C. Procedures for coordinating with the City for removal of vehicles parked in violations with posted no parking.
- D. List of equipment/vehicles to be used under the Agreement (number, model, make and year, vehicle identification number).
- E. A complaints Tracking, Reporting, and Resolution System Plan.
- F. Procedures for transmitting information and communication to and from the City and the Contractor prior to and during the Agreement Term.
- G. Procedures for controlling noise, dust and litter during street/sidewalk cleaning operations.
- H. Transfer and disposal method, including truck sizes and descriptions.
- I. A Customer Service Plan.
- J. Office location, phone number, email address, cellular phone number, fax number, and responsible person(s) in charge during all hours.

**7.2 Reporting:** Contractor will provide the City will monthly reports for the contract duration, commencing upon contract execution. The City may withhold monthly payment until Contractor submits required report to Department of Sanitation.

- A. Monthly Report: The Contractor will provide a Monthly Report on the Work completed the previous month. The Monthly Report shall be submitted no later than the tenth (10<sup>th</sup>) day of the calendar month following the month being reported, and included with the Contractor's invoice to the Department of Sanitation. The format shall be approved by the Director before the start of the Contract.
- B. Report Contents: At a minimum, the report shall contain the following information:
  - a. Daily summary of services rendered with service locations under the contract.
  - b. Addresses for new, deleted, and vacant service units.
  - c. Summary of service requests and complaints from the NOLA311 system.

- d. The actual number of public litter cans from which solid-waste was collected from that billing period. Report shall specify counts within each Service Area and distinguish between iron litter cans and solar-powered trash compactors.
- e. List of missing and damaged public litter cans.
- f. Comments or unusual occurrences.
- g. Summary of additional services authorized by the Department of Sanitation with name of City representative who authorized service.
- h. Contractor's recommendations for improvements to sanitation services in the Service Areas.
- i. Special events: Detailed invoices must be provided which correspond to the hourly unit pricing in the bid related to equipment types, identification and hours and certified personnel time sheets, including events worked by day.

**7.3 Records Management:** The Contractor will maintain books and records relating to the contract performance according to the following minimum requirements:

- A. The Contractor shall maintain all records of the Contract for seven (7) years from the date of final payment under the Contract or from the resolution of any matter arising from or relating to the Contract, whichever date is later.
- B. The Contractor will produce for the City's inspection and audit, any records or documents maintained pursuant to the Contract.
- C. The Contractor will establish, maintain, and operate an information system to provide reports and storage and retrieval of operating data relative to the contracted performance including all information needed to verify billing calculations.
- D. The Contractor will maintain other data and records as the City reasonably requires.

**8. SERVICE FAILURES:** Service failures cause serious and substantial damage to the City and its citizens and visitors. The nature of the Agreement renders repairs and responses to such damage impractical or extremely difficult. Accordingly, in case of service failures, the City may collect stipulated damages or employ other measures as herein provided.

#### **8.1 Incidental Services Failures**

- A. Stipulated Damages: Stipulated damages are compensation, not a penalty, for the inconvenience and loss of use of delay of the Service. The City decision to impose such remedies will not waive any legal remedies available to the City for any other service failures under the Contract. The recovery of stipulated damages will not preclude the City from recovery of other damages with the City documents attributable to the referenced failures, including but not limited to the cost of internal staff hours, including administrative costs, hauling cost, disposal cost and /or amounts paid to third parties as a result of such service failure.

- B. Review and Decision: If the city considers the Contractor has failed to perform, or perform in a satisfactory manner, or perform in strict compliance with Contract requirements, the City may perform a review to inform a reasoned decision whether to impose stipulated damage against the Contractor. In such case, and within ten (10) business days after it documents a service failure of the last incident thereof, the City will report the circumstances by certified mail to the Contractor. The Contractor may respond to such report within three (3) business days, supplying the City such written information documentation, and explanation as to inform a reasoned disposition. The City will thereafter reasonably decide the matter, in all cases promptly reporting and explaining the disposition to the Contractor in writing. In cases where the City confirms the service failure, the City may impose the stipulated damages provided below, deduct damage amounts from regular payments to the contractor, and without further formality, keep them for itself as contracted compensation for loss.
- C. Service Failure and Corresponding Stipulated Damages:
- a. A truck working outside of regular operating hours for the Service Areas without the approval of the City – five hundred dollars (\$500.00) per occurrence.
  - b. Failure to collect missed collection from each unit within twenty-four (24) hours of notification by the City or City representative to the Contractor – two hundred dollars (\$200.00) per occurrence for the first five (5) units missed in any thirty (30) day period. Starting with the sixth (6<sup>th</sup>) missed collection in any thirty (30) day period, four hundred dollars (\$400.00) per occurrence per unit missed. Failure of the Contractor to collect missed collection from a unit within twenty-four (24) hours of notification shall be considered an additional occurrence and shall be treated accordingly.
  - c. Failure to collect bulky waste from a unit within twenty-four (24) hours following notification of missed pick-up by the City or resident - two hundred dollars (\$200.00) per occurrence.
  - d. Failure to collect white goods or tires from a unit within twenty-four (24) hours following notification of missed pick-up by the City or resident – two hundred dollars (\$200.00) per occurrence.
  - e. Failure to provide replacement Carts for an added unit or notification by the City to provide a Cart within ten (10) business days after notification by the City – Two hundred dollars (\$200.00) per unit.
  - f. Repetition of complaints on a route after notification by the City of damage to property, spilling, crossing planted areas, improper placement of receptacles, or similar violations – five hundred dollars (\$500.00) per occurrence per repeated complaint. Repetition of complaint is any additional complaint; similar in nature, on the same route after the Contractor receives notice of complaint from the City or City representative.
  - g. Failure to clean up any spillage of refuse resulting from overfilled containers, collection or hauling activities within twenty-four (24) hours after notification by the City – five hundred dollars (\$500.00) per occurrence.

- h. Waste disposal at non-designated location – five thousand dollars (5,000.00) for the first occurrence. For each additional occurrence during the Agreement term, one thousand dollars (\$1,000.00) will be added to the previous amount paid (second occurrence will total \$6,000.00, third occurrence will total \$7,000.00. etc.) The fifth occurrence will be considered default and not amenable to cure by removal of material and payment of damages. Failure by the Contractor to physically remove the improperly disposed of materials within four (4) hours of notification by the City shall be an additional occurrence.
- i. Failure to respond or respond satisfactorily to a complaint within twenty-four (24) hours – one hundred dollars (\$100.00) per occurrence.

D. Extended Service Failures: If the contractor fails to provide Curbside Collection of Solid Waste Service, or any part thereof, as required by the Agreement for a period in excess of one (1) scheduled working day, the City may reasonable employ substitute means to perform contracted work until such matter is resolved and the Contractor is again able to perform regular solid Waste Collections. Such means may include suspending, rescheduling, adjusting, and reallocating the Contractor’s work hereunder, but only to the extent reasonable needed to maintain services pending the Contractor’s restoration of all service hereunder. The Contractor will cooperate with such alternate means. The Contractor will promptly reimburse the City the cost of substitute means reasonably employed to restore and maintain regular solid Waste Collection services, payable from the Contractor’s compensation hereunder, or if none, than otherwise. Nothing there shall limit the City’s other recourse for Contractor non-performance under the Agreement.

E. Procedures for Notification: The City may email the notice to the Contractor. The City must follow-up with a certified letter to the Contractor detailing any unresolved notifications with photographic documentation regarding the violation.

**9. EMERGENCY COLLECTION:** In the event of a declared emergency, where the City activates the emergency provision, there shall be a pre-established baseline tonnage of solid waste collection under the Contract equal to four hundred and ten (410) tons. The Contractor must provide the City with a list of dedicated equipment to transport debris under the emergency collection provision.

**10. SUPPLEMENTAL EQUIPMENT WITH OPERATORS:** Contractor shall provide pricing for the following supplemental equipment with operators. The City shall submit request for respective equipment ten (10) business days in advance of proposed service date(s), except in the case of a declared emergency, where requests will be provided twenty-four (24) hours in advance.

**12. POST BID DOCUMENTS:** The City seeks to contract with the lowest responsive and responsible selected bidder. Within three (3) business days after bid open, the two lowest bidders must submit the following

in order for the City to determine if the bidder is “responsive”. Submission of these documents does not automatically make the bidder “responsible”. Providing this information is **mandatory**. Failure to provide any of this information may cause your bid to be considered non-responsive.

12.1 List of recent contracts that it has recently fulfilled, as evidence of the bidder’s ability to successfully complete the services required by the bid.

- A. Recent contracts should include summary of the job performed, beginning and end dates, information on the services provided, and dollar value of the contract. For each contract, the selected bidder should provide two names and telephone numbers of individuals for the other contract party.

12.2 The bidder’s supporting documentation evidencing the Contractor’s licenses and/or permits to render the specified services.

### 13. INSURANCE

13.1 The Contractor shall purchase in its name and maintain, at a minimum, for the duration of the Contract, at the Contractor’s sole cost and expense, the following insurance policies to provide primary coverage for claims and/or suits that may arise out of or result from the performance of the obligations of the Contractor, its agents, partners, laborers, suppliers, employees, representatives and/or any subcontractors or anyone directly or indirectly employed by any of them to perform or furnish any of the obligations pursuant to the Contract, or anyone for whose acts any of them may be liable:

- A. Workers’ Compensation and Employer’s Liability insurance which meets the minimum requirements as defined in the Louisiana Revised Statutes. Employer’s Liability Insurance shall have a minimum limit of \$1,000,000 per accident or injury.
- B. Automobile Liability Insurance with a minimum of \$1,000,000 combined single limit per occurrence for bodily injury and property damage. The insurance shall include coverage for owned vehicles, hired vehicles and non-owned vehicles.
- C. Commercial General Liability insurance with a minimum of \$5,000,000 combined single limit per occurrence for bodily injury and property damage. The insurance shall include coverage for premises-operations, broad-form contractual liability, products and completed operations, use of Contractors and subcontractors, personal injury and broad-form property damage. The policy shall include Contractual Liability coverage, insuring the indemnity provisions of this Agreement entitled “Indemnification.” A “claims made” form shall not be acceptable. The “occurrence form” shall not have a “sunset clause.”

13.2 The insurance policies herein required shall contain or be endorsed to contain the following provisions:

- A. The City, its elected and appointed officials, officers, agents, directors, volunteers and employees shall be added as an “additional insured” under each of the Commercial General Liability and Automobile Liability policies.
- B. The Workers’ Compensation Coverage shall contain an express waiver of all rights against the City, its elected and appointed officials, officers, agents, directors, volunteers and employees for losses arising from the Work performed by the Contractor for the City.
- C. An endorsement stating that coverage shall not be non-renewed, suspended, voided or canceled by either party, or reduced in coverage or in limits, except after sixty (60) days prior written notice by certified mail has been given to the Chief Administrative Officer, City of New Orleans, 1300 Perdido Street, New Orleans, Louisiana 70112, with a copy to the City Attorney, City of New Orleans, 1300 Perdido Street, Suite 5E01, New Orleans, Louisiana 70112.

13.3 The Contractor will:

- A. Provide the City, as requested, with:
  - a. Proof of coverage for each required policy of insurance;
  - b. A complete copy of all policies, forms and endorsements; and
  - c. Statements disclosing of any policy aggregate limit as requested by the City.
- B. Without notice from the City:
  - a. Replenish any policy aggregate limit that is impaired before commencement of any work or continuation of any work;
  - b. Substitute insurance coverage acceptable to the City within thirty (30) days if any insurance company providing any insurance to the Contractor with respect to this Contract is declared bankrupt, becomes insolvent, loses the right to do business in Louisiana, or ceases to meet the requirements of this Contract; and
  - c. Notify the City’s Risk Manager in writing within forty-eight (48) hours of its receipt of any notice of non-renewal, cancellation, or reduction in coverage or limits affecting any policy of insurance maintained under this Contract.

13.4 All insurance required by this section shall be placed with insurers that are licensed and authorized to do business in the State of Louisiana and have a rating of no less than A-VI in the most current edition of the A.M. Best Insurance Report, AAA in Moody’s and AAA in S&P.

13.5 In addition to any other rights under the Contract or at law, the City may suspend all work under this Contract pending the Contractor’s compliance with the requirements set forth pursuant to this Insurance section. The Contractor’s failure to provide and maintain such insurance in force as required above shall materially breach the Contract and, at the City’s option, occasion an immediate cancellation for cause thereof.

13.6 In the case of any subcontractors, the Contractor shall require each of their respective subcontractors to provide similar insurance as set forth above, unless it is the Contractor’s intent that such insurance be afforded under Contractor’s insurance policies, respectively.

13.7 The providing of any insurance required herein does not relieve the Contractor of any of the Contract responsibilities or obligations for which the Contractor may be liable by law, agreement, contract or otherwise.

## 14. BONDS

14.1 At the Contractor's expense, the Contractor shall maintain performance and payment bonds acceptable to the City during the Contract life:

- A. Pursuant to Section 6-308(6) of the Home Rule Charter of the City of New Orleans, the Contractor shall purchase, furnish and maintain an annual performance bond in the sum of fifty (50) percent of the Total Estimated Annual Contract amount as revised from year to year to secure the faithful performance of all Contractor's obligations strictly according to the specifications of this Contract and Purchase Orders confirmed hereunder. All bonds shall be in the form prescribed by the Contract except as provided otherwise by applicable laws or regulations and shall be executed by only those sureties meeting the requirements and qualifications set forth herein.
- B. The Payment Bond shall be issued in the sum of fifty (50) percent of the Total Estimated Annual Contract Amount to secure the payment of all subcontractors, materials suppliers, and other accounts payable in connection with the contract, and otherwise according to Louisiana Revised Statute Title 38:2241.
- C. If the surety on any bond furnished by the Contractor is declared bankrupt or becomes insolvent or its right to do business is terminated in any state where any part of the Project or the Work is located, or if the surety on any bond furnished by the Contractor ceases to meet the requirements of paragraphs (a) and/or (b) below, the Contractor shall within twenty (20) days thereafter substitute another bond or surety, both of which shall comply with paragraphs (a) and (b) below:
- D. The Contractor shall provide six (6) copies of the bonds. The Contractor shall also furnish such other bonds as are required under the Contract.
  - a. Qualification of Surety – Performance and Payment Bonds. Any surety bond written for the City shall be written by a surety or insurance company currently on the U.S. Department of Treasury's Financial Management Service's list of approved bonding companies, which is published annually in the Federal Register, or by a Louisiana-domiciled insurance company with at least an A-rating in the latest edition of the A.M. Best's Key Rating Guide, or by a surety company that complies with the requirements of La. R.S. 38:2219.
  - b. Resident Agent Required. No surety will be accepted from a bondsman that does not have a permanent agent or representative in Louisiana upon who notices referred to in the General Terms and Conditions, herein, may be served. Service of said notice on said agent or representative in Louisiana shall equal to service of notice on the president of the surety. The Contractor shall immediately furnish a new bond from another company

approved by the City at no additional cost to the Owner, in the event that (1) the surety subsequently removes its agent or representative from Louisiana, or (2) the surety terminates its residency or license in Louisiana, or (3) the surety becomes insolvent, bankrupt, or otherwise, fail. The new bond shall be executed upon the same terms and conditions as the original bond.

c. Scope of the Bond and Obligation of the Surety.

- i. The Contractor's surety shall obligate itself to all terms and covenants of the Contract covering the Work to be performed thereunder. The City reserves the right to order extra work or to make changes by altering, adding to, or deducting from the Work under the conditions and in the manner herein described without notice to the Contractor's surety and without in any manner affecting the liability of the bondsman or releasing it from any of its obligations thereunder.
- ii. The bond shall also secure for the City the faithful performance of the Contract in strict accordance with the specifications of the Contract. The bond shall protect the City against all lien laws of Louisiana and shall provide for payment of reasonable attorney's fees for enforcement of the Contract and for the institution of any concursus proceedings, if such proceedings become necessary.
- iii. The surety of the Contractor shall be and does hereby declare and acknowledge itself by acceptance to be bound to the City as guarantor jointly and in solido with the Contractor for fulfillment of the foregoing, including but not limited to any provisions for actual or liquidated damages.
- iv. The bond(s) must satisfy the requirements of Louisiana Revised Statutes Title 38:2219.A. relative to a "public works project." The bond(s) must bear a countersignature by a Louisiana licensed agent authorized to represent the Surety Company writing the bond together with an effectively dated copy of a power of attorney, bearing the seal of the company, evidencing such agent's authority to execute the bond.
- v. An original certificate confirming payment in full and non-cancellable validity of the bond(s) for the period of the Agreement must accompany the bond(s)
- vi. The amounts of the Payment Bond and performance Bond shall be adjusted annually based on the revised estimated Annual Agreement Amount. Payment Bond and Performance Bonds shall be renewed annually and provided to the City by the Contractor 30 days prior to the anniversary date of the Agreement. The City will determine the Annual Agreement Amount and report it to the Contractor not later than 60 days before the contract anniversary date of each year. If the City does not report the revised Annual Agreement Amount by the date due, the Annual Agreement Amount for the current year will apply for the following year.
- vii. The Contractor's failure to provide and maintain such bonds in force as required above shall materially breach the Agreement and, at the City's option, occasion an immediate termination thereof.

**CONTRACT TERMS AND CONDITIONS**

1. **ACKNOWLEDGMENT OF EXCLUSION OF WORKER'S COMPENSATION COVERAGE.** The Contractor herein expressly agrees and acknowledges that it is an independent contractor as defined in R.S. 23:1021 (6) and as such, it is expressly agreed and understood between the parties hereto, in entering into this Contract, that the City of New Orleans shall not be liable to the Contractor for any benefits or coverage as provided by the Workmen's Compensation Law of the State of Louisiana, and further, under the provisions of R.S. 23:1034 anyone employed by the Contractor shall not be considered an employee of the City for the purpose of Worker's Compensation coverage.
2. **ACKNOWLEDGMENT OF EXCLUSION OF UNEMPLOYMENT COMPENSATION COVERAGE.** The Contractor herein expressly declares and acknowledges that it is an independent contractor, and as such is being hired by the City under this Contract for hire as noted and defined in R.S. 23:1472 (E), and therefore, it is expressly declared and understood between the parties hereto, in entering into this Contract, or agreement for hire, and in connection with unemployment compensation only, that:
  - a. The Contractor has been and will be free from any control or direction by the City over the performance of the services covered by this contract; and
  - b. Services to be performed by the Contractor are outside the normal course and scope of the City's usual business; and
  - c. The Contractor has been independently engaged in performing the services listed herein prior to the date of this Contract.

Consequently, neither the Contractor nor anyone employed by the Contractor shall be considered an employee of the City for the purpose of unemployment compensation coverage, the same being hereby expressly waived and excluded by the parties hereto.

3. **AUDIT AND INSPECTION:**
  - a. The Contractor will submit to any City audit, inspection, and review and, at the City's request, will make available all equipment and/or documents relating or pertaining to this Contract maintained by or under the control of the Contractor, its employees, agents, assigns, successors and subcontractors, during normal business hours at the Contractor's office or place of business in Louisiana. If no such location is available, the Contractor will make the equipment and/or documents available at a time and location that is convenient for the City.
  - b. The Contractor will abide by all provisions of City Code § 2-1120, including but not limited to City Code § 2-1120(12), which requires the Contractor to provide the Office of Inspector General with documents and information as requested. Failure to comply with such requests shall constitute a material breach of the Contract. The Contractor agrees that it is subject to the jurisdiction of the Orleans Parish Civil District Court for purposes of challenging a subpoena.
4. **ASSIGNABILITY.** The Contractor shall not assign any interest in this Contract and shall not transfer any interest in the same without prior written consent of the City.

5. **AMENDMENT.** The Contract shall not be modified except by written amendment executed by duly authorized representatives of the parties.
6. **CHOICE OF LAWS.** This Contract shall be construed and enforced in accordance with the laws of the State of Louisiana, without regard to its conflict of laws provisions.
7. **CONFLICT OF INTEREST.** In the interest of ensuring that efforts of the Contractor do not conflict with the interests of the City, and in recognition of the Contractor's responsibility to the City, the Contractor agrees to decline any offer of employment if its independent work on behalf of the City is likely to be adversely affected by the acceptance of such employment. The initial determination of such a possibility rests with the Contractor. It is incumbent upon the Contractor to notify the City and provide full disclosure of the possible effects of such employment on the Contractor's independent work in behalf of the City. Final decision on any disputed offers of other employment for the Contractor shall rest with the City.
8. **CONVICTED FELON STATEMENT.** The Contractor complies with City Code § 2-8(c) and no principal, member, or officer of the Contractor has, within the preceding five years, been convicted of, or pled guilty to, a felony under state or federal statutes for embezzlement, theft of public funds, bribery, or falsification or destruction of public records.
9. **CONSTRUCTION OF AGREEMENT.** Neither party will be deemed to have drafted the Contract. The Contract has been reviewed by all parties and will be construed and interpreted according to the ordinary meaning of the words used so as to fairly accomplish the purposes and intentions of all parties. No term of the Contract will be construed or resolved in favor of or against the City or the Contractor on the basis of which party drafted the uncertain or ambiguous language. The headings and captions of the Contract are provided for convenience only and are not intended to have effect in the construction or interpretation of the Contract. Where appropriate, the singular includes the plural, and neutral words and words of any gender include the neutral and other gender.
10. **DURATION.** The services to be provided under the terms of this Contract shall begin upon the date of execution of the Contract by the City's Mayor (the "Effective Date") and shall end no later than seven (7) years after the Effective Date. It is understood and acknowledged by all signers to this Contract that work described under these terms is to be accomplished during the time period specified herein.
11. **EXCLUSIVE JURISDICTION AND VENUE.** For all claims arising out of or related to this Contract, the Contractor hereby consents and yields to the jurisdiction of the Civil District Court for the Parish of Orleans, and expressly waives any (A) pleas of jurisdiction based upon Contractor's residence and (B) right of removal to federal court based upon diversity of citizenship.
12. **EXTENSION.** This Contract may be extended at the option of the City, provided that funds are allocated by the Council of the City and the extension of the Contract facilitates the continuity of services provided herein. This Contract may be extended by the City for three (3) additional one-year terms.
13. **INCORPORATION INTO SUBCONTRACTS.** The Contractor will incorporate these Contract Terms and Conditions into all subcontracts, by reference or otherwise, and will require all subcontractors to comply with these provisions.
14. **INDEMNIFICATION.** To the fullest extent permitted by law, the Contractor will indemnify, defend, and hold harmless the City, its agents, employees, officials, insurers, self-insurance funds, and assigns (collectively, the "Indemnified Parties") from and against any and all claims, demands, suits, and judgments of sums of money accruing against the Indemnified Parties: for loss of life or injury or damage to persons or property arising from or relating to any act or omission or the operation of the Contractor,

its agents or employees while engaged in or in connection with the discharge or performance of any Services under this Contract; and for any and all claims and/or liens for labor, services, or materials furnished to the Contractor in connection with the performance of work under this Contract.

- a. The Contractor's indemnity does not extend to any loss arising from the gross negligence or willful misconduct of any of the Indemnified Parties, provided that neither the Contractor nor any of its agents or employees contributed to such gross negligence or willful misconduct.
- b. The Contractor has an immediate and independent obligation to, at the City's option: (a) defend the City from or (b) reimburse the City for its costs incurred in the defense of any claim that actually or potentially falls within this indemnity, even if: (1) the allegations are or may be groundless, false, or fraudulent; or (2) the Contractor is ultimately absolved from liability.
- c. Notwithstanding any provision to the contrary, the Contractor shall bear the expenses including, but not limited to, the City's reasonable attorney fees and expenses, incurred by the City in enforcing this indemnity.

**15. NO THIRD PARTY BENEFICIARIES.** The Contract is entered into for the exclusive benefit of the City and the Contractor, and the City and the Contractor expressly disclaim any intent to benefit anyone not a party to this Contract.

**16. NON-DISCRIMINATION.** In the performance of this Contract, the Contractor will not discriminate on the basis, whether in fact or perception, of a person's race, color, creed, religion, national origin, ancestry, age, sex (gender), sexual orientation, gender identity, domestic partner status, marital status, physical or mental disability, or AIDS- or HIV-status against (1) any employee of the City working with the Contractor in any of Contractor's operations within Orleans Parish or (2) any person seeking accommodations, advantages, facilities, privileges, services, or membership in all business, social, or other establishments or organizations operated by the Contractor. The Contractor agrees to comply with and abide by all applicable federal, state and local laws relating to non-discrimination, including, without limitation, Title VI of the Civil Rights Act of 1964, Section V of the Rehabilitation Act of 1973, and the Americans with Disabilities Act of 1990.

**17. NON-EXCLUSIVITY.** This Contract is non-exclusive and the Contractor may provide services to other clients, subject to the City's approval of any potential conflicts with the performance of this Contract and the City may engage the services of others for the provision of some or all of the work to be performed under this Contract.

**18. NON-SOLICITATION.** The Contractor has not employed or retained any company or person, other than a bona fide employee working solely for him, to solicit or secure the subject Contract. The Contractor has not paid or agreed to pay any person, other than a bona fide employee working for him, any fee, commission, percentage, gift, or any other consideration contingent upon or resulting from the subject Contract.

**19. NON-WAIVER.** The failure of the City to insist upon strict compliance with any provision of the Contract, to enforce any right or to seek any remedy upon discovery of any default or breach of the Contractor at such time as the initial discovery of the existence of such noncompliance, right, default or breach shall not affect or constitute a waiver of the City's right to insist upon such compliance, exercise such right or seek such remedy with respect to that default or breach or any prior contemporaneous or subsequent default or breach.

- 20. OWNERSHIP INTEREST DISCLOSURE.** The Contractor will provide a sworn affidavit listing all natural or artificial persons with an ownership interest in the Contractor and stating that no other person holds an ownership interest in the Contractor via a counter letter. For the purposes of this provision, an “ownership interest” shall not be deemed to include ownership of stock in a publicly traded corporation or ownership of an interest in a mutual fund or trust that holds an interest in a publicly traded corporation. If the Contractor fails to submit the required affidavits, the City may, after thirty (30) days’ written notice to the Contractor, take such action as may be necessary to cause the suspension of any further payments until such the required affidavits are submitted.
- 21. PROHIBITION AGAINST FINANCIAL INTEREST IN AGREEMENT.** No elected official or employee of the City shall have a financial interest, direct or indirect, in the Contract, including through any financial interest held by the spouse, child, or parent. Any willful violation of this provision, with the expressed or implied knowledge of the Contractor, will render this Contract voidable by the City and shall entitle the City to recover, in addition to any other rights and remedies available to the City, all monies paid by the City to the Contractor pursuant to this Contract without regard to the Contractor’s satisfactory performance.
- 22. PROHIBITION ON POLITICAL ACTIVITY.** None of the funds, materials, property, or services provided directly or indirectly under the terms of this Contract shall be used in the performance of this Contract for any partisan political activity, or to further the election or defeat of any candidate for public office.
- 23. REMEDIES CUMULATIVE.** No remedy set forth in the Contract or otherwise conferred upon or reserved to any party shall be considered exclusive of any other remedy available to a party. Rather, each remedy shall be deemed distinct, separate and cumulative and each may be exercised from time to time as often as the occasion may arise or as may be deemed expedient.
- 24. SEVERABILITY.** If a court of competent jurisdiction finds any provision of the Contract to be unenforceable as written, the unenforceable provision should be reformed, if possible, so that it is enforceable to the maximum extent permitted by law, or, if reformation is not possible, the unenforceable provision will be fully severable and the remaining provisions of the Contract will remain in full force and effect and will be construed and enforced as if the unenforceable provision was never a part the Contract.
- 25. SUBCONTRACTOR REPORTING.** The Contractor will provide a list of all natural or artificial persons who are retained by the Contractor at the time of the Contract’s execution and who are expected to perform work as subcontractors in connection with the Contractor’s work for the City. For any subcontractor proposed to be retained by the Contractor to perform work on the Contract with the City, the Contractor must provide notice to the City within thirty (30) days of retaining that subcontractor. If the Contractor fails to submit the required lists and notices, the City may, after thirty (30) days’ written notice to the Contractor, take any action it deems necessary, including, without limitation, causing the suspension of any payments, until the required lists and notices are submitted.
- 26. SURVIVAL.** All representations and warranties and all obligations concerning record retention, inspections, audits, ownership, indemnification, payment, remedies, jurisdiction, venue, choice of law, and warranties shall survive the expiration, suspension, or termination of the Contract and continue in full force and effect.
- 27. SUSPENSION.** The City may suspend this Contract at any time and for any reason by giving two (2) business day’s written notice to the Contractor. The Contractor will resume work upon two (2) business day’s written notice from the City.

- 28. TERMINATION FOR CAUSE.** The City and the Contractor shall each have the right to terminate this Contract for cause, effective immediately upon the giving of written notice to the other party of its intent to terminate and the reasons therefore. "Cause" includes without limitation any failure to perform any obligation or abide by any condition of this Contract or the failure of any representation or warranty in this Contract, and any failure to comply with any provision of City Code § 2-1120 or requests of the Office of Inspector General. If the Contractor successfully challenges the termination for cause in a court, the termination for cause shall be deemed to be a termination for convenience and shall be effective thirty (30) days from the date that the original written notice of termination for cause without any requirement of further notice.
- 29. TERMINATION FOR CONVENIENCE.** The City may terminate this Contract at any time during the term of the Contract by giving the Contractor written notice of the City's intention to terminate at least thirty (30) days before the date of termination.
- 30. TERMINATION FOR NON-APPROPRIATION.** This Contract will terminate immediately in the event of non-appropriation of funds sufficient to maintain this Contract without the requirement of notice and the City will not be liable for any amounts beyond the funds appropriated and encumbered for this Contract.
- 31. TERMS BINDING.** The terms and conditions of the Contract are binding on any heirs, successors, transferees, and assigns.
- 32. WAIVER OF SICK AND ANNUAL LEAVE BENEFITS.** It is expressly agreed and understood between the parties entering into this Contract that the Contractor, acting as an independent agent, shall not receive any sick and annual leave benefits from the City of New Orleans.



Service Area – FQ (Commercial)


Service Area DDD (Residential & Commercial)


