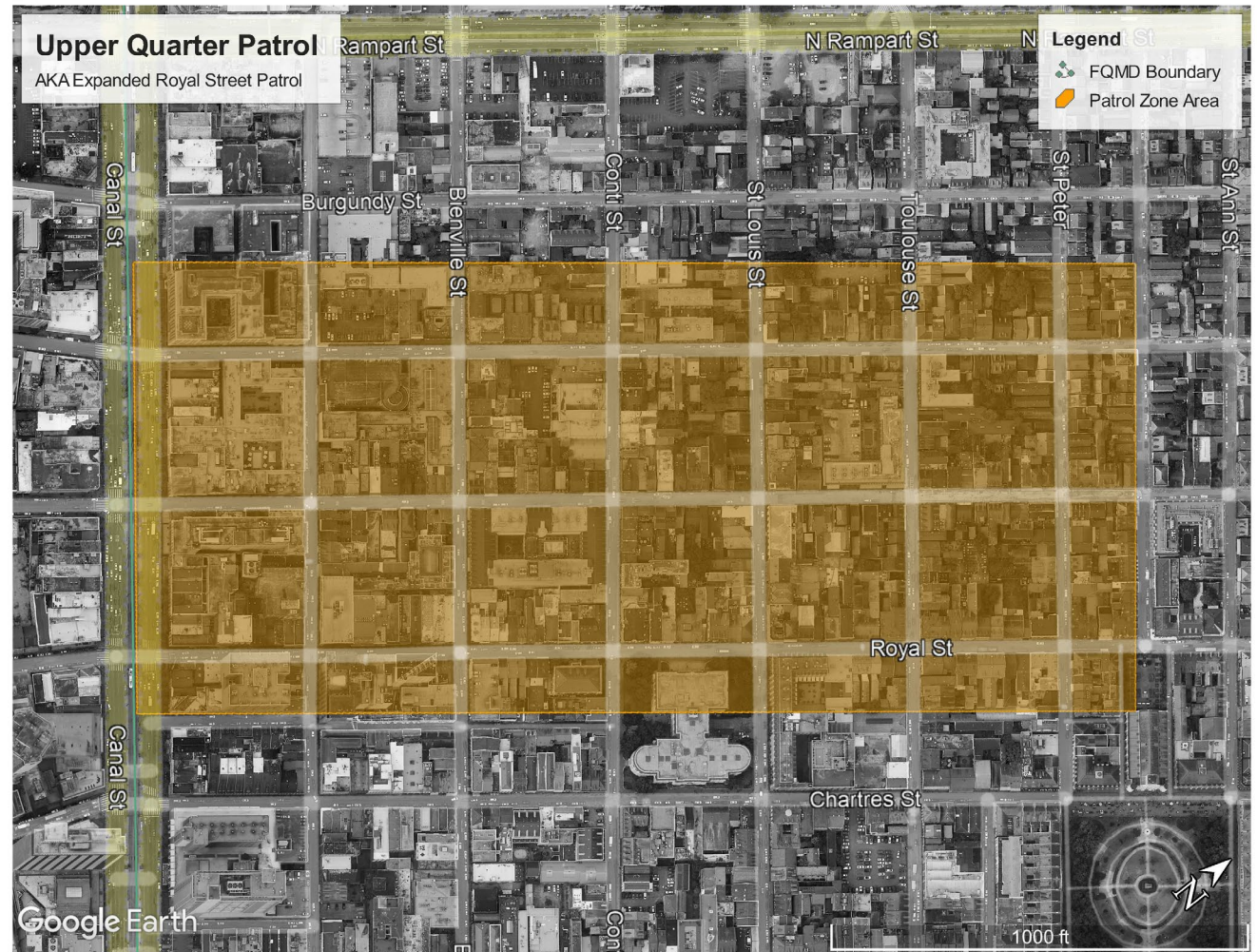

- Detain any suspect who commits any criminal offense and contact NOPD to handle incident.
- Assist with medical and fire emergencies by expediting response via police radio.
- Interact with residents, tourists, business employees, and owners so as to establish and promote public safety within the zone.

Summary of Month Activities

6/8/22

UFQ Patrol was alerted to a potential aggravated assault incident in the 500 block of Royal St. After receiving a description of the offenders, deputies detained 2 suspects in the 400 block of Royal that were positively identified by the reporting person. Deputies additionally discovered one of the suspects to be in possession of a metal blade, which was reported to be brandished in a threatening manner. NOPD was notified of the incident, at which point, deputies escorted the subjects to the 8th district station where they were detained. As a result, NOPD issued one of the subject a summons and notified his LEAD (Law Enforcement Assisted Diversion) case worker.

6/9/22

UFQ Patrol observed and engaged in a brief foot pursuit of a shoplifter that fled from Walgreens at 134 Royal St. After apprehending the perpetrator near Bourbon and Iberville, Deputies detained the suspect, while notifying NOPD dispatch of the matter. The subject appeared to have suffered a minor laceration prior to, or during the incident. As a result, EMS was requested to render aid. Upon arrival, the perpetrator refused treatment. NOPD then issued the subject a summons for theft.

6/27

Deputies were flagged down regarding a shoplifting incident committed in the 500 block of Royal St. After receiving a description of the perpetrator, Deputies were able to detain a subject that was positively identified by the witness and business owner. NOPD was notified of the incident. Upon further investigation, it was discovered that the perpetrator was also enrolled in the LEAD Program (Law Enforcement Assisted Diversion). NOPD elected to issue the arrested subject a summons, while notifying his assigned LEAD case worker.
