4. Discussion by Committee to review staff hours to evaluate billing the French Quarter Economic Development District Administrative Fee

After a one-month evaluation period, the FQMD staff recorded 150 billable hours in August to the FQEDD utilizing the time keeping application. This period included staff paid time off and was comparable to July with that consideration. The committee will determine how best to account for billable hours for the Executive Director for the period of January 2022 through May 2022.

9. Discussion by Committee of a third amendment to the Cooperative Endeavor Agreement with French Quarter Museum Association to extend the term through the year 2023

Ms. Frankic explained the CEA between FQMD and FQMA to the committee to further clarify FQMD's responsibilities in this arrangement.
