#### 2. Public Comment

No written public comment was received at the conclusion of the reading of the agenda.

3. Approval of previous meeting notes

### Ms. Klein made a motion to approve the previous meeting notes. Ms. Raines seconded the motion, and it was approved.

4. Discussion by Committee to review staff hours to evaluate billing the French Quarter Economic Development District Administrative Fee

The Committee discussed how FQMD staff have better captured FQEDD projects and hours.

5. Discussion by Committee considering a policy for recording meetings

Mr. Zumbo discussed the edits from the FQMD Board's attorney with input from Ms. Raines. The Committee decided that the Custodian of Records will be a FQMD staff member and not a volunteer Commissioner. The purpose of the recording policy is to comply with the State public records requirements for a government agency. The recording policy included one edit to remove the custodian responsibility from the FQMD Secretary to match with the policy in the FQMD bylaws per legal counsel. Ms. Bondio asked why the bylaws should be changed now if there has not been a custodian designated among the FQMD staff yet. The Committee decided to hold off on changing the FQMD bylaws regarding the custodian role until the FQMD staff have had the records retention program training held by the Louisiana State Archives through the Louisiana Secretary of State's office.

13. Discussion by Committee regarding a 2023 French Quarter Economic Development District budget

Ms. Raines reviewed the line items of the 2023 FQEDD budget. Ms. Klein asked if the Real Time Crime Center (RTCC) will have additional monitors to accommodate the additional crime cameras being installed around the French Quarter. Ms. Raines responded that the NOPD will be deciding the best practices on this project. Mr. Bilby suggested that the program be properly and efficiently integrated into the RTCC program to allow the introduction of new cameras to flow as smoothly as possible. The chain of command in utilizing these cameras should be clear as the Committee considers hiring two full-time employees as a pilot program in the RTCC to monitor and respond to potential calls of services via the additional crime cameras. Mr. Smith clarified that the additional cameras will be integrated into an already present system, where the response has been more reactive than proactive. Though RTCC crime cameras can be utilized to intervene in a crime in real-time, they primarily are used for informational and evidence gathering purposes at this time. Mr. Smith also stated that the NOPD is not classified as Public Safety and therefore does not decide procedure in the RTCC. The additional proposed RTCC employees would be utilized to monitor the additional cameras in real-time, making the program more proactive.
