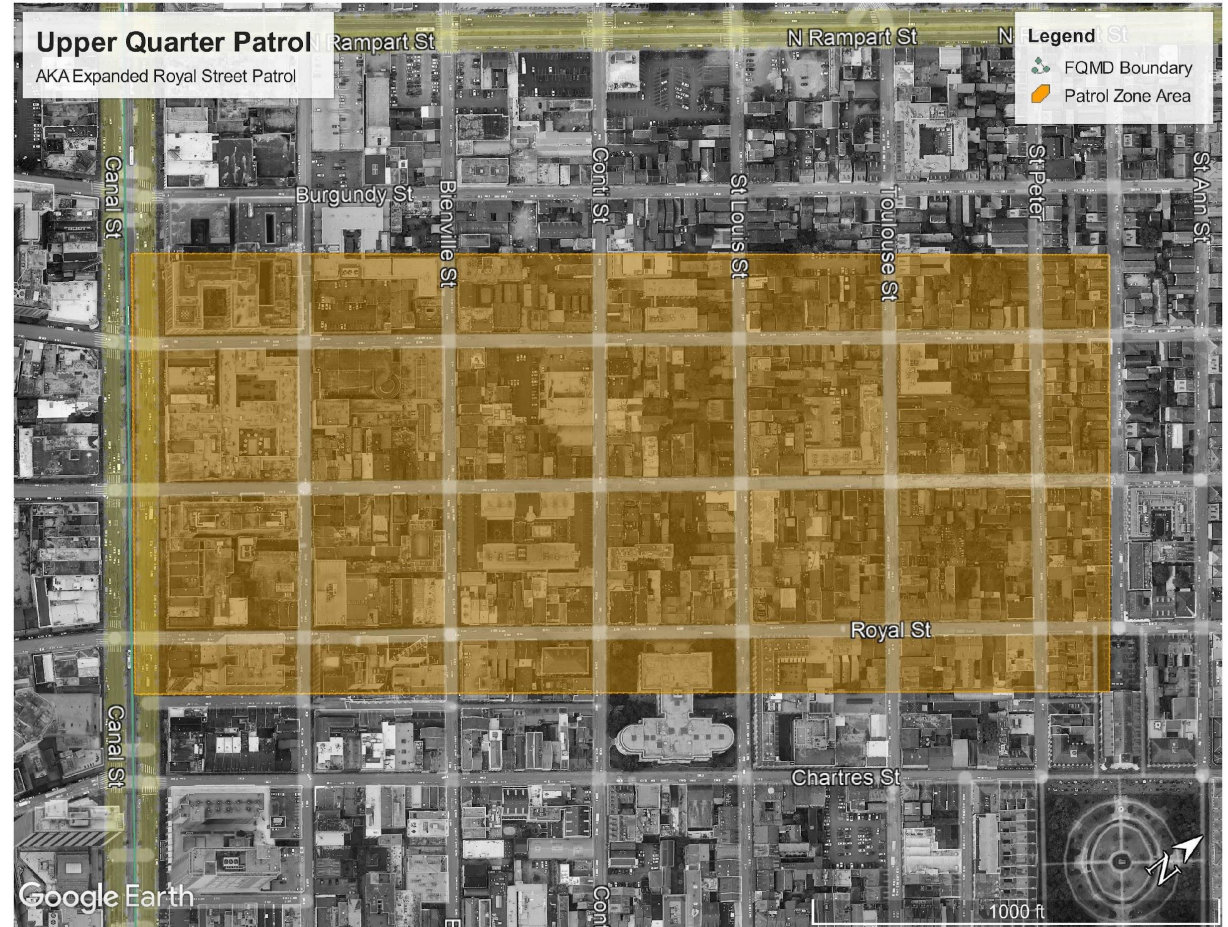

Walking Patrol Objectives

- Provide a visual presence in the patrol zone.
- Deter crime.
- Respond to emergency situations in the designated zone.
- Assist NOPD when such requests are made.
- Report/document quality of life issues in assigned Patrol Zone.
- Detain any suspect who commits any criminal offense and contact NOPD to handle incident.
- Assist with medical and fire emergencies by expediting response via police radio.
- Interact with residents, tourists, business employees, and owners so as to establish and promote public safety within the zone.

Summary of Month Activities

8/2/22: A subject approached UFQ Deputies on patrol grasping a cup containing an unknown liquid. Inexplicably, the individual became irate, at which point, threw the liquid contents of the cup directly at the officers. Deputies then detained and relocated the subject to the eighth district station. At this point, the detained subject continued to be vocally profane, unruly and uncooperative. Subsequently, the individual, who refused to identify himself, was arrested and charged with several municipal violations.

8/16/22: UFQ Patrol Deputies, while on patrol in the 100 block of Royal St, were flagged down by the bellman of the Wyndham hotel. The bellman further stated that 2 homeless individuals were observed removing items from the lobby and attempting to leave. UFQ Deputies were able to confront the subjects and recover all of the property without incident.

Through communication and collaboration with the Sobriety Center, UFQ Patrol Deputies have successfully encouraged several homeless to voluntarily accept assistance. These individuals willingly left with Sobriety House staff in hopes of treatment and successful rehabilitation. UFQ Officers will continue to offer and promote this service to those they contact while on patrol.

Additionally, UFQ Administrator, Matthew Pincus, met and spoke with 8th District, Quality of Life Officer, Johnnie Brumfield. Officer Brumfield expressed interest in the operational coordination of UFQ Patrol Personnel and 8th District NOPD Officers. This cooperative effort would focus on the movement of loiterers from the 100 block of Royal and the 700 block of Canal. Officer Brumfield was advised of the UFQ Patrol Program's willingness to offer support whenever possible. Contact numbers for administrators Matt Pincus and Don Powers were also provided.
