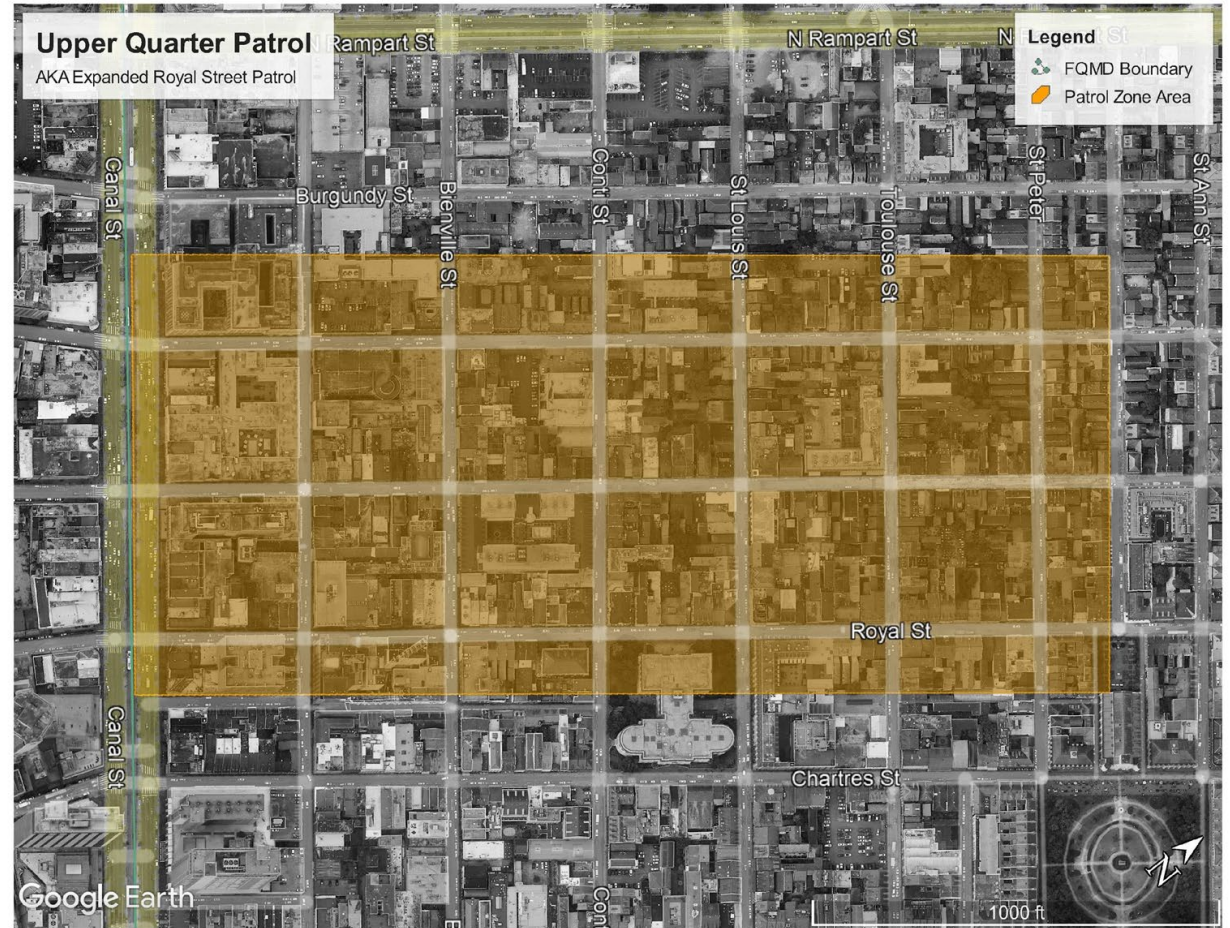

- Detain any suspect who commits any criminal offense and contact NOPD to handle incident.
- Assist with medical and fire emergencies by expediting response via police radio.
- Interact with residents, tourists, business employees, and owners so as to establish and promote public safety within the zone.

# Summary of Month Activities

---

On 9/20/2022, at approximately 11:15pm, UFQ Patrol Deputies were conducting foot patrols in the 500 block of Royal Street, at which time, observed the front door of 536 Royal Street slightly ajar. Upon further observation, Deputies were unable to detect any signs of interior disturbance, nor forced entry. On scene Deputies were able to ascertain a contact number of the business owner from a tenant residing in the building. After successfully contacting the owner by phone, a single UFQ Deputy remained on premise until a representative arrived to secure the front door of the property.

On 9/23/22, at approximately 10am, Deputy Goins of the UFQ Patrol Detail observed a female in the 100 block of Royal known to drink excessively, become disruptive by means of threats, profanity, and physical violence. At the time of the sighting, the female, later identified as, Lionka Perry, was yelling obscenities and antagonizing passing pedestrians. Dep. Goins detained Perry after she refused to comply with the Deputy's instructions. Deputy Goins relocated to the 8th District Station with the female. Due to the unavailability of NOPD units at the time of the arrest, OPSO personnel completed the arrest affidavit and provided transport to Central Lockup via the OPSO transportation division.

As previously mentioned, UFQ Patrol have been provided with Sobriety House contact info. As a result, detail personnel have made additional progress with encouraging more individuals in need to voluntarily accept treatment and rehabilitation assistance from this service.
