Summary of Month Activities

10/01/22:

At approximately 11:55 pm, while patrolling the area of Bienville and Royal streets, UFQ personnel heard multiple gunshots come from the direction of Canal St.

Upon relocating to the intersection of Canal and Royal, Deputies observed a silver Dodge Charger in the right travel lane of 100 St. Charles Ave., which appeared to have several bullet holes in the driver's side door, as well as, spent casings in the street.

Upon further investigation, deputies discovered a male occupant in the driver's seat with an apparent gunshot wound to the leg. Deputies advised NOPD dispatch via radio of the incident, while requesting EMS for the victim. It was determined by UFQ patrol personnel that the perpetrator(s) fled shortly after Deputies arrived on scene. NOPD responded immediately thereafter.

Summary of Month Activities Continued

10/7/22:

UFQ Deputies assisted NOPD in the apprehension of a subject that perpetrated multiple acts of criminal damages to car windows by means of a hammer in the area of Canal and Royal St. The Initial complaint was received by NOPD communications and then broadcasted via radio, at which time, Deputies were able to assist in the apprehension of the suspect without incident. NOPD took the subject into custody and charged him accordingly.

Summary of Month Activities Continued

10/28/22:

At approximately 11:30 pm, NOPD dispatch broadcasted a description of a subject in possession of a firearm walking in the 200 block of Royal St., and then enter the business of Sucre', located at 217 Royal st. UFQ detail officers, while conducting foot patrol in the 200 Block of Royal street, responded to the incident. Both responding Deputies then joined NOPD in entering Sucre'.

As a result, the suspect was apprehended, resulting in the recovery of a fireman that was partially protruding from the subject's right front pants packet. NOPD arrested and charged the individual accordingly.

UFQ Administrator, Matthew Pincus, was recently contacted by 8th district NOPD quality of life officers Johnnie Brumfield and Bronson Gettridge.

In an effort to assist NOPD with the ongoing issues associated with 711 Canal St. (McDonald's) and the 100 Block of Royal St., UFQ detail personnel will be assigned to vehicles with active blue lights in these locations when available. The objective is to deter individuals and groups from loitering, which has been exceptionally problematic in these areas.
