2. Public Comment

3. Approval of previous meeting notes

Mr. Fransen made a motion to approve the previous meeting notes, Mr. Pendleton seconded the motion, and it was approved.

4. Committee Chair Comments

Chair Mamie Gasperecz welcomed members and guests to the meeting and thanked Vice-Chair Holmes for helping lead the team while she was unavailable.

- 5. Update on N. Rampart Street Pedestrian and Bicycle Safety 2023 Work Plan Goal
 - a. University of New Orleans Transportation Planning Grant

UNO has a \$13M transportation planning grant and Ms. Gasperecz is meeting with their team to see how the French Quarter can be included in the Scope of Work. She will report back to the committee what she learns and bring the Executive Director into the next meetings.

b. Speed Display Sign Demonstration

The City is testing out a speed radar at the corner of N. Rampart and St. Philip Street to count and assess speed of vehicles. The data collected will help to establish the need for investment in traffic calming measures on N. Rampart Street. The committee discussed being proactive and not reactive when it comes to identifying resources and funding for improvements for quality of life in the French Quarter. This includes the status of the Nr. Rampart Streetcar.

Meeting guest Mr. Bilby made a public comment that the City's pedestrianization plan included traffic calming on N. Rampart Street and he would like to see those implemented. Ms. Holmes reported that there are preliminary plans for additional striping and improvements to the corner sevens.

6. Update on Sidewalk Assessment 2023 Workplan Goal

Maddie Charleston and Kevin Ferguson from New Orleans & Company have a walkabout scheduled for Friday to look at the condition of the sidewalks, particularly as they relate to ADA compliance.

a. Curb Use Signage 3D Attribute Modeling

b. Protocol Planning for Autumn Sidewalk Assessment

Ms. Frankic reported that she is working with DPW to create a data dictionary and protocol over the summer for the sidewalk assessment to take place this fall. The goal is to collect data that can be used for assessing conditions and attributes that include condition grade of the sidewalks and utility covers in the sidewalks.

The committee asked Mr. Dunkenberger to find the answer to how long has it been since District C had a contract in place for sidewalk repairs? The committee also made a recommendation that when Cyclomedia does future assessments, they do so on street cleaning days so they have an unobstructive view of the streets and sidewalks, which Ms. Frankic will convey.

7. Discussion – New Trash Receptacle Location Recommendations

The Dept. of Sanitation has 100 new trash receptacles that will be replacing broken cans and installing in new locations. The committee discussed a recommendation that there be at least one can at each intersection, locations with bars or gathering places, like bars in residential zones and Cabrini Park, should also have one. Bourbon, Royal, and Decatur Streets need two per block, and one within a block of Bourbon Street on adjacent streets.

The committee asked Ms. Frankic and Mr. Dunkenberger to find the answer to whether the concrete pad that is located under the trash cans is included in the initiative? Ms. Frankic will share map of current trash cans in the French Quarter.

The committee further discussed an interest in an <u>ordinance to require evidence of a current commercial solid waste contract when renewing Occupational License. This would apply to businesses, but the issue would remain for residential properties with more than 4 units. Ms. Frankic will look into the matter and report back to the committee.</u>

8. Report – Keep the Quarter Clean Love the Boot Week Event Results

16 volunteers volunteered for 4 hours shifts supporting the French Quarter Festival's Green Team. The volunteers help divert festival waste from the landfill via composting and recycling. They helped inform festival attendees about the separate bins and sorted waste materials as well.

9. New business – To consider and take action upon any other matters that may properly come before the French Quarter Management District Livability Committee

Mr. Pendleton reported that he and Commissioner Bilby spoke with Cm. King about the committee's concerns about opening up additional street vending when there is illegal vending taking place that in not being regulated or curbed. Mr. Pendleton noted that CM King stated that he supports addressing illegal vending before opening up new street vending in the French Quarter. Mr. Pendleton will also be going to Baton Rouge to ask for help from the State to help the City with additional manpower to address illegal vending. This support may include the Alcohol, Tobacco Commission and Dept. of Health.

The Supplemental Police Patrol Program has ceased placing and removing the Royal Street Pedestrian Mall barricades at the opening and closing hours of the promenade. NOPD is now using overtime officers to mobilize the barricades and monitor the mall for those that are moving the barricades for deliveries, parking, pedi-cabs, etc. Mr. Pendleton said that in his meeting with Cm. King he said that he has met with MaCCNO and they are open to reimagining the Royal Street Pedestrian Mall. He will report when he has more information.

Ms. Dietz made a public comment that Peter Moss is paying for sleeves to go over the metal police barricades that clearly name the Royal Street Pedestrian Mall with the hours. This is intended to provide additional emphasis on not moving the barricades.

The committee asked Mr. Dunkenberger how many vacancies are in Parking Enforcement.

Mr. Pendleton asked that Street Vending and the Royal Street Pedestrian Mall be added to next month's meeting agenda for further updates.

10. Next meeting date - 5 June 2023

The next scheduled meeting date is June 5th and 3:00 pm.

11. Adjournment

Mr. Pendleton made a motion to adjourn the meeting, Mr. Williams seconded the motion and the meeting adjourned at pm.


Cyclomedia blurb . . .

The City of New Orleans Department of Public Works has contracted with Cyclomedia to produce a digital capture of the City's 2,000 miles of streets. 36 with a car equipped with a specialized camera. The equipment also includes LIDAR capture meaning that a 3D model can be created providing Z or elev street view, slopes can be calculated, and flood scenarios (based on entering a flood elevation) can be simulated.

In addition to the imagery and elevation capture, public ROW assets can be extracted from the imagery and made into vector GIS datasets. Examples of street pavement edge, and sidewalk edge. These datasets are the foundation for the next effort of asset management software acquisition.

Cyclomedia won the asset collection contract via RFP in December 2023 and the data collection drives were conducted in February/March 2023. The RF
