2. Public Comment

No written public comment was received.

3. Motion – Consider a motion to approve the previous meeting notes

Maddie Charleston motioned to approve the previous meeting notes. Erin Holmes seconded the motion, and it was approved.

4. Committee Chair Comments

Mamie Gasperecz welcomed the Committee members and thanked them for their attendance. She reported that the University of New Orleans is conducting an excavation at the St. Louis Cathedral and will have a report published of their findings.

a. 2024 Livability Committee Work Plan

The French Quarter Management District is a state political subdivision created by the Louisiana Legislature as a means for the residential and business communities to work together to protect, preserve, and maintain the world famous French Quarter as a safe, clean, vibrant and friendly neighborhood for residents, businesses, and visitors.



See attached document. Ms. Gasperecz reviewed the 2024 Livability Committee Work Plan with the Committee members and thanked Ms. Holmes for her additions to the document. Ms. Gasperecz noted that the plan needs to be finalized and submitted to the Board of Commissioners for the February 19th Board meeting. She welcomed the Committee members to provide feedback. The Committee reviewed the plan and made revisions regarding the sidewalk goals. Ms. Gasperecz stated the importance of educating and bringing awareness to the private property owners in the French Quarter of standards and enforcement regarding sidewalks. Antonio Carbone motioned to amend the 2024 Livability Committee Work Plan by adding a bullet point to create a universal standard for sidewalks and advocate for ADA compliance. Ms. Charleston seconded the motion, and it was approved.

5. Discussion – Discussion by Committee of Traveler's Aid Society of Greater New Orleans Updates. To present: Karley D. Frankic

See attached report. Karley Frankic reviewed the report with the Committee, noting that by the end of 2023, the Traveler's Aid Society of Greater New Orleans (TASGNO) placed 18 individuals into permanent housing despite the State's slowdown of issuing housing vouchers in June. She reported that TASGNO hired a third case manager in December and will be procuring a vehicle for taking clients to their appointments. Ms. Frankic stated that TASGNO has identified 30 potential clients for the Rapid Rehousing Program and has prepared a list of Key Performance Indices (KPIs) to measure the program's success.

6. Discussion – Discussion by Committee of Covenant House Outreach Program Updates

Ms. Frankic reported that Melissa Tyler of Covenant House will be attending the February Board meeting to discuss the Outreach Program with the Commissioners. She stated that Ms. Tyler attended the January Agreement Monitors meeting and discussed and finalized KPIs with the Monitors. Ms. Holmes noted that the City has not been contacted about moving forward with the Covenant House funding. Ms. Frankic will send Eric Smith Ms. Tyler's contact information.

7. Discussion – Discussion by Committee of North Rampart Infrastructure and Safety Updates. To present: Erin Holmes and Antonio Carbone

Ms. Holmes reported that the North Rampart projects are moving along successfully. She stated that a lot of work has been put into these initiatives from every team member and noted that Jennifer Preston helped the team create the Request for Proposals (RFP) for this project. Mr. Carbone added that two RFPs were created, one for rectangular flashing beacons and the other for methyl methacrylate (MMA) paint for bike lanes and curb extensions as well as sturdier flex posts for the curb extensions. Ms. Holmes stated that Louis Haywood of the Department of Public Works (DPW) has helped the team use the City's mapping service to provide the group with detailed maps with the vital project details. Mr. Carbone stated that if Committee members have any contractor recommendations to send their contact information to Ms. Holmes or himself. Ms. Frankic reported that the two RFPS will be reviewed by the Finance and Development Committee tomorrow and then by the Board of Commissioners on February 19th before going out to bid.

8. Discussion – Discussion by Committee of Department of Public Works Streetlight Repair Report. To present: Karley D. Frankic.

See attached report. Ms. Frankic reviewed the report with the Committee members and stated that DPW's cost estimate of \$2M for streetlight repairs includes streetlights on the other side of Canal Street. Ms. Gasperecz asked Ms. Frankic when the FQMD conducted a streetlight survey in the past. Ms. Frankic answered that the first survey was in 2022 and added that more fieldwork verification was conducted in 2023. She stated that she plans to compare the DPW's report to the FQMD spreadsheet. She reported that at the January Agreement Monitors meeting, the Monitors agreed on prioritizing the crime hotspots with the \$150,000 streetlight allocation that was approved in the 2024 FQEDD budget. Mr. Carbone suggested also focusing on as many low-budget repairs as possible, pointing out that some poles only need a bulb replacement.



- 9. Discussion Discussion by Committee of Glass Half Full Recycling for Coastal Restoration. To present: Jane Cooper
 - a. Mardi Gras Bead Recycling Program

See attached document. Ms. Gasperecz reported that the FQMD teamed up with the Downtown Development District and Glass Half Full and launched a Mardi Gras bead recycling program on February 1st that has five participating French Quarter hotels. Ms. Frankic noted that, since the press release, more French Quarter hotels have reached out to be a part of the program, but the contract is already moving forward to the Finance and Development Committee. She added that she encouraged the interested hotels to join the effort in 2025. Ms. Holmes updated the Committee on the glass recycling plans with Glass Half Full, reporting that three locations within the interior of the French Quarter are being finalized. She noted that these efforts will be picking up after Mardi Gras.

10. Discussion – Discussion by Committee of City Sanitation Contract

See attached document. Ms. Frankic stated that the Dept of Sanitation plans to release the French Quarter and DDD RFP in March. She encouraged the Committee members to review the "Priorities for New Sanitation Contract" that was approved by the Board in 2021. Mr. Carbone stated that he wanted to see the manual sweeping behind the garbage trucks be enforced more, adding that he would like item 2.D. in the document to be underlined. Ms. Frankic said that the City would need to change the City code to reduce the maximum weight of garbage trucks to effect all solid waste contractors, not just this one. Ms. Charleston pointed out that emails sent to QuarterClean@fqmd.org commonly deal with tasks like removing furniture, which is not in the contractor's agreement with the City. Mr. Smith noted that the City has proposed putting a dedicated Sanitation Ranger into the FQEDD budget, adding that this would not be difficult to implement such a new position. Continuing to review the document, the Committee made a minor amount of revisions. Ms. Gasperecz suggested the Committee review the sanitation survey conducted by the FQMD in 2021 and consider reissuing the survey. Ms. Frankic will make the agreed upon revisions and send the revised document to Ms. Gasperecz and Ms. Holmes for final approval before sending the contract to the Sanitation Director, Matt Torri.

11. Discussion – Discussion by Committee of Acquisition of Additional Trash Receptacles

See attached document. Ms. Frankic reported that 100 additional trash receptacles will be purchased with the State appropriation funds. She stated that she spoke with Matt Torri who suggested that 10 percent overages for liners and receptacle doors also be included in the purchase, so that a stockpile of materials is readily available. Ms. Frankic reported that she requested Jennifer Garin of Clean Force to send a list of litter hotspots so that the Committee can come up with recommendations for the locations of the additional receptacles. She noted that no RFP is required for this purchase and the City has deemed it a sole source vendor already. The trash cans will be donated by act to the City of New Orleans upon order placement. After the order is placed it will take two to three months to be delivered and the City will take possession and install the cans. Ms. Holmes pointed out that if the trash receptacles had asset IDs it would be easier to track them. Ms. Frankic will ask the City for the French Quarter trash receptacle asset IDs. Mr. Carbone suggested creating a system that would utilize QR codes per receptacle so residents can scan the code and forward the information while reporting to Quarter Clean. Ms. Frankic will speak further with Mr. Carbone about creating an asset ID/QR code system for identifying the trash receptacles.

12. New business – To consider and take action upon any other matters that may properly come before the French Quarter Management District Livability Committee

No new business was discussed.

<u>Total # of Encountered Individuals who were connected to housing programs (have vouchers issued to them)</u> but were not housed by end of month

These individuals have (or had at any point in the month) a housing voucher issued to them but did not move into housing by the end of the month. This can be because their housing program is still looking for an available/affordable unit or because they are not in sufficient contact with their housing program. Because 7 of the 27 encountered individuals were housed prior to or during this month, this means 0% of (0 of the 20) encountered individuals who were still homeless by December 31st are connected to housing vouchers (which could pay their rent) but are not connected to actual available housing where they can use their vouchers.

These individuals have previously not only been connected to/approved for housing assistance from a program like Unity or HANO but had also moved into that housing after a period of homelessness and have since returned to homelessness again. This number does not include individuals who maintain their housing but choose to spend time outside for social/personal reasons and/or who are temporarily sleeping outside because they have lost access to their housing for now (e.g., due to misplaced keys or water shutoff).

Year- End Outreach Reflections:

This report is the last from the first year of the French Quarter street outreach partnership between Travelers Aid Society of Greater New Orleans (TASGNO) and the French Quarter Economic Development District and the French Market Corporation (FQEDD and FMC). Successes have included moving 18 individuals into permanent housing, providing 133 connections to some form of treatment (medical, mental health, and/or substance use), facilitating 138 enrollments into public benefits (SNAP, Medicaid, and or SSI/SSDI), and obtaining 111 vital documents (State IDs, birth certificates, and/or social security cards) for and with unhoused individuals living on the streets of the French Quarter over the past 12 months.

Notably, this work was conducted with and for 252 unique individuals. Comparatively, the summer 2021 study TASGNO conducted with funding from both FQEDD and FMC generally yielded data indicating an average of 143 individuals slept on the streets each night and that as many as 170 unhoused individuals spent time in the area during the day. Every month of this project, the TASGNO has encountered new individuals, though in the latter half of the year, that number of never-before-seen individuals averaged at 13 new individuals encountered per month – indicating, perhaps, that there is a consistent churn of about +/- 13 new individuals in the area each month, with the unique individuals encountered each month averaging at about 42, indicating maybe 30% of the encountered population may turnover,

while as much as 70% of the population may stay consistent. It should be noted that all these data points are limited by case manager capacity – with just two outreach workers, it is not possible to talk to every unhoused individual every month, especially as the case managers are consistently also focused on providing intensive, housing-focused case management to the most vulnerable individuals in the area, as opposed to simply always engaging all individuals for the sake of creating census-style data about them.

As 2024 begins and the FQEDD and FMC consider other investments, including the expansion of outreach services and rental assistance for 20 unique individuals, it will be seen how such investments can allow for both more complete coverage of all unhoused individuals in the area and a more efficient flow of unhoused individuals living on the streets of the French Quarter into housing, as the availability of housing subsidies and rental assistance funds play large roles in determining how many individuals can end their homelessness with housing at any given moment. This has been especially observable this year, when, as commented on in previous months' reports, the largest housing program for formerly unhoused persons in the area – the state permanent supportive housing program – has greatly slowed and essentially paused its acceptance of new referrals into its program, meaning many individuals eligible for and interested in housing who have completed all the necessary application steps have simply been waiting for the needed assistance to be assigned to them.

Sanitation Contract Position Paper

Priorities for New Sanitation Contract

- 1. Request for Proposal response evaluation for Lowest Qualified Bidder to include a weighted review matrix to establish terms beyond cost
 - a. Past Performance including performance in other municipal contracts.
 - b. Local ownership
 - c. Disadvantaged Business certification
- 2. Collection
 - a. Provide option for smaller garbage carts that will fit in narrow spaces available in the district
 - b. Provide option for larger residential properties and businesses to opt into City contract with competitive pricing
 - c. Reduce times for collection i.e. hours carts and garbage bags can be on curb to 4:30 pm 8:30 am*
 - d. Require manual sweeping behind garbage collection trucks
- 3. Require nighttime manual sweeping and emptying of public trash cans in heavily trafficked commercial areas, including Bourbon Street
- 4. Include weight limits on garbage trucks
 - a. Create incentive for appropriately sized garbage trucks
- 5. Require administrative costs for fulltime coverage of Sanitation Ranger in the French Quarter & Downtown
- 6. Include performance standards for accountability
 - a. Measurable and trackable with data-based analytics
 - i. Standards for pressure washing technique
 - ii. Water temperature for street washers
 - iii. Biodegradable cleansers for street washing
 - iv. Deodorizer for street washing
 - v. Include biodegradable, environmentally approved, weed killer in pressure washing cleanser
 - vi. Consistent litter abatement and public can emptying
 - vii. Maintain locks on public trash cans
 - b. Procedure for public feedback and reporting with trackable analytics utilizing a user-friendly interface such as a QR code.
 - c. Enforceable penalties for non-performance
 - i. Financial penalties
 - ii. Clear path to contract cancelation for repeated non-performance based on data analytics.

Priorities for Ordinances/City Charter Amendments EXISTING LAWS

RESIDENTIAL GARBAGE

Sanitation Contract Position Paper

- Place garbage in an approved, closed, roll cart, or in at least .8 mil black bags in front of your property. White plastic or paper bags and boxes are prohibited. Garbage in unauthorized containers will not be collected. §138-38,39,42,43,47
 - Provide option for residents and small businesses to elect to switch from garbage carts to heavy mil. bags
- Properties containing more than 4 units must hire private service. §138-45
 - Create opportunity for larger residential properties and businesses to opt into public collection with charge back to user.

COMMERCIAL GARBAGE

- Hotels, restaurants & bars; and businesses generating more than 35 gal per pick up must hire private service. §138-45
 - Create opportunity for larger businesses to opt into public collection with charge back to user.
- Haulers must pick up 4-8am and/or 4-6pm. §138-42(b)
 - Revise hours to 5-8 am* and/or 4-6pm
- GARBAGE PLACEMENT
 - No garbage carts on public property 9am–3:30pm. Carts must be stored on private property. §138-42(a)
 - Revise times to 8:30am 4:00 pm*


New Laws Related to Sanitation

- Require no less than 3 public trash cans per block or every 30 feet for densely littered areas.
- Establish weight limits within the oversized vehicle ordinance based on research from laws set in other historic cities and with an understanding of how many tons each truck actually collects within the area.
- Activate location for garbage transfer on City owned property close to the French Quarter & Downtown to accommodate smaller garbage trucks. Locations under consider with early conversation with surrounding neighbors.

Department of Sanitation Coordination

- Increase Sanitation Ranger capacity in the French Quarter & DDD for fulltime coverage.
- Provide Sanitation Ranger with citation writing authority.

^{*} Committee members to discuss proposed times with the four private haulers operating within the French Quarter as to the necessary window of time and tonnage for them to complete their contracted pickups.




