2. Public Comment:

No written public comment was received.

3. Motion – Consider a motion to approve the previous meeting notes

**Steve Caputo motioned to approve the previous meeting notes. Glade Bilby seconded the motion, and it was approved.**

4. Committee Chair's Comments

Vice-Chair Jessica Dietz welcomed the Committee members and thanked the NOPD officers for their hard work during Carnival season.

5. Presentation – Presentation of Eighth District Crime Statistics and the Supplemental Police Patrol Program. (Green Sheet)  
To Present: Sgt. Marc Boudreau

# French Quarter MANAGEMENT DISTRICT

See attached report. Sgt. Marc Boudreau reviewed the report with the Committee. Jane Cooper asked how many guns were taken off of Bourbon Street during Mardi Gras. Cpt. LeJon Roberts replied that there were over 120 guns confiscated from Bourbon Street alone, thanking and attributing the successful sweep to Lt. Chuck Ward who took charge while Cpt. Roberts was away during the Carnival season. He noted that little to no force was needed while confiscating the guns. Cpt. Roberts reported that the NOPD and the Louisiana State Police (LSP) have been working effectively together during Carnival. He stated that he will be attending a meeting with the LSP this week about their impending permanent deployment in New Orleans. He noted that the NOPD is concerned about the permit-less carry law that has been introduced in the State legislature, adding that he hopes modifications can be made to the bill prohibiting guns from the French Quarter, particularly on Bourbon Street. Ms. Dietz suggested having this topic be an agenda item for discussion and monitoring moving forward. She suggested that FQMD may need to take a position and actively work on this issue.

## a. New Patrol Vehicle Wrapping and Light Installation Status

Sgt. Boudreau reported that purchase orders were issued last week for both the Chevy Bolts and the Gators. He stated that he is waiting on a call to pick up the Gators today, noting that once the vehicles are wrapped with the lights are installed, they will be ready for the streets.

## 6. Presentation – Presentation on the monthly report of the Upper Quarter Patrol. (Purple Sheet) To present: Matthew Pincus

See attached report. Matt Pincus reviewed the Upper Quarter Patrol (UQP) report with the Committee. Ms. Cooper asked Mr. Pincus if he could share more of the UQP's successful anecdotes and statistics with New Orleans & Company in order to reinforce the value of the program.

## a. Discussion – Discussion by Committee of agreement terms related to rates of the Upper Quarter Patrol agreement

See attached document. Mr. Pincus stated that rates will depend, in part, on the Deputy's rank and status in the department. He noted that the shift time of day will also be taken into consideration. Mr. Pincus reported that the intended target times for coverage are between 7pm/8pm to 3am/4am, stating that the preferable coverage would be 8pm to 4am. He noted the importance of coordinating with the NOPD to assure that they can work together to provide support and backup to the 8<sup>th</sup> District command. He stated that a small group of deputies are in training to do the patrols and pointed out the need for departmental vehicles for the patrol officers. He informed the Committee that permanent shifts are in the process of being created.

## 7. Discussion – Discussion by Committee of Updates on the Upper Quarter Patrol Expansion Program

See attached document. Ms. Cooper stated that the expansion is dependent on receiving the funds from the State, noting that the Treasury Department has been slow to complete the process, adding that she hopes to hear back on the CEA by the end of this week. Mr. Pincus reviewed the UQP zone map with the Committee and discussed which sub-zones will be prioritized when personnel is limited. He reported that he has a meeting with the Orleans Parish Sheriff's Office to discuss the expansion further. Ms. Dietz stated that the next step is finalizing the QR code technology for the officers.

## 8. Presentation – Presentation of Travelers Aid Society of Greater New Orleans. (Orange Sheet) To Present: Karley D. Frankic

### a. Case Management January Report

See attached report. Karley Frankic stated that TASGNO has onboarded the third case manager, noting that they are now trained and out on the streets working. Ms. Frankic informed the Committee that the Key Performance Indices (KPIs) that were put in place last year for TASGNO's outreach team were carried over for this year's monthly reporting.

### b. Rapid Rehousing Program launch and Key Performance Indices

Ms. Frankic reported that at last month's Agreement Monitors meeting, the Monitors established KPIs for the Rapid Rehousing Program, noting that the Committee will see these reflected in the monthly KPI report moving forward. She stated that the KPIs include the number of individuals enrolled in the program, the number of individuals moved into housing using the flex fund, the number of returns to homelessness in the program, and the number of individuals bridged to permanent housing. noted that Nathaniel Fields, Angela Owczarek, and Melissa Tyler of Covenant House all attended the February Board meeting to discuss the homeless services programs and to address questions posed by the Commissioners. Ms. Cooper added that the guests reminded the Board that these groups do not do law enforcement but provide outreach and connect individuals to services. Mr. Caputo noted that some cleanup with homeless encampments has already taken place. Ms. Dietz asked Ms. Frankic if there was an update on TASGNO acquiring a vehicle. Ms. Frankic replied that she will get an update from Ms. Owczarek at the Agreement Monitors meeting.

## 9. Discussion – Update on Streetlight repairs and survey fieldwork

Ms. Dietz reported that the streetlight fieldwork is scheduled for this week. Ms. Frankic stated that one of the goals with the fieldwork is to figure out how to prioritize the \$150,000 put aside in the FQEDD budget for streetlight maintenance. She noted that at last month's Agreement Monitors meeting the Monitors agreed that prioritizing the crime hotspots would be the most beneficial use of the funds.

## 10. Discussion – Update on Real Time Crime Center Crime Camera Installations

Eric Smith reported that there are 81 crime cameras installed and operational as of today, noting that there are around 20 left that need to be installed. He noted that the Real Time Crime Center (RTCC) is currently reworking the wireless connectivity for the cameras to improve resiliency, stating that the RTCC expects to have all electrical and wireless issues sorted out within the next six weeks. Sgt. Boudreau reported that, of the four months that the cameras have been in place, videos were downloaded 327 times to assist in investigations. Cpt. Roberts noted that the crime cameras have been instrumental in assisting the Eighth District, noting that even when the camera feeds are not live, the camera is fully functional and recording and the footage can be manually downloaded.

## 11. Presentation – Presentation of Updates on City Safety Coordination Efforts by City Chief Administrative Office. To Present: Eric Smith & Alex Dunkenberger

### a. Supplemental Police Patrol App Request for Proposals and Contract Status

Mr. Smith reported that the Request for Proposals (RFP) for the SPAPP app was completed and awarded to SDT Productions based on the scoring rubric. He announced that he has a meeting with City Legal and SDT Productions tomorrow to begin working on a contract and discuss the app functionality. Mr. Smith stated that if both parties cannot come to terms, the RFP will be immediately reissued and left open for a minimum of two weeks.

### b. FQEDD Code Enforcement Inspector Status

Mr. Smith reported that the FQEDD Code Enforcement Inspector will be attending today's Agreement Monitors meeting, noting that the Inspector is a veteran officer that was transferred into this position. Ms. Dietz asked if the Committee can get reporting from the Inspector at March's Committee meeting. Mr. Smith answered yes, noting that the KPIs will be reported in the FQEDD monthly KPI report. Mr. G. Bilby asked if there was a way to submit information to the Inspector for them to look into. Mr. Smith answered yes, stating that locals and businesses can utilize [fqcode@nola.gov](mailto:fqcode@nola.gov) to report any concerns or complaints.

## 12. New Business– To consider and take action upon any other matters that may properly come before the French Quarter Management District Security and Enforcement Committee

Mr. G. Bilby stated that he would like the FQMD to take a position on making the French Quarter a gun-free zone. Alex Fein stated that he will also discuss the matter with the French Quarter Business League before the next Committee meeting. Joshua Grippo said that though he is in full support of advocating for the French Quarter to become a gun-free zone, he pointed out that an awareness campaign would need to be implemented so that locals and visitors were made fully aware.

## 13. Next Meeting Date:

The next scheduled meeting of the Committee is Monday, March 25<sup>th</sup>, 2024, at 11:00 am.

## 14. Adjournment

Frances Hegenberger made a motion to adjourn. Mr. G. Bilby seconded the motion, and the meeting was adjourned at 11:56 am.

# Summary of Month Activities

At around 5:40pm, while assigned to the UFQ Patrol in the 100 block of Royal Street, OPSO Lt. Ernest Newman observed a black male screaming while running on foot from Iberville Street into the 100 block of Royal Street. After successfully detaining the subject without incident, Lt. Newman was advised of the following:

- Minutes prior to encountering Lt. Newman, the black male was involved in a dispute with an unidentified white male at the corner of Bourbon and Iberville Street.
- During the verbal exchange, the white male produced and fired a semi automatic handgun at the black male. The white male then fled the scene in a dark colored SUV.

After learning that the black male was actually the intended victim of the incident, Lt. Newman advised the victim to speak with NOPD, who arrived on scene shortly thereafter. The incident was documented under NOPD item number A-10011-24.

1/19/24

At approximately 2:15pm UFQ Deputies conducting routine patrols in the 700 block of Canal Street observed what appeared to be an altercation between DDD Rangers and a white male. Upon arrival, Deputies further learned from the Rangers that the white male, known to frequent the area, was reported to have been causing a disturbance inside the business. The Rangers went on to state that upon approaching the unruly individual, the male subject swung a large stick in an attempt to strike them. Fortunately, both were able to avoid being struck. The offender was then detained without further incident by UFQ patrol deputies. Shortly thereafter, NOPD arrived on scene and placed the perpetrator under arrest for assault. The arrested subject was then transported to central lockup for booking.

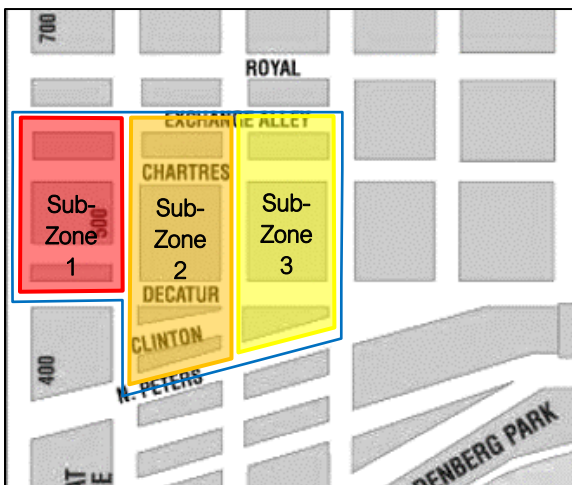

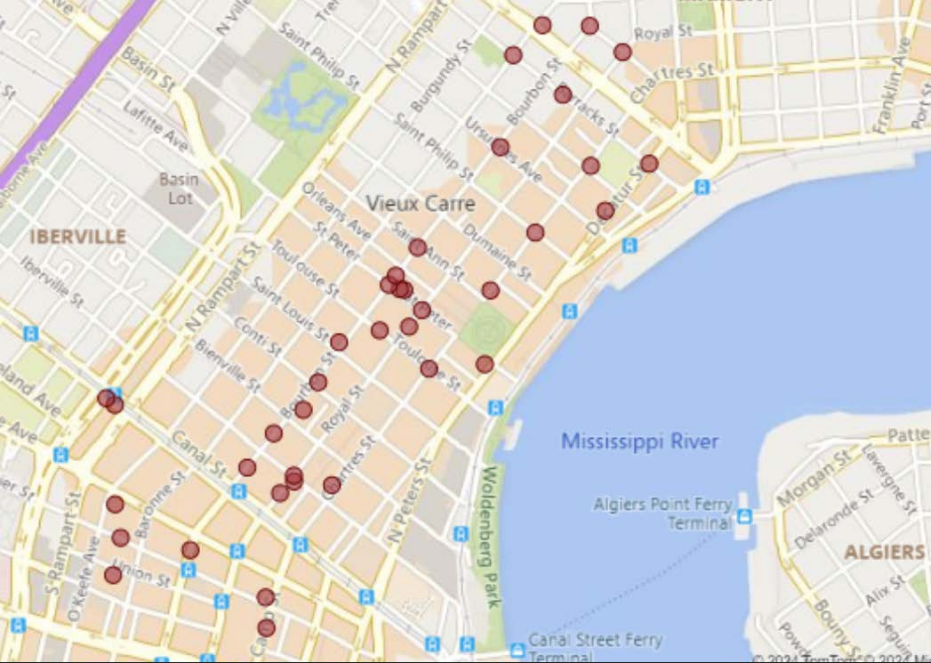
**Outreach Successes:**

This month, the French Quarter outreach team welcomed its new staff and assisted them through agency training for several weeks and then they began to meet unhoused individuals on the streets of the French Quarter and assist them with case management, inclusive of helping them complete housing and benefit applications, attend doctors' appointments, regain their vital documents, and generally become engaged in the case management service process.

This month, two individuals living on the streets of the French Quarter were also newly matched to housing vouchers that will pay their rent. One was able to move into housing within about a week of receiving her voucher, and the other moved in by the time of this report's writing, in February. We are excited to welcome these two individuals home, especially because both were matched to other housing programs within Travelers Aid, so we can continue to hear about their progress as they adjust to life off of the streets.
