2. Public Comment:

No written public comment was received.

3. Motion – Consider a motion to approve the previous meeting notes

**Joshua Grippio motioned to approve the previous meeting notes. Frances Hegenberger seconded the motion, and it was approved.**

4. Committee Chair's Comments

Christian Pendleton thanked the Committee members for their attendance and thanked Vice-Chair Jessica Dietz for her hard work over the last few months. He stated that the FQMD stands in a good place with the State to potentially receive additional funding for streetlight repairs, noting that in order to do this a Cooperative Endeavor Agreement (CEA) will need to be created that authorizes the FQMD to oversee the repairs. Mr. Pendleton will continue to update the Committee on this matter. He added that with the Super Bowl less than a year away, the FQMD must push forward and continue to nudge City officials to get things prepared. Cpt. LeJon Roberts added that the Eighth District has been in constant communication with law enforcement agencies in Jefferson Parish and Saint Bernard, as well as with the Louisiana State Police to discuss preparations for the 2025 Superbowl, noting that he is confident that a safe and secure Super Bowl will take place.

## 5. Discussion – Update on Concealed Carry Bill

Cpt. Roberts reported that the concealed carry bill is set to go into full effect on July 4<sup>th</sup>. He stated that a lot of people are opposing this bill, including Superintendent Kirkpatrick. Cpt. Roberts stressed his concern of how this bill will effect his officers and their safety, as well as the safety of the residents, tourists, and businesses in the French Quarter. He noted that the Eighth District officers came up with some strategies that they will present to the Superintendent. Cpt. Roberts reported that the Eighth District had their first negligent carry charge last week. Ms. Dietz suggested that the Committee monitor the negligent case as it moves forward. Cpt. Roberts added that though the possibility of an amended bill that would make the French Quarter a gun-free zone was previously discussed, most likely this will not come to fruition.

## 6. Presentation – Presentation of Eighth District Crime Statistics and the French Quarter Patrol. (Green Sheet) To Present: Sgt. Marc Boudreau

See attached report. Sgt. Marc Boudreau reviewed the February Eighth District crime statistics with the Committee, noting that shift coverage was down to 58% due to officers being pulled for Carnival Season parade routes. Cpt. Roberts reported that Sgt. Boudreau is being promoted and will be moving onto his next career venture. He stated that he is proud of the hard work Sgt. Boudreau has put toward the French Quarter Patrol and reported that the transition of Sgt. John Castelin taking over the role should be seamless. The Committee thanked Sgt. Boudreau for his hard work and dedication.

### a. New Patrol Vehicle Wrapping and Light Installation Status

Sgt. Boudreau reported that the Gators are wrapped and are waiting for the light bars. He stated that the Bolts will begin the wrapping process this week.

## 7. Presentation – Presentation of Upper Quarter Patrol. (Purple Sheet) To Present: Matthew Pincus

### a. Upper Quarter Patrol February Report

See attached report. Matt Pincus reviewed the February report with the Committee, reminding them that there were 10-14 days of no service during Carnival Season. He reported that two Upper Quarter Patrol (UQP) officers have been discharged for failure to comply with rules and regulations and added that three weekday evening positions from 4 PM to 10 PM have been onboarded. Alex Fein stated that he wanted to praise Mr. Pincus and the UQP, noting that when he recently called the officers to report an issue at his business, the officers where there within minutes to help.

### b. Expanded Upper Quarter Patrol Launch

Mr. Pincus reported that the soft launch of the UQP expansion commenced last Friday, thanking Ms. Dietz for attending the launch and helping out. He reported that during the soft launch the zones were shown to the officers on foot, the protocol was explained, and expectations were conveyed. He noted that the officers also had the opportunity to respond to some calls for service throughout the weekend. Ms. Dietz reported that the officers resolved incidents including a business alarm going off, a self-inflicted cutting, juveniles pulling on car doors, and an attempted car-jacking. She noted that the officers also had community engagement, with residents and children speaking with them and asking questions. Ms. Dietz stated that it was a great start to the program. Cpt. Roberts agreed and stated that Mr. Pincus and Ms. Dietz did a great job, and the Eighth District welcomes the added coverage and partnership.

## 8. Presentation – Presentation of Travelers Aid Society of Greater New Orleans. (Orange Sheet) To Present: Karley D. Frankic

### a. Street Outreach Case Management February Report

See attached report. Karley Frankic reviewed the report with the Committee, noting that a big success for TASGNO in February was having a client who had been unhoused on and off since 2016 find housing. She noted that TASGNO still faces challenges with long-term support care.

### b. Rapid Rehousing Program Launch and First Key Performance Indices Report

See attached report. Ms. Frankic reviewed the Rapid Rehousing Program KPIs for the month of February and informed the Committee that 20 individuals have been identified for the program. She noted that two of these individuals originally targeted

for the Rapid Rehousing Program were recently housed through a different housing voucher program. Ms. Frankic stated that TASNCO is still waiting for the funding for this initiative. Mr. Smith added that there is a delay in the receiving of funds because of the delay in getting the finalized French Quarter Economic Development District (FQEDD) budget approved by both the FQEDD and the City Council. He noted that he does not foresee the funding delay interfering with the success of the program and stated that “seed” money is able to be put towards the program in the meantime while an amended contract is being created. Mr. Pendleton stressed the importance of setting expectations that can realistically be met and monitoring the program’s successes, pointing out that the mid-year budget adjustment is coming up and stakeholders want to see tangible results.

## 9. Discussion – Update on Streetlight Repairs and Survey Fieldwork

Ms. Frankic reported that last month she conducted streetlight fieldwork with Ms. Dietz and Livability Committee Vice-Chair Erin Holmes which focused on the crime hotspots as determined by the NOPD. Of the 90 streetlights surveyed, Ms. Frankic stated that 1/3<sup>rd</sup> of the lights were not functioning. She noted that the results from the survey have been sent to the Department of Public Works (DPW) and added that the DPW is currently working on a Request for Proposal (RFP) for the \$150,000 budgeted for streetlight maintenance in the FQEDD budget. Ms. Frankic stated that the primary focus for the streetlight maintenance will be the lights located in the crime hotspots, as well as the low-budget repairs.

## 10. Discussion – Update on Real Time Crime Center Crime Camera Installations

Ms. Frankic reported that two crime cameras were installed last month, with a total of 83 being fully functional out of the 104 total. She stated that there are still some wiring issues that need to be worked out for the remaining cameras. Ms. Frankic noted that the NOPD has mentioned on multiple occasions how valuable the video downloads from the Real Time Crime Center (RTCC) have been during investigations. Sgt. Boudreau reported that the License Plate Readers (LPRs) have also been valuable and effective for the Eighth District. Jane Cooper stated that it was reassuring to hear the positive feedback regarding the LPRs and cameras. Mr. Pendleton agreed and noted that it is important that the FQMD touts the successes of these force multipliers.

## 11. Presentation – Presentation of Updates on City Safety Coordination Efforts by City Chief Administrative Office. To Present: Eric Smith & Alex Dunkenberger

### a. French Quarter Patrol App Contract Status with SDT Productions

Eric Smith reported that SDT Productions is working with Legal on the contract now. He noted that the original proposal was well above the budget, so some negotiations were necessary. Mr. Smith stated that he expects the framework of the CEA to be created by the end of this week. Ms. Cooper asked if Mr. Smith could provide a list of the app upgrades included in the contract. Mr. Smith replied that app compatibility is a major upgrade in the contract, with new and compatible versions being released on the app store for IOS and Android devices. He stated that additionally, the City will have direct access to all databases and data contained therein, and a real-time public dashboard will be created.

### b. FQEDD Code Enforcement Inspector Updates

Mr. Smith reported that Shaune Gilbert has been out on the streets conducting French Quarter walkthroughs. He noted that the majority of Code Enforcement cases during February revolved around graffiti on private property. Mr. Pendleton asked if Code Enforcement is able to do anything regarding the conditions of the sidewalks in the neighborhood. Mr. Smith answered no, stating that the sidewalks fall under State Constitutional laws. He added that the only options for addressing this issue would be to either write an amendment to the State Constitution that would allow the City to be able to enforce its’ existing laws dealing with public right of ways, or have the City directly fund every sidewalk repair, which would cost over \$1M in capital funding. He reminded the Committee that the primary issues that the Code Enforcement Inspector deals with revolve around property issues like siding, paint, and keeping properties up to building codes.

## 12. New Business– To consider and take action upon any other matters that may properly come before the French Quarter Management District Security and Enforcement Committee

Ms. Dietz proposed that funds be allocated towards deep cleaning the interior of the French Quarter Patrol vehicles. The Committee all agreed, and Ms. Cooper stated that no motion will be necessary because the funding has already been put

aside in the budget for maintenance. Mr. Smith will speak with Cpt. Roberts and Sgt. Boudreau after the meeting about the details to move this forward.

Ms. Dietz asked if the mobile light towers are ready to be deployed. Sgt. Boudreau answered that the three light towers are in the garage at the substation now but will need to be branded specifically as French Quarter towers. Ms. Frankic asked if the previously printed decals can be used on the towers. Mr. Smith answered yes and suggested getting more printed. Mr. Smith will order the decals this week.

Ms. Frankic asked Mr. Smith if there was an update on the barricade sleeves. Mr. Smith stated that the sleeves were ordered two weeks ago, and now he is waiting for them to be completed and delivered. He added that he does not expect to see delays with this process.

# Summary of Month Activities

---

2/5/24

At approximately 6 PM, while conducting patrols in the 100 block of Royal Street, Lt. Ernest Newman observed a disturbance in front of Unique Grocery Store at 127 Royal Street where individuals were fighting. Lt. Newman immediately intervened and separated the individuals involved. Both participants, who were neither injured or desired to press charges, were advised to leave the area and not return. Moments later, one of the participants of the altercation, later identified as Tyrone Jenkins, DOB 9/21/1980, returned to the scene and provoked another fight unrelated to the initial incident. At this point, Lt. Newman, while attempting to diffuse the disturbance, was physically pushed by the aggressor, Tyrone Jenkins. Lt. Newman then physically took Jenkins to the ground without injury or further incident. Jenkins was handcuffed and placed under arrest for the following offenses: disturbing the peace, public intoxication and resisting arrest. Lt. Newman transported the arrested subject to intake and processing where he was booked accordingly.

UQP personnel have encountered an alarming number of medical incidents in the 100 block of Royal Street. These occurrences were all related to injuries sustained in falls caused by large holes and cracks in the sidewalks, including an exposed water meter with no cover. Alcohol was not a factor in these mishaps.

Operationally, 2 members of the UQP detail were discharged for failure to comply with rules and regulations. Additionally, 3 weekly evening positions from 4pm-10pm have been onboarded.

These individuals have previously not only been connected to/approved for housing assistance from a program like Unity or HANO but had also moved into that housing after a period of homelessness and have since returned to homelessness again. This number does not include individuals who maintain their housing but choose to spend time outside for social/personal reasons and/or who are temporarily sleeping outside because they have lost access to their housing for now (e.g., due to misplaced keys or water shutoff).

**Total # of Encountered Individuals Who were Connected to Housing Programs (have vouchers issued to them) but not housed by end of month** **3**  
These individuals have (or had at any point in the month) a housing voucher issued to them but did not move into housing by the end of the month. This can be because their housing program is still looking for an available unit for them that is within the voucher price or because they are not in sufficient contact with their housing program to be able to view and select from available units. Because 7 encountered individuals were housed prior to or during this month, this means 3 of the 51 encountered individuals who were still homeless by February 29th (5.8%) are connected to housing vouchers (which could pay their rent) but are not connected to actual available housing where they can use their vouchers.

**Outreach Successes:**

This month, a client who has been homeless on and off since at least 2016 (as evidenced by records in the state system) was able to move into housing on the last day of the month. She is extremely medically vulnerable, being one of the highest-scoring individuals on the universal vulnerability assessment that all individuals applying to housing in New Orleans must complete as part of their housing application, and she is almost 70 years old. Her medical vulnerabilities have caused her to be hospitalized multiple times, and having to stay with her dog, whom she feels helps protect her at night on the streets, has made it difficult for her to attend appointments, as some service providers and clinics don't allow dogs to come inside. Despite these challenges, our outreach team has been working with her for just about a year to collect proof of her homelessness, to repeatedly connect her with treatment providers, and to complete the many steps involved in the local housing application. This month, she was finally matched to a housing voucher and our team introduced her to her new housing case manager and brought her to see an apartment with them. She was housed the next week after her voucher match, and is elated to finally be home indoors with her dog and begin recovering from her many years on the street.

**Outreach Challenges**

There have been some continued challenges in connecting clients to long-term support agencies. Throughout much of the latter half of 2023, we struggled to get clients matched to housing vouchers largely because the largest Permanent Supportive Housing (PSH) program, coordinated through the Louisiana Department of Health and offering services funded through Medicaid, took a pause on accepting new referrals for almost six months of the year. Now that we are having clients matched to housing programs again – with five clients

being newly matched to housing programs in the first two months of this year – we are sometimes instead encountering a lack of communication and/ collaboration with other agencies for warm hand-off. Once any unhoused client is approved for PSH, they are transferred to a housing case manager for long- term support – however, sometimes, clients either have little to no contact or support from their new PSH case manager, and thus rely heavily on their original outreach case manager to continue to meet their needs, even after they are housed, which places a significant strain on outreach case management time and capacity.

Rapid Rehousing Report -----

**Number of individuals targeted for rapid rehousing assessment (RRH) **20****

These individuals all have been homeless in the French Quarter for more than six months and all struggle with significant vulnerabilities that have made connecting them to traditional PSH programs difficult. However, until the RRH program is “live” and able to move individuals in, efforts will continue to facilitate the entry of these individuals into other housing programs as well

**Number of targeted/assessed individuals matched to other housing vouchers as of 02/29/2024 **2****

Due to continued problem-solving and focused, intensive case management, the FQ outreach team was able to have 2 of 20 individuals we originally targeted for RRH assessment matched to other housing vouchers in February.

These individuals have been informed of the upcoming opportunity that may be possible to be quickly connected to housing via the FQ RRH program. They have indicated their interest and are working on completing initial paperwork with our team in advance of receipt of funding.
