Summary of Month Activities

3/13/24

At about 10 AM, UQP deputies Madrigal and Patton, while on routine patrol in the 800 block of Canal Street, were alerted to a shoplifting in progress. Upon entering the store, Deputies were directed to a white male later identified as Lewis Moore, DOB 5/27/1986. It was then learned from store personnel that Moore, a known shoplifter, took merchandise totaling \$47.15. Upon attempting to flee the store with the stolen property, UQP deputies simultaneously entered the store on a routine business check. While attempting to place the perpetrator under arrest, Lewis resisted by fleeing. Deputies were able to immediately restrain and take Lewis into custody without further incident. Arrested subject Lewis was charged with theft and resisting arrest by flight. NOPD officer RD Gaines assisted with transporting the arrested subject to central lockup, where he was booked accordingly.

3/14/24

At about 7:40 PM, UQP Deputies, while conducting routine foot patrol in the 100 block of Royal Street, encountered a disturbance at 127 Royal Street, Unique grocery. At this time, Deputies observed a male subject screaming obscenities at the store employee. Deputies further learned that store management requested that the disruptive subject leave the premises but refused to comply. Deputies then intervened and requested that the individual leave the immediate area. Despite multiple requests, the irate male subject refused and continued screaming profanities. Deputies then placed the subject, identified as Devon Jackson, B/M, 9/9/2005, under arrest for trespassing. A search incidental to arrest revealed Jackson to be in possession of a large clear plastic bag containing green vegetable matter consistent with marijuana. The arrested subject was additionally charged with possession of marijuana. UQP personnel transported Jackson to the intake and processing center where he was booked accordingly.

Summary of Month Activities

Expanded Upper Quarter Patrol

3/24/24

At approximately 1:30 AM, EUQP deputies responded to a large crowd outside of 239 Decatur, Carre' Bar. Multiple females in the crowd were observed becoming argumentative and hostile with each other. Sgt. Jamil Champagne, EUQP member, advised Channel 8 dispatch of the circumstances. At this time, UQP detail personnel deployed overhead lights on their marked patrol vehicles, along with broadcasting orders to disperse via the vehicle's PA system. As a result of these actions, the large crowd disbanded. It should be noted that this particular location has become a hotbed for large, unruly gatherings.

3/30/24

EUQP Patrol Sgt. Jamil Champagne, while conducting vehicular patrol in the 100 block of South Peters, observed a gray Ford truck driving recklessly. Sgt. Champagne executed a traffic stop and exited his marked unit to further investigate. Upon contacting the driver, it was determined that the operator was under the influence based on the slurring of words, concentrated aroma of alcohol on his breath and the inability to respond to basic questions. After learning that a DWI unit was unavailable, Champagne arrested the subject for reckless operation, including the issuance of three additional traffic citations. Sgt. Champagne transported the driver to lockup where he was booked accordingly.
