1. Call to Order, Reading of the Agenda, and Roll Call

2. Public Comment:

No written public comment was received.

3. Motion – Consider a motion to approve the previous meeting notes

Maddie Charleston motioned to approve the previous meeting notes. Frances Hegenberger seconded the motion, and it was approved.

4. Committee Chair's Comments

Vice-Chair Jessica Dietz welcomed the Committee and thanked Karley Frankic, Shelby Ursu, Matt Pincus, Cpt. LeJon Roberts, Sgt. John Castelin, and Lt. Chuck Ward for their hard work.

5. Discussion – Additional Parking Space Availability for Patrol Vehicles

Sgt. Castelin reported that acquiring permanent parking on Chartres Street is still a work in progress but noted that additional parking spaces on Conti Street has been made available to the Supplemental Police Patrol Program (SPPP) recently, which has helped to alleviate congestion for residents, workers, and NOPD officers. Ms. Frankic pointed out that a budget line item has been made in the 2025 French Quarter Economic Development District (FQEDD) budget draft specifically for SPPP parking.

6. Discussion – Update Royal Street Barricade Replacements

See attached document. Bob Bejarano, the FQMD Program Manager, reported that the contract has been awarded to Irish Channel Ironworks. He added that the vendor is now being paid for their services, and preliminary ironwork has begun. Mr. Bejarano noted that the ironwork is estimated to take four to six weeks for completion.

7. Presentation – Presentation of Eighth District Crime Statistics and the Supplemental Police Patrol Program. (Green Sheet) To Present: Sgt. John Castelin

See attached report. Sgt. Castelin reported that the percentage of shifts filled, and shifts worked has increased since last month, with 91% of shifts filled and 84% of shifts worked. Cpt. Roberts added that the Eighth District continues to have the lowest response time in the city and attributes this to the SPPP successfully working with the Eighth District.

a. New Patrol Vehicle Wrapping and Light Installation Status

Sgt. Castelin reported that the vendor for vehicle wrapping has officially been paid by the City. He stated that all of the Chevy Bolts are wrapped and are now waiting for their light installation. Sgt. Castelin noted that the Bolts are far back in the queue for lighting installation, so he is working on a possible alternative vendor. He added that he estimates that the Bolts will be in service by the end of the year.

b. Vehicle Cleaning & Maintenance

Ms. Dietz stated that she is working with a contractor to iron out the details for providing monthly vehicle cleaning and maintenance. She reported that the monthly quote from the vendor would be \$1,150.00 which lands around \$80 a vehicle and totals to \$13,800 annually. Ms. Dietz stated that the scope of work includes weekend onsite interior and exterior cleaning, basic detailing, waxing, and window cleaning. Ms. Dietz will forward the quote to Eric Smith today.

8. Discussion – Discussion by Committee of Firearm Free Signage for Businesses and Emergency Call Dispatch Procedure

See attached document. Ms. Dietz reviewed the signage with the Committee, noting that this has been provided to interested businesses in the French Quarter. She reported that Dr. Avegno of the New Orleans Health Department is working to get this signage available city-wide.

Sgt. Castelin stated that the SPPP will handle the emergency calls related to firearms in the district as they do for any 911 emergency calls, noting that the officers will respond accordingly. Jane Cooper asked if the plan to purchase gun-free zone signage that the Committee discussed earlier this year has moved forward. Cpt. Roberts replied that the logistics are still being worked out regarding this plan. He noted that once the Eighth District gets the final greenlight from the Attorney General and the NOPD Superintendent regarding enforcing the Eighth District as a vo-tech school, the plan will be able to move forward. Ms. Dietz added that anyone interested in tracking status updates of occupancy permits is able to look on nola.gov for more information.

9. Presentation – Presentation of Upper Quarter Patrol (Purple Sheet) To Present: Matthew Pincus

See attached report. Mr. Pincus reviewed the monthly report with the Committee.

10. Discussion – Discussion by Committee of Increased Police Presence on Bourbon Street

a. Upper Quarter Patrol

Mr. Pincus stated that, due to a recent plea by merchants for additional law enforcement presence on Bourbon Street, a successful pairing of the Orleans Parish Sheriff's Office Deputies with NOPD Bourbon Street Promenade officers has begun occurring on Fridays and Saturdays from 7 PM to 3 AM, noting that after four weeks, this endeavor has provided a positive

impact on officer safety and has added manpower for more effective policing. Mr. Pincus added that there are no stats yet for these new shifts but stated that the Committee should expect to see them next month. Ms. Dietz thanked Mr. Pincus and stated that the Upper Quarter Patrol's (UQP) partnership and collaboration with the Eighth District has been strengthening each week. Cpt. Roberts agreed and added that the UQP has been instrumental in aiding the NOPD.

b. Louisiana State Police Troop NOLA

Ms. Frankic informed the Committee that Commander Hyatt of the Louisiana State Police (LSP) Troop NOLA is working on a proposal to add additional LSP coverage on Bourbon Street. She added that this proposal is not ready to present at this point in time, but the details are being ironed out.

c. Overtime Mounted Unit

Sgt. Castelin reported that on Thursdays, Fridays, Saturdays, and Sundays the SPPP has been performing mini Bourbon Street sweeps along with the NOPD Mounted Division, the Bourbon Street Promenade, the UQP, and the Louisiana Office of Alcohol and Tobacco Control (ATC). Sgt. Castelin stated that there has been a significant decrease in illegal vendors and noted that these sweeps are performed twice a week, twice a day. He added that the moral between the officers has been great, as well as the feedback from residents and businesses. Cpt. Roberts stated that in addition to these Bourbon Street sweeps, the Eighth District is also performing ongoing quality-of-life sweeps with the ATC, the Taxicab Bureau, Parking Enforcement, Troop NOLA, the Orleans Parish Criminal Sheriff's Office, and law enforcement partners. He noted that the LSP have been doing an outstanding job of helping the Eighth District with violent crimes and informed the Committee that violent crimes are down in the district by 12%. Alex Fein asked if statistics from the illegal vending and quality-of-life sweeps will be shared. Cpt. Roberts answered yes.

Ms. Dietz reported that the LSP, the UQP, and the Overtime Mounted Unit plan to move forward with an increase in police presence on Bourbon Street. Lt. Ward stated that the Overtime Mounted Unit would like to supplement the SPPP with two additional Mounted Unit officers deployed during peak hours on the weekends to assist with the sweeps and quality-of-life issues. Ms. Frankic clarified that these two officers would be in addition to the two officers required on Bourbon Street according to the Cooperative Endeavor Agreement. Sgt. Castelin stated that he already has mounted officers that are signed up for the program and noted that he expects this to be seamless to implement.

11. Presentation – Presentation of Travelers Aid Society of Greater New Orleans. (Orange Sheet) To Present: Karley D. Frankic

See attached report. Ms. Frankic encouraged the Committee members to read the latest TASGNO report. She stated that the FQEDD flex fund for the Rapid Rehousing Program was received on Friday, July 26th. She added that nine individuals have been identified for the program so far and are matched with housing vouchers. Ms. Frankic stated that the housing process can vary depending on each individual, noting that the process can be longer if an individual has a disability, a criminal history, or owns a dog.

Ms. Cooper noted that only one individual has been placed in permanent housing through TASGNO, year to date, and stated that the FQMD must continue to monitor TASGNO's progress and use of funds.

12. Presentation – Presentation of Updates on City Safety Coordination Efforts by City Chief Administrative Office. To Present: Eric Smith & Alex Dunkenberger

a. French Quarter Patrol App Contract Status with SDT Productions

Mr. Smith reported that the negotiations have been made and the contract is ready to be executed. He noted that he expects to receive the contract from the vendor today and anticipates getting the contract to the Mayor's office by this Thursday.

b. FQEDD Code Enforcement Inspector Updates

Mr. Smith reviewed the Code Enforcement updates with the Committee. He noted that the majority of violations were due to graffiti.

13. New Business– To consider and take action upon any other matters that may properly come before the French Quarter Management District Security and Enforcement Committee

Ms. Dietz reported that she has been working with FQMD Commissioner Sue Klein and Sgt. Castelin on a proposal to add evening shifts for the Community Liaison Officers (CLOs) within the SPPP, noting that these CLOs would be focusing on quality-of-life issues such as excessive noise, illegal vending, and illegal parking on street corners, sidewalks, or in front of fire hydrants. She stated that the existing CLOs currently work primarily during the day, but this proposal would be a way to add additional coverage in the evenings that would put more eyes on the residential community and their concerns. Sgt. Castelin added that these CLOs would be responsible for areas in the French Quarter that need more coverage during the nighttime, noting that North Rampart and Toulouse Street as well as lower Decatur Street have been areas that were brought to his immediate attention for this proposal, but informed the Committee that the CLOs will be focused on the entire French Quarter. He stated that the funding is lined up and there are already a few interested officers who were former quality-of-life officers in other districts. Sgt. Castelin noted that he ran a successful pilot to test the program out which resulted in a number of summonses being written, the arrest of an illegal vendor who refused to cooperate, and a vehicle being towed. Ms. Frankic stated that this proposal will be moving forward to the Board of Commissioners at the September 9th meeting.

Ms. Cooper thanked Ms. Dietz and Sgt. Castelin for putting this proposal together. She reported that funding is being allocated to an overnight SPPP shift which will be for a POST-certified officer instead of a volunteer civilian. Sgt. Castelin noted that he has an officer in line for this position.

Ms. Cooper reminded the Committee that the 2025 FQEDD budget is moving forward to the Finance and Development Committee and then to the Board for final approval on September 9th and asked that if any Committee member has further comments or questions about the budget to discuss them today. The Committee made no revisions or further recommendations to the budget draft and were in agreement with moving it forward.

14. Next Meeting Date:

The next scheduled meeting of the Committee is Monday, September 23rd, 2024, at 11:00 am.

15. Adjournment

Ms. Hegenberger made a motion to adjourn. Ms. Charleston seconded the motion, and the meeting was adjourned at 11:58 AM.

Summary of Month Activities

6/9/2024

On Sunday, June 9th, 2024, at about 10:15 AM, UQP deputies received a broadcast of a subject wanted for a simple robbery reported to be at 717 Canal Street. Upon arrival, it was quickly learned by responding deputies that the suspect, a white male attired in black shorts and a white t-shirt named Anthony, was located in the rear loading dock of the building. Deputies decided to approach from Iberville Street via the Acme Oyster loading dock to prevent the suspect from having a route of escape. Deputies observed the subject, at which time, approached and successfully took the suspect into custody without incident. A subsequent search revealed the male to be in possession of a white powder substance consistent with cocaine. The arrested subject was then handed over to NOPD officers, at which time a name check was conducted of the arrested subject. It was then additionally learned that Anthony had an active warrant for simple robbery. NOPD transported the subject to central lockup for booking.

6/14/2024

On Friday, June 14th, 2024, at about 8:45 AM, UQP Deputy Madrigal, while on routine foot patrol, received a broadcast via NOPD frequency 8 of a 103M (mental) causing a disturbance at 730 St. Louis Street. Upon arrival, the perpetrator was observed throwing objects at the business resulting in all the front door glass being broken. Dep. Summary of Month Activities

7/1/2024

On June 22, 2024, and June 23, 2024, an individual identified as Nelson Washington (DOB: 01/28/1960), was observed on surveillance footage stealing merchandise from Italy Direct located at 213 Royal Street. Washington was observed by a store representative stealing several items of clothing totaling \$524.99. On July 1, 2024, at approximately 3:20 PM, Nelson Washington was recognized and intercepted at the corner of Royal Street and Bienville Street by UQP Deputy Loy Madrigal. Expanded Upper Quarter Patrol

7/6/2024

At approximately 2:45 AM, EUQP patrol members Sgt. Tyrone Jones and Alex Berthelot responded to a radio broadcast via NOPD communications in reference to a group of five teenagers harassing homeless individuals at St. Louis Street and the riverfront. It was also reported that the offenders were targeting bystanders with a BB gun. The EUQP arrived on scene with NOPD, at which time, began canvassing the immediate area for the perpetrators. Moments later, NOPD and EUQP units observed and approached 5 individuals in the parking lot located at 200 N. Peters Street. The subjects, which matched the description of the perpetrators, were detained and transported to the 8th District Station. After further investigation, it was determined that all five individuals were participants in an armed robbery that occurred earlier that evening on St. Peter Street at the river. As a result of the arrest, one gun was seized. The arrested subjects were later transported to lockup where they were booked accordingly.

- To recap the last 3 months of activity, the EUQP has been responsible for handling over 700 calls for service, 509 assists to the NOPD, 119 traffic violations issued, 17 municipal arrests, 12 state arrests and 4 juvenile arrests.
- Lastly, due to a recent plea by merchants for additional law enforcement presence on Bourbon Street, a successful pairing of OPSO Deputies with NOPD Bourbon Promenade officers has occurred on Friday and Saturday from 7 PM to 3 AM. After four weeks, this endeavor has provided a noticeable increase in law enforcement presence, as well as a positive impact on officer safety. The added manpower has also made proactive policing and enforcement more effective.

Outreach Success Stories

The client was diagnosed with cataracts a year ago and at the time the prospects of surgery seemed out of reach; the doctors could not perform the surgery as the client was unhoused and living in a place not meant for human habitation. After one year of connecting and working with case workers, the client was finally housed and got cataract surgery completed.

Outreach Challenges

Proving nine months of homelessness as a qualification for housing poses significant challenges to individuals navigating the complex bureaucracy of social services, primary for the individuals that cannot access conventional social services. Additionally, securing stable housing is critical for efforts to *end* homelessness, however, the other set of challenges individuals face once housed are exasperated because of limited aftercare / support. Without holistic care, the transition from homelessness to stability becomes temporary and perpetuating cycles of poverty and housing insecurity.

Outreach Success Stories

There were quite a few referrals that finally went through this month after many months of waiting. Unity has been ramping up the number of Public Housing Authority (PHA) vouchers (as opposed to Continuum of Care vouchers, which is the vast majority of vouchers that Unity issues). These PHA vouchers are new to the system and typically require more documentation, which is a challenge to collect, but our team has been working closely with other community partners to both obtain the needed documentation as well as advocating for fewer restrictions.

Outreach Challenges

SNAP/EBT continues to be problematic across all clients, whether it is the initial interview, replacement cards, unexplained cancellations, or other parts of the process. TAS staff continues to record and report these issues as they arise.
