2. Public Comment:

November 25, 2025

TO: Ms. Michelle Courseault, FQMD Executive Director via <u>publiccomments@fqmd.org</u> RE: Gator Purchase Request

I am a French Quarter resident, FQMD Commissioner, and I am not being paid in connection with my comments and requests regarding this request for a Gator purchase for the newly approved CLO positions.

In years past, the NOPD 8th District had assigned what was designated Quality of Life (QOL) officers available to respond to residents and businesses when QOL occurrences were negatively affecting them. This included harassing behavior, excessive noise, blocked driveways, et cetera. I found these officers to be very responsive, because they dealt exclusively with QOL and not put into the 8th Districts general daily staffing pool.

Since the former QOL officers are now designated by the City and NOPD as Community Liaison Officers (CLO), FQMD recently approved CLO positions to address these concerns. NOPD would prefer these officers to utilize Gator's as their vehicle of choice.

Therefore, I'm requesting that FQMD budget for 2 more Gators to fulfill this request. The CLO budget line item (\$175,000.00 - \$151,000.00 needed for staffing and supplies) recently approved should come close to paying for one of these vehicles.

3. Motion - Consider a motion to approve the previous meeting notes

Glade Bilby made a motion to approve the previous meeting notes. Frances Hegenberger seconded the motion, and it was approved.

4. Committee Chair's Comments

Vice-Chair Jessica Dietz welcomed the Committee and guests and thanked them for their attendance. She stated that with the recent mass shooting she would like to extend gratitude on behalf of the Committee to Cpt. LeJon Roberts, Sgt. John Castelin, and Matt Pincus of the Upper Quarter Patrol (UQP) and noted the importance of remaining steadfast in commitments to public safety. Ms. Dietz reported that, thanks to the advanced technology of the License Plate Readers (LPRs) and Project Nola cameras, in less than one hour the vehicle was located and one of the perpetrators was apprehended. She added that the LPRs and Project Nola cameras have been essential and have assisted in reducing the violent crimes in the district by 20% this year, with an 82% solve rate on homicide- one of the lowest in the nation.

Jane Cooper noted that she and Michelle Courseault met with Governor Landry and had a discussion of finding ways to keep Troop NOLA and the Louisiana State Police (LSP) permanently in the City and the French Quarter. She noted that this would cost an estimated \$10M, which Governor Landry is working to find multiple funding sources for. Ms. Cooper stated that a formal proposal from the LSP is currently in progress, adding that the 2024-2025 State appropriation budget could help to fund this proposal.

5. Discussion – Discussion by Committee of the 2025 Committee Work Plan

See attached document. Ms. Dietz asked the Committee to fully review the 2024 Committee Work Plan in their packets and submit any comments, suggestions, or revisions for the 2025 Committee Work Plan to her before the next Committee meeting. She added that the document will need to be reviewed in more detail at the December 16th meeting, and fully approved by the FQMD Board in January.

6. Discussion – Discussion by Committee of a Proposal for Procuring for John Deere Gators for the Supplemental Police Patrol and the Upper Quarter Patrol

Ms. Dietz stated that though this proposal has support, the FQMD Commissioners raised concerns at the previous Board meeting regarding the liabilities involved with the purchasing of more Gators. She added that an Act of Donation to the City may be the easiest way to accomplish this goal for the Supplemental Police Patrol Program (SPPP), which would leave no strings attached to the FQMD, but noted that because the UQP is a private entity, this may further complicate the process. Ms. Cooper agreed and reminded the Committee that the SPPP is funded through the French Quarter Economic Development District budget, but the UQP cannot be funded through this budget. She stated that finding the answers regarding an Act of Donation versus leasing the vehicles will be necessary, pointing out that the Board will want these crucial details. <u>Ms. Dietz stated that some research will need to be done, adding that she will look into the previous process that was utilized when the SPPP vehicles were purchased in the past.</u>

7. Discussion – Discussion by Committee of Public Relations for the FQMD To Present: Michelle Courseault

Ms. Courseault reported that she has been working with the FQMD's Public Relations firm, Ellie Rand Public Relations (ERPR), to find ways to elevate public awareness of the FQMD and its' successful public safety and quality of life programs. She noted that she would like to work with the Committee and ERPR to create a boilerplate format of public safety statistics from the SPPP and UQP that can be sent out to residents and stakeholders. She asked the Committee to brainstorm what they would like to communicate to the public and how they would like the communicate this information, noting that ERPR can create the

format, whether it be online on the FQMD's website or a monthly newsletter, and the Committee can then review and approve this format. Ms. Cooper suggested that the Committee steer clear of making statements about violent crimes in the French Quarter, and to leave this to the NOPD. Sgt. Castelin agreed, but noted that he can share general information with Ms. Courseault that can be released. Ms. Courseault stated that the goal is to highlight the good things that are being accomplished. Joshua Grippo voiced his support of the idea, suggesting a scheduled periodic release. <u>The Committee agreed</u> to add this to the 2025 Committee Work Plan.

8. Discussion – Discussion by Committee of Project Nola Security Cameras

Ms. Dietz stated that conversations continue regarding how the Committee can find ways to put funds towards the Project Nola security cameras and spread these cameras throughout the French Quarter. She encouraged the Committee to continue to spread the word to residents and businesses about the benefits these cameras provide to the overall public safety of the district. Ms. Dietz added that she will ask Cpt. Roberts for the list of identified locations that are crime hotspots which would be prioritized for camera installations. She stated that details for this program will need to be fully mapped out in the Committee. Ms. Cooper agreed and stated that a one-pager should be made with the program costs, as well as the options for residents versus the options for businesses. The Committee agreed to endorse this project and continue to move it forward. <u>Ms.</u> <u>Courseault will work with Ms. Dietz on creating a one-pager that will detail the program which will be disseminated to the FQMD's Committees, Commissioners, and stakeholder organizations.</u>

9. Discussion – Update Royal Street Barricade Replacements

Ms. Courseault stated that she is working with Bob Bejarano, the FQMD Program Manager, Cpt. Roberts, and Ross Bourgeois of Homeland Security, to find solutions for the deployment plan for the new Royal Street barricades. She noted that while discussions are still ongoing, Cpt. Roberts and his Eighth District team have offered to continue deploying the barricades in the meantime until a solution is reached.

10. Discussion – Update on 2024 Streetlight Repairs Project

Ms. Courseault reported that The Tobler Company will be providing monthly reports starting next week with updates on the 2024 Streetlight Repairs Project. She added that there will be two phases of the project, with the first phase beginning from Canal Street to St. Ann Street and the second phase being St. Ann to Esplanade Avenue. Ms. Courseault reported that a team will be out in the French Quarter inspecting every pole, and a second team will be simultaneously performing the repairs.

11. Presentation – Presentation of Eighth District Crime Statistics and the Supplemental Police Patrol Program. (Green Sheet) To Present: Sgt. John Castelin

See attached document. Sgt. Castelin reported that the average response time for the month of October was 1.5 minutes, while the average app call response time was 7 minutes. He noted that reckless driving and unauthorized vehicles were an area of focus for the SPPP in October. Sgt. Castelin stated that 97% of shifts were filled for the month.

a. New Patrol Vehicle Wrapping and Light Installation Status

Sgt. Castelin reported that the vehicles are wrapped and just need to be wired. He noted that there was an issue with the previous light installation vendor, and a new company has been selected, with one vehicle currently getting serviced. Sgt. Castelin stated that the vehicles should be ready by the end of the year.

12. Presentation – Presentation of Upper Quarter Patrol (Purple Sheet) To Present: Matthew Pincus

See attached report. Mr. Pincus reviewed the monthly report with the Committee. He noted that the UQP continues to forge forward with assisting and supplementing the NOPD's Bourbon Promenade. Mr. Pincus reported that a senior full post Orleans Parish Sherriff's Office Deputy has begun working every Wednesday, Thursday, and Saturday. Sgt. Castelin thanked Mr. Pincus and the UQP, noting that they are a force multiplier that has greatly helped the SPPP.

13. Discussion – Updates of Municipal Court Follow-up



Ms. Dietz noted that she has joined Committee members Maddie Charleston and Mr. G. Bilby to accompany Sgt. Filibert to court to monitor the status of traffic citations and nuisance crime cases in order to ensure that those individuals receive the highest fines. She added that she will continue to monitor the cases and keep the Committee updated.

 - a. French Quarter Patrol App Contract Status with SDT Productions

Ms. Courseault noted that the FQMD website has been updated to reflect the email address that residents can utilize if they experience any tech issues with the SDT app.

Summary of Month Activities

<u>10/1/2024</u>

On October 1, 2024, at approximately 12:15 PM, Deputy Loy Madrigal of the Orleans Parish Sheriff's Office was flagged down by multiple individuals on the 600 block of Bourbon Street. Complainants reported that a Mr. Gregory Thompson Morrow Jr. parked his vehicle, a blue car with a Florida license plate, in the middle of the street, obstructing the flow of traffic. Witnesses observed him leaving the vehicle and walking towards the 400 block of Bourbon Street. Upon questioning, Mr. Morrow denied operating the vehicle despite multiple witnesses verifying his involvement. He initially hesitated to provide identification but ultimately presented his Florida driver's license and an additional ID belonging to a female. Deputy Madrigal instructed Mr. Morrow to move the vehicle to alleviate the traffic obstruction. While Deputy Madrigal was clearing the traffic, Mr. Morrow fled the scene, leaving the area in his vehicle. Witnesses informed the Deputy that he had made a left turn onto St. Peter Street. A thorough search of the area was conducted, but the subject and the vehicle could not be located. Mr. Morrow's actions constitute violations of RS 32:141 (Obstruction of Traffic) and RS 108.1 (Resisting an Officer by Flight). Given the subject's actions, a request to the Court for an arrest warrant has been submitted to ensure Mr. Morrow is held accountable for these violations.

10/6/2024

On Sunday, October 6th, 2024, at approximately 1:22 PM, Deputy Madrigal, while on foot patrol at the 100 block of Royal Street, was flagged down by Chakeva Brown, an employee of the Walgreens store located at 134 Royal Street. Ms. Brown reported that an older male entered the store and caused a disturbance by cursing at her before leaving on foot in an unknown direction. Later that same day, at approximately 4:30 PM, Deputy Brittney Lackings and Deputy Madrigal were flagged down by a passersby in the 700 block of Iberville Street, who reported a black male defecating in public. Upon arriving at the scene, the deputies located the subject, later identified as Kenneth Royal (DOB 11/11/1962). Upon further investigation, Mr. Royal admitted that he had been trying to find a restroom. He had gone to Walgreens at 134 Royal Street earlier but was informed that no bathroom was available, which upset him and led to the disturbance reported by Ms. Brown. After being unable to find a restroom, Mr. Royal proceeded to defecate in public, resulting in the lewd conduct. Based on the information provided and observations made, Mr. Royal was issued a summons for violation of City of New Orleans Municipal Code Section 54.254 (Lewd Conduct) and Section 54.403 (Disturbing the Peace). He is scheduled to appear in court on November 11, 2024, at 9:00 AM at the Municipal Traffic Court located at 1601 Perdido Street.

10/10/2024

On October 10th, 2024, at approximately 5:05 PM, Deputy Madrigal and Detective Alex Berthelot were conducting routine patrol in the 300 block of Bourbon Street, when they identified the subject, Lewis Moore, (DOB 5/26/1986), who was known to be wanted for the following charges: LRS 14:34.2 Battery of a Police Officer, LRS 14:108 Resisting Arrest by Flight, and LRS 14:103 Disturbing the Peace. Upon identifying the subject, Deputy Madrigal and Detective Berthelot approached Mr. Moore. The subject was informed of the active warrants for his arrest and was placed under arrest without incident. Dispatch was immediately notified of the arrest. The subject was subsequently escorted on foot to the 8th District station for further processing. Following the completion of paperwork and processing, Lewis Moore was transported to Orleans Justice Center for the booking process. No further incidents occurred during the arrest or transportation of the subject.

Summary of Month Activities

10/20/2024

On Sunday, October 20, 2024, at approximately 4:30 PM, Deputy Madrigal, while on foot patrol in the 200 block of Royal Street, observed a known subject, Rene Collins, (DOB 05/06/1985), entering the Walgreens located at 134 Royal Street. The subject had been previously warned multiple times by both Deputy Madrigal and store employees that he was no longer permitted to enter the business due to habitual offenses involving theft of merchandise. As Deputy Madrigal approached the Walgreens, he observed Mr. Collins exiting the store carrying two bottles of drinks and one bag of chips. The total value of the items was \$7.53. Walgreens employees, identified as Ayniah Taylor and Ashlyn Collins, also witnessed the theft and immediately recognized Mr. Collins as a habitual offender. Deputy Madrigal detained Mr. Collins and escorted him to the 8th District station, where he was processed. Mr. Collins was issued a municipal summons for the following violations: 17271 MCS 54.186 Theft of goods valued at \$7.53, 17271 MCS 54.188 Possession of stolen items, and 17271 MCS 54.153 Criminal Trespass. Mr. Collins was advised to appear in Municipal Traffic Court at 1601 Perdido Street on November 11, 2024, at 9:00 AM.

<u>10/23/2024</u>

On Wednesday, October 23, 2024, Deputy Madrigal received information from NOPD Officer Mark Boyle regarding a suspect wanted for a business burglary that occurred earlier the same day at 831 Chartres Street. The suspect was described as a white male wearing a hospital gown with a Tweety Bird T-shirt, carrying a multi-colored backpack, and having identifiable tattoos on his right arm. At approximately 12:50 PM, while patrolling on Dumaine Street near Louis Armstrong Park, Deputy Madrigal observed a male fitting the suspect's description. The subject was now wearing a green T-shirt, blue pants, green shoes, and a white baseball cap. The subject was sitting on a trailer, and shortly after, he got on a bicycle with two other individuals, heading towards North Claiborne Avenue. Deputy Madrigal followed the subject and confirmed the presence of tattoos on the suspect's right arm, matching the description provided. Deputy Madrigal notified dispatch and requested backup to assist in the apprehension of the suspect. He continued to monitor the suspect until they reached the corner of Claiborne Avenue and Dumaine Street, where an NOPD unit arrived and apprehended the suspect without incident. The suspect was turned over to 8th District detectives for further questioning in connection with the business burglary.

Expanded Upper Quarter Patrol

10/24/2024

On Thursday, October 24, 2024, at approximately 7:00 PM, OPSO deputies were present at the 8th District station for a requested roll call attendance by the NOPD Promenade rank. 8th District officers along with OPSO deputies were alerted to high volumes of drug trafficking in the 700 block of Bourbon Street as a result of ongoing surveillance conducted in the area. The surveillance also provided photographic images of wanted subjects engaged in the illicit activity. At about 8:00 PM, groups of NOPD and OPSO officers converged and took two offenders into custody along with the vehicles that they were in possession of. Subsequently to arrest, a search of the vehicle uncovered drug paraphernalia along with a firearm. The two arrested subjects were taken to central lockup by OPSO deputies and stripped search. At this time, contraband in the form of cocaine and fentanyl were discovered. The arrested subjects were then additionally charged for the concealed narcotics.

10/26/2024

On Saturday, October 26th, 2024, OPSO Detectives Bryant Parish and Conner Berthelot were conducting proactive patrols in the 300 block of Chartres Street. At this time, a radio broadcast of a foot pursuit involving three African-American juveniles armed with a firearm was in progress on St. Louis Street proceeding towards N. Rampart Street. The detectives responded to the incident and arrived at North Rampart and St. Louis within seconds. Upon arrival at the location, the deputies assisted NOPD in apprehending the suspects within the immediate vicinity without incident.

Bourbon Promenade

10/22/2024

On Tuesday, October 22, 2024, at approximately 8:15 PM, while on foot patrol in the 300 block of Bourbon Street, Deputy Madrigal and Detective Michael Gil heard a dispatch regarding a disturbance involving a male subject fighting a female in the 500 block of Royal Street. The male subject was identified as Brandon Jackson (DOB 05/25/1994). The female involved was identified as Jennifer Walters. Deputy Madrigal and Detective Gil notified dispatch and proceeded to the 500 block of Royal Street to investigate the reported disturbance. Upon arrival, they were flagged down by several witnesses who had observed the altercation. The witnesses pointed out the suspect, Brandon Jackson, as he was attempting to leave the scene on a bicycle. Deputies commanded the subject to stop, but Jackson refused and fled on foot towards the 600 block of Toulouse Street. Deputy Madrigal and Detective Gil pursued the suspect, who barricaded himself inside the bathroom of the Pig Out business located at 537 Toulouse Street. Deputy Madrigal ordered Jackson to exit the bathroom with his hands visible. The subject complied and was detained without further incident. Mr. Jackson was escorted to the 8th District station for further questioning. Detective Gil interviewed several witnesses from a nearby bar, who stated that although Jackson had been involved in a verbal altercation with the victim, he did not physically strike her. Witnesses confirmed that Jackson had made gestures as if to hit the victim but did not follow through. The witnesses had intervened and called the police. The victim, Ms. Walters, confirmed that Jackson had not physically assaulted her and expressed that she did not wish to pursue charges against him.

Additional Notes:

The UQP continues to forge forward with assisting and supplementing NOPD's Bourbon Promenade. A senior full post OPSO Deputy has been identified and is scheduled to commence working every Wednesday, Thursday, and Saturday. Deputy Charles Morgan, departmentally assigned to the Major Crimes Task Force, brings years of academic and field experience to the UQP Detail.



<u>The Frontier Outreach Program – French</u> <u>Quarter</u> Travelers Aid Society (TAS) in Partnership with FMC/FQEDD

October 2024 Monthly Report

In efforts to improve the life quality of individuals in the French Quarter area with active experiences, or notable histories of homelessness, Travelers Aid Society of Greater New Orleans has developed a program that will support connecting individuals to needed services previously inaccessible.

Progress Report: Efforts and Outcomes

For this program, three (3) case manager will be responsible for providing holistic services to unhoused individuals by offering connections to healthcare, public benefits, identification documents, and documentation support for housing needs.

The role of French Quarter outreach case managers expansion will be to consistently canvass the area on foot, engage with unhoused individuals residing in our designated zone to triage for basic needs and offering "light touch" referrals, service information, and/or case management assistance.
