#### 2. Public Comment:

No written public comment was received.

3. Motion – Consider a motion to approve the previous meeting notes

No action was taken. The motion is deferred until a quorum of Committee members present at the May 19th meeting are present to vote.

4. Committee Chair's Comments

Chair Christian Pendleton welcomed the Committee and guests. He stated that he was in attendance at the June 18<sup>th</sup> City Council meeting, and though he still has unanswered questions regarding the City's plan of action for Bourbon Street, he is eager to see what follow-up will occur. Vice-Chair Jessica Dietz presented Sgt. John Castelin with an honorary plaque symbolizing his achievements with the Supplemental Police Patrol Program (SPPP) and all of his outstanding contributions over the past year since stepping into his role. Ms. Dietz and the Committee expressed their gratitude for the hope that Sgt. Castelin has instilled in them.

#### 5. Presentations -

a. French Quarter Youth Engagement & Outreach To Present: Jessica Strange of the Orleans Parish District Attorney's Office

Jessica Strange, the Community Engagement Liaison with the District Attorney's (DA) Office, introduced herself to the Committee. She stated that the DA's office has been working with the NOPD, community organizations, and various city stakeholders to address quality of life issues. Ms. Strange reported that on Friday, May 23<sup>rd</sup>, the DA's office convened a group of stakeholders, which included Ms. Dietz and FQMD Executive Director Michelle Courseault, to discuss concerns regarding the unattended youth in the French Quarter,

commonly referred to as the "bucket kids." She added that the group discussed the idea of creating an ongoing program with a street outreach team that can directly provide resources and services to these youths. Ms. Dietz hosted a walkthrough with neighborhood stakeholders to highlight these community concerns, with one of the major issues being that these children are commonly seen remaining in the French Quarter as late as 1 AM, seemingly unsupervised. Residents and businesses have expressed the opinion that Bourbon Street is unsafe and can be too hostile an environment for children. Ms. Strange stated that during the meeting the attendees discussed the complex dynamics surrounding this issue, with enforcement being further complicated when parents are actively bringing their children into the French Quarter late at night, and also discussed a potential "no kids out after 8 PM" rule. She stated that six families have been identified as regulars who have continued to bring their unattended children into the French Quarter, and through this program she hopes to reach those families to have discussions about enforcement. The Committee agreed that accountability and enforcement with the parents or guardians will be necessary. Jane Cooper suggested that the FQMD speak with Covenant House to get more details on their Curfew Center to see what resources the FQMD can provide in order to support this new program.

b. Eighth District Crime Statistics and the Supplemental Police Patrol Program\* To Present: Sgt. John Castelin

See attached document. Sgt. Castelin reported that the average response time in May for calls was 1.4 minutes, and 93% of shifts were filled. He noted that there were 227 traffic citations as well as 25 parking citations. Sgt. Castelin reported that the SPPP is participating in the new weekly sweeps of the French Market area, with an 11 AM morning sweep as well as an additional nightly sweep. He stated that the SPPP is in desperate need of new iPads, specifically five full size iPads and two iPad minis for the officers riding bike details, but this request has to go through the City due to the City having the contract with the carrier. Ms. Cooper asked if there have been any improvements with obtaining Parking Enforcement ticketing booklets. Sgt. Castelin replied that there has been no traction yet on the digital ticket books, but noted that the Upper Quarter Patrol (UQP) has been taking on writing tickets. He reported that he had a few meetings with the City and the DA's Office to discuss moving forward on a program where tow trucks will come out from 7 PM to 1 AM on weeknights, and 8 PM to 3 AM on weekends, as well as during special events. Sgt. Castelin also noted that Parking Enforcement has recently hired 16 new tow truck drivers.

c. Upper Quarter Patrol Monthly Report\*

See attached document. Mr. Pendleton reviewed the UQP's May statistics and recommended that the Committee members take the time to read the full report, noting specifically the May 22<sup>nd</sup> incident. Cpt. Sammy Palumbo informed the Committee that the individual involved in the May 22<sup>nd</sup> incident turned out to be an antique dealer. He assured the Committee that this was not an attempted attack, but was an elevated issue that was handled excellently by the officers who were on scene to investigate.

d. Travelers Aid Society of Greater New Orleans Monthly Report\* To Present: Mayté Hernandez

See attached document. Mayté Hernandez reviewed the latest Travelers Aid Society of Greater New Orleans report with the Committee, noting that in May 71 clients were reached, with 21 of these individuals being new clients. She noted that two clients were moved into permanent housing, two clients were connected to housing vouchers, and two clients were moved into transitional housing. Ms. Hernandez reported that, as of May, 18 individuals have been housed through the Rapid Rehousing program.

#### 6. Discussions -

a. Essence Festival Security Communications

Sgt. Castelin stated that the SPPP is prepared for Essence Fest, noting that there will be more officers working than regularly and that he expects no disruptions in service. Cpt. Palumbo reported that the closures will be from 4 PM to 4 AM, however there may be times when closures will have to go into effect sooner. He added that the Eighth District is prepared to continue closing Bourbon Street daily, but may close the street earlier during the festival based on traffic flow. Cpt. Palumbo stated that when closures are in place, Royal Street will be open. Mr. Pendleton stressed the importance of communicating these updates to all neighborhood residents, businesses, workers, and stakeholders.

b. Downtown Development District / FQMD Security Collaboration

Donald Clouse of the Downtown Development District (DDD) reported that he had a meeting a few weeks ago with the Louisiana State Police (LSP), Ms. Dietz, Ms. Courseault, and Matt Pincus to discuss combining all available resources from each party for tackling the problematic 100 blocks of the French Quarter. Sgt. Castelin added that he is trying to duplicate the sweeps in these areas as well. Ms. Dietz reported that the Department of Public Works (DPW) is working on a plan to change the parking spaces of the 100 blocks at Exchange Place and Royal Street into police zones. Ms. Courseault is working on coordinating a follow-up meeting for all involved parties. Seth Knudsen, the new President of the DDD, introduced himself to the Committee and stated that he is excited about the partnership between the FQMD and the DDD.



#### 7. Updates -

a. City Council Community Development 6/18 Meeting Recap

Mr. Pendleton reported that the administration did not provide many answers and did not present a set plan for the Bourbon Street pedestrian mall to the public at the June 18<sup>th</sup> City Council meeting. Ms. Cooper recommended that the Committee decide if they want to take the lead on a traffic and parking enforcement study, as well as what this would entail. Mr. Pendleton agreed, stating that it may be necessary to schedule another Committee meeting before July 21<sup>st</sup>.

b. French Quarter Public Safety Signage Assessment

Ms. Dietz reported that she has been working with Committee members Josh Grippo and Maddie Charleston, and the Community Liaison Officers (CLO) on surveying the French Quarter stop signs and one-way signs, noting that three quarters of the neighborhood have already been surveyed. She stated that once the entire French Quarter has been surveyed and the list of signage is complete, any sign that is not in good condition will be replaced. The new signs will then be installed by the DPW. Bob Bejarano added that the signs have already been ordered and delivered to the FQMD office. He thanked Mr. Grippo and Ms. Dietz for the data they collected and provided to him for this project.

c. Street Markings Safety Project\*

See attached document. Bob Bejarano reported that 52 ramps have been repainted, along with 120 yellow corners and 18 fire hydrant corners. He stated that this project has already shown positive results, but reminded the Committee that the DPW will not be responsible for repainting these areas in the future, meaning the FQMD will have to continue future painting maintenance.

d. Gators for Community Liaison Program: Alex Dunkenberger

Sgt. Castelin reported that the Gators are waiting on a single source document stating that the supplier of the Gators is the only supplier that the SPPP uses, but after this document is received, he expects the Gators to arrive quickly. He added that he has the entire CLO program lined up and ready to go, with these two Gators dedicated specifically to the program. Sgt. Castelin noted that in the meantime he has been putting extra officers in these areas to address quality of life issues. Ms. Cooper stated that Alex Dunkenberger should be present at the Agreement Monitors meeting this afternoon to discuss any further updates.

8. New Business—To consider and take action upon any other matters that may properly come before the French Quarter Management District Security and Enforcement Committee

Ms. Dietz thanked KC Guidry, the Executive Director of the French Market Corporation, for her attendance. Ms. Guidry thanked the FQMD for their hard work and dedication to the French Quarter, noting that it will be valuable for both groups to work together in order to solidify these relationships moving forward.

Mr. G. Bilby stated that he has been hearing positive feedback from residents and businesses about the integration of LSP in the French Quarter last fall. He noted that he has been working with Ms. Dietz on writing a proposal for funding an LSP detail, which would be in coordination with the Eighth District, and would fund two officers for four days a week. Ms. Dietz will disseminate this proposal to the Committee after today's meeting.

9. Next Meeting Date:

The next scheduled meeting date of the Committee is Monday, July 21st, 2025, at 11 AM.


Glade Bilby made a motion to adjourn. Steve Caputo seconded the motion, and the meeting adjourned at 12:13 PM.







## Summary of Month Activities

#### 5/16/2025

On Friday, May 16, 2025, at approximately 10:50 AM, Deputy Loy Madrigal, along with Deputy Joseph Lodwick, was positioned at the intersection of Royal Street and Iberville Street when a radio transmission was received from dispatch regarding a sighting of one of the escaped inmates from Orleans Parish Jail. The subject was reported to be fleeing toward the Hotel Monteleone Garage located in the 600 block of Bienville Street. Deputies Madrigal and Lodwick responded to the location, along with officers from the Louisiana State Police. Upon arrival, all units began a coordinated search of the Hotel Monteleone garage. While searching the ground level, Deputy Madrigal observed a male subject hiding underneath a parked pickup truck, drew his service weapon, pointed it at the subject, and gave loud verbal commands directing him to show his hands and remain still. The subject, later identified as Kendell Myles, initially refused to comply and displayed combative behavior. Louisiana State Police officers moved in and physically restrained the subject. Despite actively resisting arrest, they were able to gain control and place him in handcuffs. The subject was then escorted out of the garage. Before being placed into the police unit, a search of the subject's person was conducted. During the search, an improvised weapon commonly referred to as a shank was found in his possession. The weapon was secured and properly logged as evidence. Myles continued to act combatively and was verbally aggressive as he was placed into a marked police unit for transport. After securing the area, Deputies Madrigal and Lodwick initiated a continued search of the vicinity in an effort to locate the second escaped inmate who was reportedly with Myles. Shortly thereafter, dispatch was notified by the transporting officers that Myles remained highly combative during transport and additional assistance would be needed at the lockup. Deputies Madrigal and Lodwick proceeded to the lockup to assist. The subject continued to resist and verbally esca

#### 5/22/2025

On Thursday, May 22, 2025, at approximately 4:30 PM, Deputies Madrigal and Lodwick were conducting routine foot patrol in the 300 block of Royal Street when they observed a black Mercedes-Benz Sprinter van improperly parked, facing the wrong direction in the 600 block of Royal Street. Upon approaching the vehicle for further investigation, Deputy Lodwick observed in plain view via the driver-side window what appeared to be a submachine gun with a suppressor located on the front passenger seat. Nearby, a dark red mask and a leather bandoleer for shotgun shells were also visible. Deputy Madrigal flagged down Sgt. Russel Philibert of the New Orleans Police Department, who was in the immediate area. Sgt. Philibert notified dispatch and began coordinating an on-scene investigation. A witness provided a description of the individual associated with the vehicle (white male wearing a black jacket, gray pants, and a straw hat). Moments later, a male subject matching that description exited the M.S. Rau Gallery located on the same block. Deputy Thomas Maag, who had arrived on scene after hearing the radio call, detained the subject, later identified as Corey Wayne Briscoe. A lawful search of Briscoe's person revealed two antique pistols concealed in the jacket pockets, without holsters. Detective Charles Morgan of the Major Task Force and Homeland Security Investigations (HSI) was contacted and responded to the scene. He in turn notified his HSI supervisory agent. Based on the potential threat posed by the visible weapon and accessories in the vehicle, it was decided that the van would be cleared by an FBI K9 unit and sonar equipment to detect explosives. A search warrant was also requested and obtained. The 600 block of Royal Street was immediately blocked off to ensure public safety. After the vehicle was rendered safe, a lawful search was conducted. Several additional firearms and ammunition were recovered and secured. The firearms and evidence were documented and transported to the property room. Further investigatio

## Summary of Month Activities

#### 5/31/2025

On Saturday, May 31, 2025, at approximately 8:10 AM, while on foot patrol in the 300 block of Royal Street, Deputy Madrigal, along with Deputy Lodwick, received a radio call from Deputy Rodney Bailey requesting immediate assistance with a combative subject in the 100 block of Royal Street. Deputies Madrigal and Lodwick responded on foot and arrived at 132 Royal Street (Mr. Ed's Restaurant), where Deputy Bailey was observed struggling with a white male subject inside the main entrance. The subject was physically combative and resisting efforts to be controlled. Several NOPD officers and civilians were already on scene attempting to assist in subduing the individual. Deputy Madrigal assisted by controlling one of the subject's hands and applying handcuffs with the assistance of Deputy Lodwick and NOPD officers. Despite being restrained, the subject remained noncompliant, verbally aggressive, and physically resistant. In an effort to de-escalate and safely remove the subject from the business, Deputy Madrigal lifted the subject into a seated position and, with the assistance of other deputies, escorted him outside of the premises. The subject continued to struggle during the removal but was successfully placed in an NOPD unit and transported to University Medical Center for medical evaluation. The subject was not placed under arrest due to his uncooperative state and possible underlying medical or mental health conditions.

## Summary of Month Activities

#### 5/3/2025

On Friday, May 3rd, 2025, Detectives Conner Berthelot and Tyrone Jones were working an approved off-duty detail for the UQP Expansion Detail in the French Quarter. While patrolling in a marked OPSO unit on Canal Street going river bound, both Berthelot and Jones observed a silver Acura Sedan traveling at an excessive speed without active head lights. Detective Berthelot activated his emergency lights to signal the driver to pull over, at which point, the operator of the vehicle pulled over in the 400 block of Canal Street. At this time, NOPD officer Levi Atkin arrived to provide further assistance on the traffic stop. Detectives Berthelot and Jones then made contact with the driver, who was identified as Trey Lee, during which, Officer Atkin contacted the rear passenger identified as Dominick Raymond. Officer Atkin then conducted a criminal history check of both subjects revealing that Lee and Raymond were both wanted. Detectives Jones and Berthelot, with the assistance of Officer Atkin, then removed Lee and Raymond from the vehicle and placed them both in hand cuffs, while verification of the warrants were in progress. NCIC promptly verified that Raymond was wanted by the St. Bernard Parish Sheriff's Office for violations of Louisiana Revised Statues 14:35.3 (Domestic Abuse Battery) and 14:56 (Simple Criminal Damage to Property). Arrested subject Raymond was booked under a Fugitive item E-01025-25 and 6 Municipal warrants under item(s) E-01056-25, E-01057-25, E-01058-25, E-01059-25, E-01060-25, and E-01061-25. Arrested Subject Lee was booked into the Orleans Justice Center for the violations of Louisiana Revised Statues 14:68.4 (Unauthorized use of a Motor Vehicle) and 14:69(A) (Illegal Possession of Stolen Auto) under old NOPD item D-27718-23.

#### 5/4/2025

On May 4th, 2025, at approximately 12:05 PM, Detectives Berthelot and Jones were working an approved off-duty detail for the UQP Expansion Patrol in the French Quarter. Detective Berthelot was travelling down Canal Street driving towards the river when he observed a large group of individuals inhaling the contents of latex balloons outside of Creasers Casino. Upon returning to the exact location at 1:00 AM, Detectives Jones and Berthelot observed the offender, Tyrell Davis, inflating colorful latex balloons from a large black trash bag, which partially concealed one silver metal Nitrous oxide tank. Deputies then confiscated the silver nitrous tank from the subject's possession. Davis was searched incident to arrest and found to be in possession of a large quantity of large and small bills, including a multitude of balloons. Davis was then transported to the Orleans Justice Center and booked under the municipal statute for illegal possession of Nitrous oxide. The tanks were seized by Detective Jones, Detective Berthelot, and Sergeant Philibert.

## Summary of Month Activities

#### 5/2/2025

On Friday, May 2<sup>nd</sup>, 2025, at approximately 11:00 PM, Detectives of OPSO working the UQP Bourbon Promenade units, along with NOPD officers, attempted to apprehend a male subject at the intersection of Common Street & Carondelet Street. The suspect then fled the scene on a Moped. Detectives Madrigal, Berthelot, Jones, and NOPD Officer Patrick McFarlane followed the fleeing suspect, but lost sight of the suspect momentarily. Upon arriving at the intersection of Loyola & Tulane Avenue, the Detectives observed the fleeing subject involved in an accident with oncoming traffic. The suspect then ran on foot towards the Public Library. Seconds later, Detective Madrigal and Officer McFarlane were able to apprehend the subject without further incident. The NOPD Federal Task Force then assumed primary control of the incident.

#### 5/10/2025

On Saturday, May 10th, 2025, at approximately 10:40 PM, OPSO detectives working the UQP Bourbon Promenade responded to a radio call of an aggravated battery at the St. Louis Cathedral. Upon arrival, NOPD Detectives and OPSO detail personnel apprehended a male subject in possession of a box cutter. The male subject had just perpetrated the cutting of another male subject (victim) at the location. The incident was corroborated by witnesses. ## The Frontier Outreach Program – French Quarter Travelers Aid Society (TAS) in Partnership with FMC/FQEDD

#### May 2025 Monthly Report

In efforts to improve the life quality of individuals in the French Quarter area with active experiences, or notable histories of homelessness, Travelers Aid Society of Greater New Orleans has developed a program that will support connecting individuals to needed services previously inaccessible.

#### Progress Report: Efforts and Outcomes

For this program, three (3) case manager will be responsible for providing holistic services to unhoused individuals by offering connections to healthcare, public benefits, identification documents, and documentation support for housing needs.

The role of French Quarter outreach case managers expansion will be to consistently canvass the area on foot, engage with unhoused individuals residing in our designated zone to triage for basic needs and offering "light touch" referrals, service information, and/or case management assistance.



#### Success story

With some of our clients, connections to healthcare treatment can be challenging. This month, we were able to use the trust and bond we created with one particular client for a successful healthcare connection. This client had been struggling with an infection of both of their feet for many years and it had led to many hospitalizations. The client would get out of the hospital, go back to living on the street, and within a few weeks would have another critical infection. This had an immense effect on the client's mental health and their ability to stay in touch with their care workers and get housed. In the most recent flare up, the client had denied services. However, through building trust and teaming up with the client's support systems, our case manager was able to get the client the crucial care they needed. During this time, our case manager was also able to submit the client's full PSH packet and advocate directly with Coordinated Entry regarding the status of his condition. With this push, the client was matched to a program and a warm handoff was made. In the meantime, while the housing happenes, our case managed made strides to confirm a respite bed for the client. This care plan will ensure that the client does not have to go back to living on the street in his condition. With all the supports lined up this emergency situation turned into a very positive outcome.

#### **Challenges**

The current and upcoming weather conditions have posed a great challenge for the outreach team. As we approach hurricane season, we are encountering heavy rains and intense heat. Outreach workers have had to adjust their canvassing efforts to accommodate the unpredictable weather and are concerned about the state of our clients trying to protect themselves in this weather with no shelter. Clients have become difficult to find during rainstorms, as they seek shelter under street awnings and highway overpasses to attempt to stay dry. Many of our clients experienced heat stroke or heat exhaustion last summer and we are concerned about the worsening heat conditions expected this summer. Outreach workers have suggested to clients to seek shelter but are finding that many of our clients are unwilling to stay in any city shelters as a result of their negative experiences. It is our hope that we can provide as many weather provisions as possible for our clients in the upcoming months.







## How the Orleans-Jefferson Parish-Kenner 2023 \$32,898,648 HUD Continuum of Care Award is Spent



- This is the current award that the CoC is operating from. It was made pursuant to the Federal FY 2023 Funding Competition, with each of the grants beginning sometime in the calendar year 2024.
- Permanent Supportive Housing is an ongoing rent subsidy with a case manager visiting the client in their apartment as often as needed. This is the evidence-based practice for ending homelessness of those who have mental or physical disabilities and need supportive services to remain stably housed.
- Rapid Re-Housing is a time-limited rent subsidy with a case manager visiting the client in their apartment. This is proven effective at ending the homelessness of people with less severe service needs, especially those able to work full-time. RRH can also serve as a bridge to PSH while documentation of disability is being gathered.

#### **PROJECT EXPANSION**

FQMD, in partnership with the City Department of Public Works, began work May 2025 for the Street Markings Project, following *MUTCD guidelines* for approved street markings to clearly identify where illegal parking is prohibited in the French Quarter and to improve access for fire and emergency response vehicles to maneuver in the Quarter. *NOTE: Maintenance of these colors, will be the expressed responsibility of FQMD. As of June 2025, this project has expanded to include more signage and Pedestrian Safety Crosswalk Markers in the specified locations.*
