2. Public Comment:

No written public comment was received.

3. Motion – Consider a motion to approve the previous meeting notes

Joey DiFatta made a motion to approve the previous meeting notes. Rene Fransen seconded the motion, and it was approved.

4. Committee Chair's Comments & Guest Introductions

Chair Mamie Gasperecz welcomed the Committee and guests. She noted that she will be reaching out to the remaining addresses on the Spanish Tiles replacement list this week.

Mr. DiFatta made a motion to reorder New Business to be agenda item number five. Antonio Carbone seconded the motion, and it was approved.

5. New Business—To consider and take action upon any other matters that may properly come before the French Quarter Management District Livability Committee

See attached document. Katy Casbarian, French Quarter resident and Arnaud's employee, introduced herself to the Committee and presented her Bourbon Street Holiday Lighting proposal. She stated that she has teamed up with the design firm Studio West to create the lighting designs, which celebrate Bourbon Street's cultural identity through illuminated trumpets, umbrellas, mesh "music" lighting, and handkerchief motifs, with the site plan for the installation to be the 100-300 blocks of Bourbon Street, Ms. Casbarian added that the installation will include a special memorial for the victims of the January 1st tragedy, with the names of the victims incorporated into the lighting. She noted that this installation is not permanent, adding that the lighting would be installed in three separate stages. Ms. Casbarian stated that the budget for the project is \$290K, but, to date, \$165K has been collected from multiple organizations in support of the project. She noted that she is working with Studio West through the permitting process with the Department of Public Works, the labor is being donated by All Start Electric, and the marketing and public relations are being handled by New Orleans & Company (NO&CO). Ms. Casbarian added that this would be a one-time investment, and can be expanded in later years if it is successful. She informed the Committee that she has also reached out to Councilmembers Freddie King, Helena Moreno, JP Morrell, and Director of Nighttime Economy Mike Ince. Vice-Chair Erin Holmes asked if she has approached the Vieux Carre Commission (VCC) about the project. Ms. Casbarian replied that she has not yet reached out to the VCC. Mr. DiFatta commended Ms. Casbarian for taking on this project, and noted that he is serving on the Memorial Committee for the January 1st victims and will be at the Committee's first meeting tomorrow at 10 AM at the Greater New Orleans Foundation where Ms. Casbarian will be presenting her proposal. He asked if the there is a storage facility for the lighting. Ms. Casbarian replied that she will be speaking with the Convention Center to see if they have available storage space.

Ms. Casbarian stated that her request for the FQMD comprises of two elements: assistance in funding, up to the remaining balance of \$145K, and for the FQMD to act as the entity owning the project. She noted that, if the FQMD agrees to own the project, a Cooperative Endeavor Agreement (CEA) would need to be created between NO&CO, the FQMD, and the Convention Center. Mr. Carbone pointed out that part of the funding that the FQMD administers is for the French Quarter Economic Development District (FQEDD), and if the holiday lighting drives foot traffic to the French Quarter, this would generate more sales for all businesses and provide a return on investment with FQMD donating to the cause. The Committee discussed the pros and cons of the FQMD leading the project, with the main concerns being staff capacity and bandwidth. Mr. Carbone pointed out that a CEA will have to be drafted and legal liabilities would need to be figured out. Ms. Courseault stated that she would prefer to advise Ms. Casbarian to seek others to own the project, but that the FQMD would still like to provide funding in some capacity. Jane Cooper added that the funding for this project would come out of the FQMD's operations budget, which could affect salaries and insurance. Ms. Holmes stated that she likes the proposal, but is not comfortable voting yes or no on the matter until she is able to speak to her board at VCPORA. Mr. DiFatta made a motion to recommend to the Finance & Development Committee approval of the Bourbon Street Holiday Lighting Proposal with the understanding that the FQMD is providing financial support for this request, but no administrative responsibilities. Katie Kolthoff seconded the motion, and it was approved. Ms. Holmes abstained.

 - a. 2026 Budget Planning
 - i. (Revised) Public Safety ROW Guidelines

Mr. Carbone reviewed the revised proposal with the Committee, noting that the revisions made include changes to the language to provide more clarity, a narrower and more specific scope, and a list of deliverables. The Committee made no further revisions. Mr. Carbone stated that he will be presenting the proposal to the Finance & Development Committee tomorrow afternoon.

ii. Unhoused Outreach & Services: Approach and Desired Outcomes (KPIs)

Ms. Gasperecz stated that the Committee will need to decipher if they want to move forward with funding the Travelers Aid Society of Greater New Orleans (TASGNO), and if this topic should remain as an area of focus for the Security & Enforcement Committee, or be moved to the Livability Committee. Ms. Cooper added that, though TASGNO works hard, there have not

been very effective results. She stated that the FQMD can look into other ways to fund homeless services, noting that funding an entity like Unity, which has the ability to provide permanent housing vouchers, may be a more beneficial route. Ms. Gasperecz stated that she felt that the Livability Committee is where this focus should land. She noted that she has a call with the CEO of Unity this week to discuss TASGNO's impact on the community as well as other funding options. She asked the Committee members for their feedback. Mr. DiFatta stated that the topic is a quality of life issue and should be a focus for the Livability Committee. Ms. Kolthoff agreed, but pointed out that law enforcement is critical for any program dealing with the unhoused. Ms. Holmes agreed that this topic should be a focus for the Livability Committee, and stated that she would like to have more information from Unity on all of the existing homeless services organizations and how the FQMD can tap into each of these entities' strengths for maximum impact. Ms. Cooper noted that \$250K has been earmarked in the FQEDD 2026 budget draft, but the group will need to reach a consensus at their October 6th Committee meeting on how this funding should be allocated. She recommended that the Committee come to next month's meeting with a "menu" showcasing the budget breakdown. Ms. Gasperecz agreed, noting that she will send out the information she receives from Unity to the Committee members individually before next month's meeting. She stated that she wants the Committee to send her feedback and questions between now and October 6th.

Ms. Courseault reported that FQMD Coordinator Shelby Ursu applied for Keep Louisiana Beautiful's 2026 Healthy Communities Grant, and was approved. She added that more details will be presented at the October 6th Committee meeting.

(Revised) Livability Committee Proposal Public Safety Right-of-Way Guidelines

I. Purpose

The Livability Committee proposes funding the development of a comprehensive plan focused on the French Quarter's public safety right-of-way (ROW). This initiative will establish long-term, preservation-compatible guidelines to govern improvements to infrastructure, signage, streetscapes, and public amenities.

Proposal Request: \$150,000

II. Background and Need

The French Quarter's public safety right-of-way assets—sidewalks, curbs, signage, lighting, trash infrastructure, and stormwater systems—face ongoing degradation from age, overuse, and lack of coordinated reinvestment. Restoration efforts are often piecemeal, and no comprehensive, district-specific standards currently guide ROW rehabilitation or modernization.

III. Scope

The plan will address the following public safety right-of-way categories:

- Sidewalks, curb ramps, and ADA access
- Historic and Cultural Wayfinding Signs
- Street markings and crosswalks
- Street lighting and utility poles
- Stormwater management (including but not limited to: gutter infrastructure, greenspace, tree well integration)
- Trash/recycling infrastructure
- Barricades, bollards, and safety infrastructure

IV. Deliverables

- District-wide condition and needs assessment
- Public safety right-of-way design guidelines and best practices
- Permitting and material standards aligned with VCC/DPW
- Prioritized implementation plan (phased, cost-tiered)
- Maintenance and Quality Assurance and Quality Control protocols

V. Implementation and Oversight

This proposal has been endorsed by the City of New Orleans, Department of Public Works and the Vieux Carré Commission, and will work in conjunction with both to steward this proposed Guidelines development. The Guidelines plan will serve as a foundational tool for aligning future projects, budgeting capital improvements, and advancing the district's livability and infrastructure goals.

The Frontier Outreach Program – French Quarter Travelers Aid Society (TAS) in Partnership with FMC/FQEDD

July 2025 Monthly Report

In efforts to improve the life quality of individuals in the French Quarter area with active experiences, or notable histories of homelessness, Travelers Aid Society of Greater New Orleans has developed a program that will support connecting individuals to needed services previously inaccessible.

Progress Report: Efforts and Outcomes

For this program, three (3) case manager will be responsible for providing holistic services to unhoused individuals by offering connections to healthcare, public benefits, identification documents, and documentation support for housing needs.

The role of French Quarter outreach case managers expansion will be to consistently canvass the area on foot, engage with unhoused individuals residing in our designated zone to triage for basic needs and offering "light touch" referrals, service information, and/or case management assistance.

French Quarter and TAS Rapid Rehousing Program

20 clients enrolled in TAS FQ RRH

18 clients housed in total

Efforts are being conducted to connect eligible and interested clients to Permanent Supportive housing. Out of the 18 currently housed, 14 will be bridged to another housing voucher. All participants were informed of the process as well as the possible wait time, and consenting documentation was obtained from all 14 participants. In addition:

- 8 mental health assessments were scheduled
- 4 ID card appointments were scheduled

Success story

This month, one of our French Quarter Case Manager facilitated a critical housing transition for a client and her mother. These clients had been previously housed through a Continuum of Care program but lost their apartment due to case management gaps. Since losing their apartment, both had been surviving in an unsafe and uninhabitable property. With multiple chronic and life-threatening health conditions, our case manager worked diligently with TASGNO's PSH Co-Lead to complete a housing program intake. After viewing a two-bedroom apartment, our clients will move in the first week of August. For the first time in months, this health-challenged family will have a stable, healthy environment, giving our client space to manage her conditions.

Challenges

This month, our FQ Case Managers continued to encounter challenges in the Washington Square Park and Marigny areas. Despite the City's increased focus on housing through shelter placements, the shortage of shelter beds has prevented some of our clients from obtaining a slot here. When clients are told to go to shelters, but none are available, progress toward long-term housing is halted. Without consistent outreach and stable case management, our clients risk falling further from essential services, perpetuating cycles of homelessness in some of the city's most impacted neighborhoods.






