2. Public Comment

No written public comment received.

3. Motion – Consider a motion to approve the previous meeting notes

Christine Bondio made a motion to approve the previous meeting notes. Vice-Chair Jane Cooper seconded the motion, and it was approved.

4. Committee Chair's Comments, Guest Introductions

Chair Alex Fein welcomed the Committee members and guests. He asked that the presenters be mindful of time during the meeting, so that all proposals have room for discussion.

- 5. Presentations / Discussions
 - a. *French Quarter Economic Development District Trust Fund 2026 Budget

See attached document. Alex Dunkenberger reviewed the 2026 French Quarter Economic Development District (FQEDD) Trust Fund budget draft with the Committee, noting that there are still some numbers that are being worked out. He reminded

the group that the City is required to present the draft budget, per the Cooperative Endeavor Agreement, by October 1st. Mr. Dunkenberger added that he will get the year-end tax revenue estimation and report it back to the Committee. He recommended that the Committee consider adopting a policy or guidelines in 2026 for the unused Trust Fund balance, which would help ensure that the reserves do not get overly depleted. Ms. Cooper agreed, but stated that this will need more discussion after the tax renewal vote. He continued to review the budget draft with the Committee and noted that some of the proposals under "Other Public Safety Programs" have yet to be approved. Frank Zumbo requested seeing the 2025 year-to-date budget and actuals to compare to the 2026 budget. Heidi Raines suggested adding a footnote into the document to clarify that the budget items highlighted in gray are unvetted items. Mr. Fein stated that it will be easier to have the unvetted gray items included in the budget now, rather than having to enter them into the budget in the future.

b. Budget Proposals

i. *Bourbon Street Holiday Lights Installation

See attached document. Steve Caputo presented the Bourbon Street Holiday Lighting Proposal to the Committee, noting that the proposal was created by Katy Casbarian, a French Quarter resident and business owner (Arnaud's). He stated that the proposal details Ms. Casbarian's collaboration with the design firm Studio West, and plans to coordinate with the Department of Public Works (DPW), and other city organizations, to have temporary holiday lighting installed on the first three blocks of Bourbon Street. This proposal also includes a tribute to the January 1st victims, with the victims' names being incorporated into the lighting design. Ms. Courseault stated that Ms. Casbarian presented her proposal to the Livability Committee yesterday, with two main requests to the FQMD: funding assistance for up to the remaining balance, and for the FQMD to manage the entire project and administer the funds. Ms. Courseault noted that, of the \$290K total project cost, \$165K has already been pledged. Ms. Cooper added that the Livability Committee was in support of funding the project in some capacity but did not support taking on the administering and managing of the project, due to the FQMD staff's bandwidth to take this project on within the next two months. Sue Klein pointed out that this project cannot be funded through the FQEDD Trust Fund, according to its language. Mr. Caputo pointed out that much of the heavy lifting would be the project's startup costs this year, with the option to expand the lighting in the future. He added that the FQMD has put a lot of hard work into the security and public safety of the French Quarter but hasn't had much focus on economic development or beautification, which are also part of the FQMD's obligations. Joey DiFatta noted that at the Memorial Committee meeting for the January 1st victims this morning, Ms. Casbarian gave the impression that most of the project's heavy lifting is already being conducted by All Star Electric, Studio West, and the DPW.

Ms. Courseault stated that Ms. Casbarian informed the Livability Committee that All Star Electric is donating all of the labor for the lighting installations, but storage would need to be assumed by another partner. Mr. Caputo suggested that the FQMD consider funding the project this year, and take lead on the project in 2026. The Committee agreed to consider. Ms. Courseault replied that there is currently \$327,500 remaining in the 2025 State appropriations to be utilized to fund this project. Ms. Cooper noted that Ms. Casbarian will need the funding as soon as possible, and because the State funds have not yet been received, the FQMD would have to pull from the operational budget and then be reimbursed once State funds arrive. Mr. Fein recommended donating 10% of the remaining State Appropriations fund to recommend to the full Board for consideration to the project. The Committee agreed, see motion below.

ii. *Security & Enforcement Committee: Transport Unit

See attached document. Security & Enforcement Committee Vice-Chair Jessica Dietz reviewed the Transport Unit Proposal for the Upper Quarter Patrol (UQP) with the Committee, noting that this transport unit would be specifically assigned to the UQP but would cover the entire French Quarter. Ms. Dietz stated that this vehicle would come at no cost to the FQMD, however it would ensure that the UQP officers on the grounds patrolling would not have to leave their patrols to transport arrestees. She noted that the proposal request is for \$62,400. The Committee was in support of the proposal, see motion below.

iii. *Livability Committee: (Revised) Public Safety Right of Way Guidelines

See attached document. Antonio Carbone, FQMD Livability Committee member, presented the revised Public Safety Right-of-Way Guidelines Proposal, noting that changes have been made to language in the proposal to provide more clarity, and the project scope and deliverables have been made narrower and more specific. He noted that this proposal would also be funded with State appropriations. Ms. Cooper pointed out that there are still unanswered questions on if the DPW would sign off on all of these guidelines. Ms. Courseault added that both DPW and the VCC have endorsed working with FQMD on this project. Ms.

Raines suggested that the project begin with the needs assessment study and then move on to the next steps with a pilot program. Mr. Fein agreed and recommended lowering the budget request to \$50K for the study, which the group can continue to review at next month's Committee meeting. He added that there is still time to review and revise the proposal instead of voting on it today. Mr. Carbone and Ms. Courseault will work together to ascertain the cost of the study and get clarity on how much the project's implementation will cost.

iv. *Government Affairs Committee: Elected Officials Forums

See attached document. No new updates were discussed; this agenda item is deferred.

v. *Operations: Marketing

See attached document. No new updates were discussed; this agenda item is deferred.

c. *FQMD YTD Budget to Actuals Presented By: Michelle Courseault

See attached document. Ms. Courseault reviewed the 2025 year-to-date budget and actuals with the Committee, noting that the document combines the City Trust Fund numbers and FQMD accountant John Foard's numbers. Mr. Zumbo pointed out that the FQMD does not handle the Trust Fund monies, stating that he feels the format is confusing and misleading. He stressed that the FQMD is not a revenue-generating organization and can only administer the revenue. He reminded the group that the FQMD has zero control of the City sales tax monies. Ms. Raines agreed, stating that the document makes it seem as though the FQMD is the fiduciary agent of the revenue. Ms. Courseault pointed out the specific language is listed on this budget document as "fiscal and operational oversight of the Trust Fund". Ms. Raines recommended adding a column into the document specifically for the FQEDD budget. Mr. Fein agreed and stated that he will continue to work with Ms. Courseault on cleaning up the budget format and making the document more comprehensive. Ms. Courseault confirmed that a new version to satisfy all concerns expressed will be presented in the next meeting.

The Committee made no motion at this time.

ii. *Authorization for Chair/ Vice Chair to execute contract with Dr. Richardson, for Economic Impact Study

See attached document. Ms. Klein made a motion to recommend to the Board of Commissioners authorization of the Board Chair or Vice Chair and to sign and execute a contract with Dr. Richardson for the Economic Impact Study. Ms. Raines seconded the motion, and it was approved.

iii. Bourbon Street Holiday Lights Installation

Ms. Cooper made a motion to approve funding the Bourbon Street Holiday Lighting Proposal for \$32k, but not to approve any project management or storage for the lighting. Ms. Klein seconded the motion, and it was approved.

iv. Transport Unit

Mr. Zumbo made a motion to recommend to the Board of Commissioners approval of the Upper Quarter Patrol Transport Unit Proposal as presented, with funding to come from the OJP Byrne grant. Ms. Raines seconded the motion, and it was approved.

v. Public Safety Right of Way Guidelines

No motion was made at this time.

vi. Elected Officials Forums

No new updates were discussed. This motion is deferred.

vii. Marketing

No new updates were discussed. This motion is deferred.

7. New Business—To consider and take action upon any other matters that may properly come before the French Quarter Management District Finance & Development Committee

Ms. Courseault stated that the Committee needs to vote on extending FQMD Program Manager Bob Bejarano's contract. She noted that he will remain a consulting contractor, increasing hours from 24 to 35 hours per week. Ms. Bondio made a motion to authorize the Board Chair or Vice-Chair to sign and execute the French Quarter Management District Program Manager contract extension. Ms. Raines seconded the motion, and it was approved.

Ms. Klein noted that staff should ensure that all contracts for street lighting and street markings are not paid in full until the work has been completed. Ms. Courseault agreed and clarified that nothing will be paid out for any of the ongoing projects until work has been completed and quality and assurance checks have been confirmed. She also noted that this is largely reported in the Livability Committee and Board meetings but will include more financial project updates for the Finance & Development Committee moving forward.

Mr. Zumbo recommended that the FQMD consider the idea of having legal counsel present at all Board meetings once the administration changes, noting that the Downtown Development District (DDD) always has a lawyer present. Ms. Courseault also noted that another difference between the DDD and the FQMD is their permanent existence legislatively and in funding. Mr. Dunkenberger also noted the difference in taxes: ad valorem taxes vs. Sales taxes. Mr. Zumbo added that DDD collects their tax directly.

The next scheduled meeting date of the Committee is Tuesday, October 7th, 2025, at 3:00 PM.

Ms. Bondio made a motion to adjourn. Ms. Raines seconded the motion, and the meeting adjourned at 4:13 PM.

Funding Request: Bourbon Street Holiday Lighting

Economic Development & Beautification Project

Background

Holiday lighting delivers both *beauty* and *economic* return, 2 pillars of FQMD's legislative purposes. Cities worldwide use seasonal lighting to draw visitors, extend stays, and increase local spending. Studies show every \$1 invested in lighting can yield \$4–\$6 in local economic impact. This project positions Bourbon Street as a holiday destination, not just a nightlife corridor—boosting tourism and business while honoring our culture.

Project Overview

Led by Studio West, the attached design celebrates Bourbon Street's cultural identity through illuminated trumpets, umbrellas, mesh "music" lighting, and handkerchief motifs. In recognition of the anniversary of the tragic January 1st incident, the installation will include a special memorial element: the names of victims incorporated into the handkerchief lighting. This gesture provides a visible acknowledgment of loss, remembrance, and resilience, woven into the celebratory spirit of the design.

Scope: 100–300 blocks of Bourbon Street
Season: Thanksgiving – first week of January

• Installation: One-week timeline

Project Budget:

- Total expense for fabrication- \$290k
- Committed Funding to Date- \$110k
- Funding Request of FQMD- Open, no amount specified, any contribution appreciated

Request:

FQMD has been approached with this request for funding as this is within legislative purpose: "The purpose of the district shall be to preserve and protect the French Quarter as a historic neighborhood and as a valuable component of the state's tourism industry, to aid in the beautification and overall betterment of the district, including but not limited to public safety and sanitation services, and to enhance the economic development of the district."

This project advances those purposes by:

- Enhancing the aesthetic environment of the French Quarter.
- Driving business vitality and tourism during the peak holiday season.
- Honoring the January 1 victims through a visible memorial element.
- Leveraging public-private partnerships to maximize community impact.

ED recommends consideration of the following eligible funding sources: (1) current bank balance OR (2) 2025-26 State Appropriations

BUDGET PROPOSAL: SEC - TRANSPORT

Transport Proposal - Upper Quarter Patrol

Enhancing Patrol Efficiency and Interagency Collaboration

Overview

This proposal recommends the addition of a dedicated transport component to the Upper Quarter Patrol. The proposed initiative involves assigning two OPSO deputies to operate a transport van on Friday and Saturday evenings from 8:00 PM to 2:00 AM.

Operational Details

· Personnel: Two OPSO deputies per shift

Schedule: Fridays and Saturdays, 8:00 PM – 2:00 AM

· Equipment: OPSO-provided transport van

Rationale and Justification

Currently, officers and deputies must leave the district to transfer arrested subjects, reducing the law enforcement presence in the area during critical hours. By introducing a transport van staffed by OPSO deputies, patrol units will remain in the district, increasing visibility and responsiveness to incidents. This enhanced coverage directly supports public safety and community confidence.

Additionally, this proposal strengthens the ongoing partnership between the New Orleans Police Department (NOPD) and the Orleans Parish Sheriff's Office (OPSO), fostering greater collaboration and operational efficiency.

Cost Estimate

Deputy Pay Rate: \$50 per hour per deputy



(Revised) Livability Committee Proposal Public Safety Right-of-Way Guidelines

I. Purpose

The Livability Committee proposes funding the development of a comprehensive plan focused on the French Quarter's public safety right-of-way (ROW). This initiative will establish long-term, preservation-compatible guidelines to govern improvements to infrastructure, signage, streetscapes, and public amenities.

Proposal Request: \$150,000

II. Background and Need

The French Quarter's public safety right-of-way assets—sidewalks, curbs, signage, lighting, trash infrastructure, and stormwater systems—face ongoing degradation from age, overuse, and lack of coordinated reinvestment. Restoration efforts are often piecemeal, and no comprehensive, district-specific standards currently guide ROW rehabilitation or modernization.

III. Scope

The plan will address the following public safety right-of-way categories:

- Sidewalks, curb ramps, and ADA access
- Historic and Cultural Wayfinding Signs
- Street markings and crosswalks
- Street lighting and utility poles
- Stormwater management (including but not limited to: gutter infrastructure, greenspace, tree well integration)
- Trash/recycling infrastructure
- Barricades, bollards, and safety infrastructure

IV. Deliverables

- District-wide condition and needs assessment
- Public safety right-of-way design guidelines and best practices
- Permitting and material standards aligned with VCC/DPW
- Prioritized implementation plan (phased, cost-tiered)
- Maintenance and Quality Assurance and Quality Control protocols

V. Implementation and Oversight

This proposal has been endorsed by the City of New Orleans, Department of Public Works and the Vieux Carré Commission, and will work in conjunction with both to steward this proposed Guidelines development. The Guidelines plan will serve as a foundational tool for aligning future projects, budgeting capital improvements, and advancing the district's livability and infrastructure goals.

2025 FRENCH QUARTER ECONOMIC IMPACT STUDY

THIS CONTRACT is made and entered into this ___ day of _______, 2025 by and between the French Quarter Management District, represented by Jane Cooper, Board Chair (the "FQMD"), and Dr. James A. Richardson, Economic Consultant (the "Contractor") (jointly "Parties").

WHEREAS, the Contractor, whose address is <u>3165 Kleinert Avenue Baton Rouge, LA 70806</u>, submitted a resume and work history in response to the FQMD's Request for Qualifications dated <u>30 July 2025</u> seeking a contractor to provide <u>2025 French Quarter Economic Impact Study</u>; and

WHEREAS, the FQMD desires to award the Contract to the Contractor.

NOW THEREFORE, the FQMD grants and confirms to the Contractor the contract to provide <u>2025 French Quarter Economic Impact Study</u> to the FQMD under <u>RFQ No. 2025-006</u> and the FQMD and the Contractor, for good and valuable consideration, agree as follows:

I. THE CONTRACTOR'S OBLIGATIONS.

The Contractor will perform all obligations of the Contractor and be subject to all terms and conditions set forth in this Contract and in the following documents that are incorporated fully into this Contract: the Request for Qualifications No. 2025-006, dated 30 June 2025; the Contractor's response dated 8 August, 2025 (the "Proposal"); a

The Contractor agrees to pay, at Contractor's expense, all taxes and other expenses incurred by reason of the job to be performed by Contractor, including but not limited to all sales and use taxes, licenses, fees, and personal property taxes, and all employment taxes or contributions imposed by law or trade union contracts or regulations.

II. THE FQMD'S OBLIGATIONS.

The FQMD will pay the Contractor for Services at the rates set forth in the Contractor's Proposal for the satisfactory performance of this Contract, within thirty (30) days of invoicing, and will perform all obligations of the FQMD and be subject to all terms and conditions set forth in this Contract and any incorporated documents.

III. TERM/TERMINATION.

This Contract may be terminated by either party upon thirty (30) days written notice to the other party.

IV. COMPLIANCE WITH LAWS.

Contractor shall comply with all applicable provisions of federal, state and local equal employment opportunity laws, rules and regulations, with all other applicable laws, rules, regulations, and orders including without limitation federal, state and local occupational safety, health and safety, and environmental requirements.

V. INDEPENDENT CONTRACTOR.

The Services rendered by Contractor in the fulfillment of the terms and obligations of this Contract shall be as an independent contractor and not as an employee, nor shall contractor be considered an agent, partner, or joint venturer of FQMD. Correspondingly, Contractor's employees shall not be employees of FQMD. Contractor shall not represent to third persons to be other than an independent contractor of FQMD, nor shall Contractor offer or agree to assume any obligations or commitments in the name of FQMD.

VI.—GUARANTEE.

Contractor guarantees all work and materials against defects in material and workmanship and against failure under normal usage, exclusive of ordinary wear and tear.

— Under such guarantee, Contractor agrees to repair or replace defective work and materials at no cost to FQMD when notice of defects or failure is given to Contractor within one year from the date of final acceptance of work by FQMD.

VII.—LIENS.

At FQMD's request, Contractor agrees to furnish a list of all fabricators, materialmen, subcontractors, suppliers, and workmen involved in Contractor's performance, together with evidence satisfactory to FQMD that all claims for labor and material have been satisfied and paid and that there are no unsatisfied claims for injuries or damage to persons or properties.

Contractor will defend, indemnify, and hold harmless FQMD their officers and employees, against liens, or claims of rights to enforce liens arising out of any Services performed by Contractor or any of Contractor's Subcontractors or due to any materials furnished by Contractor's or Subcontractor's supplier, provided FQMD has paid for such Services and materials, and for any claims, actions, or damages arising from Contractor's negligence.

VIII. INSURANCE.

Except as otherwise noted, at all times during this Contract or the performance of the Services required by this Contract, the Contractor will maintain the following insurance in full force and effect for the duration of the work under this Contract. Evidence of coverage shall be provided prior to the start of any activities/work, in conjunction with the Contractor's scope of work under the contract.

If the Contractor maintains broader coverage and/or higher limits than the minimums shown below, FQMD requires and shall be entitled to the broader coverage and/or the higher limits maintained by the Contractor. Any available insurance proceeds in excess of the specified minimum limits of insurance and coverage shall be available to the FQMD:

A. Minimum Requirements:

- 1. Workers' Compensation & Employers Liability Insurance in compliance with the Louisiana Workers' Compensation Act(s). Statutory and Employers Liability Insurance with limits of not less than \$500.000.
- 2. Commercial General Liability Insurance including contractual liability insurance, products and completed operations, personal & advertising injury, bodily injury, property damage, abuse and molestation, and any other type of liability for which this Contract applies with limits of liability of not less than \$1,000,000.
- 3. Automobile Liability, \$1,000,000 per accident combined single limit bodily injury and property damage liability.
- 4. Umbrella/Excess Liability Umbrella/Excess policies must follow form of the underlying policies.
- 5. Contractor shall be able to meet the above referenced specific policy limits of liability through a combination of primary and umbrella /excess coverage.
- 6. The obligations for the Contractor to procure and maintain insurance shall not be constructed to waive or restrict other obligations.
- 7. It is understood that neither failure to comply nor full compliance with the foregoing insurance requirements shall limit or relieve the Contractor from any liability incurred as a result of their activities/operations in performing the Scope of Work. Contractor shall be responsible for any losses, expenses, damages, claims and/or suits of any kind which exceed the Contractor's limits of liability that arise from the Contractor's performance of work under the Contract.
- B. Other Insurance Provisions. The insurance policies are to contain, or be endorsed to contain, the following provisions:
 - 1. Additional Insured Status: Contractor and all Subcontractors (where applicable) will provide, and maintain current, a Certificate of Insurance naming the FQMD, its departments, political subdivisions, officers, officials, employees, and volunteers as "Additional Insureds" on the CGL policy with respect to liability arising out of the performance of this Contract; General liability insurance coverage can be provided in the form of an endorsement to the Contractor 's insurance (at least as broad as ISO Form CG 20 10 11 85 or both CG 20 10 and CG 20 3 7 forms if later revisions used).

The Contractor shall require and verify that all Subcontractors maintain insurance and coverage limits meeting all the requirements stated herein. The Certificate of insurance, as evidence of all required coverage, should name the French Quarter

Management District as Certificate Holder and be delivered via U.S. Mail to

400 N. Peters Street, Suite 206, New Orleans, LA 70130.

The Additional Insured box shall be marked "Y" or Commercial General Liability coverage. The Subrogation Waiver Box must be marked "Y" for Workers

- Compensation/Employers Liability and Property.
- Primary Coverage: For any claims related to this Contract, Contractor's insurance coverage shall be primary insurance as respects the FQMD, its departments, political subdivisions, officers, officials, employees, and volunteers. Any insurance or self-insurance maintained by the FQMD shall be non-contributing to the Contractor's coverage.
- 3. Claims Made Policies: If applicable, the retroactive date must be shown and must be before the date of the Contract or the beginning of work. If the coverage is canceled or non-renewed, and not replaced with another claims made policy, Contractor must purchase "extended reporting" coverage for a minimum of 3 years after the termination of this Contract.
- 4. Waiver of Subrogation: Contractor and its insurers agree to waive any right of subrogation which any insurer may acquire against FQMD by virtue of the payment of any loss under insurance required by this Contract.
- 5. Notice of Cancellation: Each insurance policy required above shall provide that coverage shall not be canceled, expire, or altered except without prior notice to the FQMD of no less than 30 days.
- 6. Acceptability of Insurers: Insurance is to be placed with insurers licensed and authorized to do business in the State of Louisiana with a current A.M. Best's rating of no less than A: VII, unless otherwise acceptable to the FQMD.
- C. Contractor will provide the FQMD's Executive Director (at FQMD, 400 N. Peters Street, Suite 206, New Orleans, LA 70130) -Ref.: French Quarter Economic Impact Study within 10 calendar days of the Effective Date and at any other time at the FQMD's request the following documents:
 - 1. Proof of coverage for each policy of insurance required by this Contract; and
 - 2. Copies of all policies of insurance, including all policies, forms, and endorsements.
- D. Without notice from the FQMD, Contractor will:
 - 1. Replenish any policy aggregate limit that is impaired before commencement of any work or continuation of any work under this Contract; and
 - 2. Substitute insurance coverage acceptable to the FQMD within 30 calendar days if any insurance company providing any insurance with respect to this Contract is declared bankrupt, becomes insolvent, loses the right to do business in Louisiana, or ceases to meet the requirements of this Contract; and
 - 3. Notify the FQMD's Executive Director in writing within 48-hours of its receipt of any notice of non-renewal, cancellation, or reduction in coverage or limits affecting any policy of insurance maintained under this Contract.
- E. Special Risks or Circumstances: The FQMD shall reserve the right to modify these

requirements, including limits, based on the nature of the risk, prior experience, insurer coverage, or other circumstances.

IX. LIABILITY AND INDEMNITY.

As an independent contractor, Contractor shall be responsible for its own operations in accordance with the laws of the State of Louisiana.

X. CHANGES.

FQMD may request changes to the specific work scopes under this Contract. If Contractor is of the opinion that a proposed change will either increase or decrease the cost and/or time required for performance, Contractor shall so notify FQMD, and any subsequent change satisfactory by Contractor and FQMD, and shall thereafter modify this Contract accordingly and in accordance with Louisiana law.

XI. GOVERNING LAW.

THE PROVISIONS OF THIS CONTRACT AND THE DOCUMENTS DELIVERED PURSUANT HERETO SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF LOUISIANA. ANY CLAIMS, ACTIONS, OR LAWSUITS SHALL BE SUBJECT TO VENUE IN A COURT OF COMPETENT JURISDICTION IN ORLEANS PARISH, STATE OF LOUISIANA.

XII. SUSPENSION AND/OR CANCELLATION.

Should Contractor be unable to fulfill the Services under this Contract in a timely and professional manner, FQMD shall have the right to cancel or suspend this Contract with seven (7) days written notice. FQMD shall be entitled to pursue any and all legal remedies against the Contractor for any failure of Contractor to perform the obligations set forth in this Contract.

In the event that the FQMD determines that the project covered under the Scope of Work is not able to continue, FQMD shall immediately notify Contractor and terminate Contract without further expense. Any costs incurred and owed prior to this notice, will be paid by FQMD.

XIII. SAFETY.

Contractor acknowledges that it possesses the federal, state and local licenses and certifications necessary to practice in the state in which the work is to be performed and shall perform the work in a manner consistent with all applicable regulatory and industry standards.

XIV. ASSIGNMENT OF SUBCONTRACT.

Contractor shall not assign or transfer this Contract, or any interest herein, without written consent of the FQMD.

XV. FLOW-DOWN AND JOB-SPECIFIC PROVISIONS.

Contractor acknowledges that its participation in certain work assignments may be contingent upon its acceptance of additional provisions including, but not limited to, obligations to secure bonds, increase insurance limits or sign non-disclosure contracts as may be required by the type of work or the terms of a contract between FQMD and Contractor. FQMD shall present such requirements to Contractor for its review, and appropriate provisions shall be included in the Purchase Order for the Work.

XVI. ENTIRE CONTRACT.

This Contract contains the entire Contract of the Parties, and there are no other promises or conditions in any other Contract whether oral or written.

XVII. SEVERABILITY.

If any provision of this Contract shall be held to be invalid or unenforceable for any reason, the remaining provisions shall continue to be valid and enforceable. If a court finds that any provision of this Contract is invalid or unenforceable, but that by limiting such provision it would become valid or enforceable, then such provision shall be deemed to be written, construed, and enforced as so limited.

XVIII. STATUTORY EMPLOYER RELATIONSHIP.

The following terms shall have the following meanings: (a) "Contract Work" shall mean, in addition to its definition elsewhere stated, all additional or supplemental work as Contractor and/or employees of Contractor may be called on to perform or actually perform under this Contract, and which additional or supplemental work, if any, shall be deemed to be contemplated by and included in this Contract; and, (b) "Employees of contractor" shall mean all direct, immediate or statutory employees of Contractor performing contract Work as that term is defined in this paragraph. The Contract work shall be considered as part of Contractor's trade business, or occupation and an integral part of, or essential to, the ability of Contractor to generate its goods, products or services. Contractor shall be the statutory employer of contractor individually, and all Employees of contractor while performing the contract Work. It is the intent of Contractor to have all the benefits of a statutory employer relationship to the fullest extent permitted by LA-R.S. 23:1061, as amended.

XIX. ADDITIONAL PROVISIONS.

A. Entire Contract. This Contract, including all incorporated documents, constitutes the final and complete Contract and understanding between the Parties. All prior and contemporaneous Contracts and understandings, whether oral or written, are superseded by this Contract and are without effect to vary or alter any items or conditions of this Contract.

An Economic Impact Analysis of the French Quarter in New Orleans

August 8, 2025

I. Introduction, Background, and Purpose

Overview

Dr. James A. Richardson, Economic Consultant, 3165 Kleinert Avenue, Baton Rouge, LA 70806, presents a scope of work and proposal regarding an analysis of the economic impact and role of the French Quarter in New Orleans to the French Quarter Management District making use, as appropriate, of qualitative analysis, statistical analysis, economic modeling including input-output models, and benefit-cost analysis. All of these methods of data analysis require an accurate description of the New Orleans French Quarter in terms of economic activity and connecting the French Quarter analysis to the New Orleans economy.

Background and Purpose

The French Quarter has been a long-standing complement of and participant in New Orleans' world-wide recognition as an incredible place for tourism, business conferences, major conventions, sporting events, and supporting other major activities in New Orleans. The Bureau of Governmental Research in its 2015 analysis of what was on the ballot in the 2015 election made the following statement: "The French Quarter is unlike any other neighborhood in New Orleans. Not only is it home to approximately 3,800 residents, it is the centerpiece of the city's tourist economy. In 2014, an estimated 9 million tourists visited the Quarter." The University of New Orleans Hospitality Research Center estimated that 9.52 million visitors came to New Orleans in 2014 or 95% of visitors to New Orleans in 2014 visited the French Quarter.

From time-to-time it is important to evaluate or re-evaluate and quantify the role of the French Quarter in the overall New Orleans economy including economic impact and role of the French Quarter to the overall economic outcomes in New Orleans.

Consulting Team

Dr. James A. Richardson will be the lead consultant. Dr. Richardson's curriculum vita, recent studies that he has completed, work that he has done for New Orleans organizations, and other information regarding his qualifications are presented in Attachment B.

As a summary, Dr. Richardson has worked with every Governor and members of the State Legislature since the 1970s through 2019. In 1987 he was asked to be the private economist on the State's Revenue Estimating Conference, and he served on that Conference until September 2019 working with six different governors. This Conference defined exactly how many dollars the state had for recurring expenses and the State's budget could not exceed this amount. Dr. Richardson worked with

the State in getting financial aid for New Orleans after Katrina. He testified before the House Committee focused on the financial needs of the city; he, along with others, met with the U.S. Secretary of Commerce; and he spoke with staff members of the President's Council of Economic Advisors. Dr. Richardson worked with architects and contractors after Katrina to develop a redevelopment plan for New Orleans.

Dr. Richardson has consulted with the Audubon Nature Institute, Greater New Orleans, Inc., the Downtown Development District, the Louisiana Public Health Institute, the New Orleans Convention and Visitors Bureau (now New Orleans & Company), the Greater New Orleans Foundation, and other New Orleans-related organizations and companies. Dr. Richardson served with Dr. Tim Ryan on a mayoral committee to evaluate the overall tax structure in New Orleans.

In the past five years, Dr. Richardson worked with the Louisiana Hospital Association on the economic role of hospitals throughout Louisiana, by medical districts within the state, and by Congressional Districts. He provided information to the Lafayette Economic Development Authority in encouraging a major business to locate in Lafavette. He assisted Lafavette Utilities Services, Fiber in developing a plan to extend its services (providing internet, video, and phone service) throughout the parish. He provided a summary of 50 years of financial activity by the Louisiana Public Facility Authority and its economic impact with over 25% of financial support being in the New Orleans area; an examination of Pointe Coupee Parish budgeting given a major change in its available ad valorem revenue; a study on the economic activity of the Bar Pilots for the Associated Branch Pilots (licensed to captain big ships between the sea buoy and Pilottown); the public benefits associated with developing a public road connecting Esperanza Business Park with LA Hwy 3177 in St. Charles Parish; participated in a study for Calcasieu and Cameron Parishes, Just Imagine SWLA, that was supported by the Community Foundation of Southwest Louisiana; short and long-term budget analysis for the Cameron Parish School Board; an analysis of the economic role of a major company in northwest Louisiana; and, has served as an expert witness in several legal cases. He is currently working with a private firm focusing on redeveloping an iconic building in downtown New Orleans.

Dr. Richardson will be assisted by

- (1) Mr. Gregory Albrecht, Chief Economist of the Louisiana Legislative Fiscal Office for nearly thirty years, prior to retiring at the start of 2022. As Chief Economist he was responsible for state revenue forecasting for the Consensus Revenue Estimating Conference that determined much of state resources available for appropriation each year. He also was responsible for fiscal notes associated with bills being proposed by members of the State Legislature. He also provided information about possible tax changes being considered by the Legislature or being proposed by the Governor. He is presently a research fellow for the LSU Center for Energy Studies assisting with economic and fiscal estimates of various energy projects within the state. He developed various methods for data visualizations and infographics in providing information to state leaders and the public. Greg has recently returned as a Consultant to the Legislative Fiscal Office for revenue forecasting.
- (2) Dr. Daniel Groft is Associate Professor of Economics and Director of the HC Drew Center for Business and Economic Analysis at McNeese State University. After receiving his Ph.D. in Economics from Louisiana State University, Dr. Groft was Assistant Professor at McNeese for two years before becoming the sole economist at Louisiana Economic Development. Serving as the sole economist at the state agency, Dr. Groft provided economic research services and produced

statistical data, frequent economic reports, and analyses for use by regional partners, marketing staff, clients, legislature, and other governmental bodies. Dr. Groft went on to be the economist at the Louisiana Department of Revenue. While there, he analyzed tax situations and policies for legislative and technical inquiries, reports, and publications. He also estimated the effects of federal and state tax policy proposals on state tax revenues while evaluating the impact of business trends and Louisiana's economy on tax collections. As Director of the Drew CBEA at McNeese, Dr. Groft's duties include tracking economic data related to the Southwest Louisiana economy, answering economic related inquiries, producing quarterly reports on the state of the regional economy, and conducting economic analysis for commissioned reports such as *Just Imagine SWLA*. He is a frequent guest speaker at local events giving updates on the economy and also hosts the Southwest Louisiana Economic Intel podcast which looks at economic issues affecting the five parish Southwest Louisiana region.

II. Scope of Work

Consultant will perform the following tasks:

- (1) The objective of the study is to identify and quantify the economic impact and role of the French Quarter on the tourist industry in New Orleans, including its impact on overall local businesses and employment, its impact on hotels and restaurants, and its impact on special events.
- (2) Consultant will confer with the French Quarter Management District and other parties associated with the City of New Orleans regarding the role of the French Quarter in driving the growth of the New Orleans economy. These other parties, after conferring with the French Quarter Management District, may include New Orleans and Company, the New Orleans Convention Center, Greater New Orleans, Inc., Greater New Orleans Foundation, Louisiana Restaurant Association, Louisiana Hotel Association, the Downtown Development District, the Superdome Commission, and other participants in support of New Orleans tourism and the New Orleans economy. Consultant will utilize the studies and data provided by the Bureau of Governmental Research, The Data Center, and other research outlets in New Orleans and the state.
- (3) A complete analysis of the economic importance and significance of tourism to the City of New Orleans, the Greater New Orleans economy, and the state of Louisiana
- (4) A full economic description and analysis of the French Market District and its role as a significant economic driver in the New Orleans economy, the New Orleans MSA, and the state of Louisiana. This description will include information on the number of businesses in the French Quarter, state and local sales taxes generated by these businesses, property taxes and other real estate data as they pertain to the French Quarter, and other economic measurements that are publicly available and as possible, information that may be available through private parties.
- (5) Other economic data regarding tourism for New Orleans including estimates of visitors and length of stay, hotel occupancy rates by geographical divisions within the city, estimates of spending by visitors, flight data at the Louis Armstrong New Orleans International Airport and the Lakefront Airport, and other data that will be helpful in identifying the significance of tourism to the New Orleans economy and the significance of the French Quarter in enhancing this tourism.
- (6) Consultant will gather public data including business and government data, property data, and any and all existing reports that may be available.

- (7) The data gathered in Sections (2), (3), (4), (5), and (6) will describe the importance of tourism to the New Orleans economy and, for that matter, to the state's economy. But this is just the beginning of the role of tourism and the role of the French Quarter in supporting the local and state economy.
- (8) Economic impact of tourism on the local and state economy with this impact relating to capital spending and ongoing spending and employment; the impact on other industries in the region; the employment and personal income associated with this economic impact in the region and state; and, the ongoing tax revenues, both local and state, associated with the economic impact associated with New Orleans tourism and the significance of the French Quarter in generating and supporting this tourism.
- (9) Economic impacts will be based on nationally-recognized Input-Output models and, as appropriate, benefit-costs ratios will be developed.
- (10) An analysis of what an increase in tourism means to the New Orleans economy and the state's economy and how the French Quarter fits into that increase
- (11) In summary, consultants will focus on the following:
 - a. Tourism and economic activities in the French Quarter, New Orleans, Greater New Orleans area, and the state
 - b. Impact of tourism on other industries in the city and state
 - c. Economic impact of the tourism on the local and state economy.
 - d. The role of the French Quarter in encouraging and supporting tourism in New Orleans
 - e. Provide an executive summary (no more than two pages) and an economic impact report to the French Market Management District and provide infographics that can be used to highlight the results of the analysis.
 - f. Dr. Richardson will be available to discuss the study with French Quarter Management District and other persons and organizations as requested by the French Quarter Management District.

III. Deliverables and Timeline

Consultant will provide the following deliverables as described in the Scope of Work: (1) an executive summary, (2) an economic impact report, (3) infographics and data visualizations, and (4) consultant will be available for discussions of the report with the French Quarter Management District.

Consultant will submit the executive summary, economic impact report, and a set of infographics as of October 3, 2025 if the proposal is accepted no later than August 22, 2025. Consultant will present key findings of the study to the Board of Commissioners on October 13, 2025.

Summary of the Curriculum Vitae for Dr. James A. Richardson

James A. Richardson is Professor Emeritus at Louisiana State University. He was Alumni Professor of Public Administration and Economics in the E. J. Ourso College of Business at Louisiana State University in Baton Rouge, Louisiana. Dr. Richardson has served as Chairman of the Department of Economics, Acting Dean of the College of Business Administration, Associate Vice Chancellor for Academic Affairs at Louisiana State University and Director of the Public Administration Institute.

Dr. Richardson served from 1987 through September 2019 as the private economist on the Louisiana Revenue Estimating Conference, the panel with the constitutional authority and responsibility to provide official revenue estimates for the state. This Conference includes the Governor of the State, the President of the Senate, the Speaker of the House of Representatives and the private economist. All decisions must be unanimous. He received Commendation from the Louisiana Senate and House of Representatives (SCR 115) for his 32 years of service on the Revenue Estimating Conference. Dr. Richardson also serves as a member of the Board of Directors of the Public Affairs Research Council and as a member of the Council for A Better Louisiana. He has also provided services for the Louisiana Committee of 100.

He organized and supervised a major tax study for the state of Louisiana which resulted in Louisiana Fiscal Alternatives: Finding Permanent Solutions to Recurring Budget Crises, published by the LSU Press in 1988. Dr. Richardson has co-edited a major book, Handbook on Taxation, which was published by Marcel Dekker in January 1999. Two books have been recently published with the LSU Press, Exploring Long-term Solutions for Louisiana's Tax System, November 2018 (with co-authors from Tulane University) and Managing Hurricane Katrina: Lessons from a Mega-Crisis, 2019 (with co-authors from the Netherlands and Belgium). Dr. Richardson also served on the Louisiana Law Institute's Tax Study Commission, a group that was formed in response to Senate Concurrent Resolution 88, passed in 1999. In 2016 Dr. Richardson was named co-Chair of the Task Force for Strategic Changes in Budget and Tax Policy for the State Legislature. He was asked by the Governor to serve on the Recovery Task Force helping shape the state's recovery from the August 2016 storms. He has also been asked to be a participant in the Resilient Louisiana Commission, a group seeking to assist Louisiana in working its way through the economic issues dealing with the pandemic and setting up a long-term growth strategy for the state. He worked with Urban Design Associates of Pittsburg, PA on a long-term economic development strategy for Southwest Louisiana and is working with the City of Lake Charles regarding federal assistance to assist in disaster recovery.

Dr. Richardson served as fiscal advisor to the Governor of Louisiana from 1988 through 1991. He contributed to the comprehensive tax study for the state of Kansas in 1995. He served as an advisor to the state of Alabama's Department of Revenue in 1996. He has served as Associate Editor of the Journal of Education Finance and the Texas Business Review. His work has been published in numerous journals such as the National Tax Association Proceedings, State and Local Government, Public Finance Quarterly, Growth and Change, Natural Resources Journal, Journal of Energy and Development, and Journal of Economic Dynamics and Control.

Dr. Richardson participated in the preparation of the Louisiana Economic Outlook, a two-year forecast of the Louisiana Economy published by the E. J. Ourso College of Business at Louisiana State University from 1983 through 2015. This outlook focuses on major industries in Louisiana, specifically the oil and gas industry. Dr. Richardson has worked with the state of Louisiana, with various Louisiana ports, and with the industry regarding oil and gas development in the state and in the Gulf of Mexico.

Dr. Richardson prepared analysis of the impact of Katrina on the New Orleans economy and ways to accelerate its recovery for the Financial Services Roundtable. He also testified before the Committee on Financial Services of the United State House of Representatives on Housing and the New Orleans Recovery. He has been involved in numerous studies regarding the New Orleans recovery, including studies regarding the upgrading of the riverfront, enhancing the theater district, developing downtown attractions such as the aquarium and the insectariums, and relating the New Orleans airport to the city's economic development. Dr. Richardson was a member of the team that put together Plan Baton Rouge 2, the master plan for East Baton Rouge Parish, the BioDistrict in New Orleans, and the master plan for Ascension Parish. Dr. Richardson provided information regarding changing school boundaries in East Baton Rouge Parish School System as well as creating a new municipality in East Baton Rouge parish. He later served as an expert in the St. George/Baton Rouge court case.

Dr. Richardson received his Bachelor of Art degree in economics from St. Mary's University of San Antonio, Texas and his master's degree in economics and the doctorate in economics from The University of Michigan. Dr. Richardson specializes in regional forecasting, state and local tax policy, economic valuation, and energy economics.

PROPOSAL: GOVERNMENT AFFAIRS COMMITTEE ELECTED OFFICIALS ENGAGEMENT EVENTS

Purpose:

Host two events in 2026 to engage elected officials, showcase FQMD's impact, and build support for legislative and funding priorities.

Background:

FQMD's legislative purpose includes collaboration with government partners to improve public safety, sanitation, and infrastructure in the French Quarter. The Government Affairs Committee currently relies on fragmented, largely 3rd party communications with elected officials. Hosting structured, targeted events will allow FQMD to: - Demonstrate project outcomes and accountability - Strengthen relationships across government levels - Build momentum for future support, per the recommendation of LRA Government Affairs department.

Proposed Plan: Two events will be planned and hosted in 2026:

- 1. Spring 2026 State of the Quarter Briefing Luncheon (at the Capitol)
 - Presentation
 - o Invite: State, City, and Congressional officials
 - o Content: FQMD accomplishments, impact visuals, current priorities
- 2. Fall 2026 French Quarter Forward Reception
 - Host event at a historic venue
 - Invite: New Orleans delegation + local FQ elected officials and partners
 - o Content: Brief remarks, printed priorities, optional cultural element

Roles:

Staff: FQMD prep print materials, coordination of invitations

Gov't Affairs Committee:

- Rely on LRA, Hotels & Lodging, and NOCO to coordinate logistics: venue and F&B;
- Messaging, outreach

Board Members: Participation, relationship-building

French Quarter Management District

Proposal: Marketing Consultant Retainer (Project-Based)

Background

The French Quarter Management District (FQMD) is legislatively tasked with enhancing public safety, sanitation, and quality of life while preserving the cultural and economic vitality of the French Quarter.

To deliver on this mission, FQMD must not only implement programs but also ensure clear, visible, and consistent communication with stakeholders. At present, these responsibilities fall heavily on the Executive Director and consultants whose scopes are limited, which constrains the organization's ability to deliver professional outreach and marketing.

The FY 2025 Trust Fund budget includes a \$7,500 line item specifically allocated to marketing the Task Force Mobile App. Multiple committees have also emphasized the need for marketing support to advance their initiatives:

- Livability Committee: Spanish Tiles Restoration, Glass Half Full Recycling Pilot
- Security & Enforcement Committee: Task Force Mobile App (budgeted)
- Security & Livability (joint): Remove Lock Take crime prevention campaign
- Infrastructure/Livability: 311 promotion for streetlight repair reporting

Given these approved budget allocations and committee directives, FQMD is required to execute marketing and public outreach to fulfill its commitments.

Proposal

Contract with a Marketing Consultant on a project-based retainer to provide communications and campaign execution across FY 2024–25.

The consultant will:

- Develop branded campaigns for Board/Committee-approved initiatives.
- Produce professional one-pagers, digital assets, and outreach collateral.
- Create social media packets for Board of Commissioners' organizations to post on their own platforms (graphics, captions, hashtags).
- Build campaign-specific media kits to support ERPR's press and narrative work.
- Integrate campaigns into FQMD's broader ERPR (Earned, Owned, Shared, Paid) media strategy for consistency and impact.

Priority Campaigns 2024–25:

- Spanish Tiles Restoration (heritage + beautification)
- Glass Half Full Recycling Pilot (sustainability + sanitation)

- Task Force Mobile App (public safety engagement; Trust Fund budgeted)
- Remove Lock Take Campaign (crime prevention + awareness)
- 311 Streetlight Repair Promotion (infrastructure + safety reporting)

Budget & Financial Options

Option 1: Retainer Model (Recommended)

- \$3,000/month (\$36,000 annually)
- Covers all campaigns with consistency and efficiency.
- Benchmark: Industry norm (\$2,500-\$5,000/month).

Option 2: Project-Based Contracts

- \$7,500-\$10,000 per project (industry average).
- With 4-5 campaigns annually, estimated cost = \$30,000-\$50,000.
- Pros: Clear start/finish per campaign.
- Cons: More contract administration; less consistency.

Option 3: Hybrid Approach

- \$2,000/month baseline retainer (\$24,000 annually) + project add-ons (\$5,000-\$7,500 each).
- Estimated annual cost = \$30,000-\$40,000.
- Pros: Flexibility to scale.
- Cons: Requires additional approvals for add-ons.

Deliverables

- Campaign Collateral: One-pagers, FAQs, flyers, signage templates, branded digital assets.
- Press & Media Materials: Media kits with logos, photos, fact sheets, talking points (ERPR handles pitching/distribution).
- Community Engagement Tools: Spanish Tiles Owner Packet, Recycling and Remove Lock Take flyers, 311 repair campaign graphics, Task Force App content.
- Digital Presence: Landing pages, social media calendars, BoC social media packets, short videos/reels, newsletters.
- Measurement & Reporting: Monthly metrics dashboards, committee-specific updates, year-end ROI report.

Recommendation & Impact

ERPR excels at media relations, managing press relationships, and securing coverage. However, their scope does not include the creation of visuals, marketing collateral, or campaign execution. A dedicated Marketing Consultant will fill this gap by producing professional, branded materials and digital content.

Together, ERPR and the Marketing Consultant create a comprehensive communications system:

- ERPR = Media Relations (earned/shared narrative, press engagement)
- Marketing Consultant = Visuals & Collateral (owned/paid assets, campaign execution)

Impact:

- Meets budget requirements by executing the \$7,500 Trust Fund allocation for Task Force App marketing.
- Fulfills directives from multiple committees (Livability, Security & Enforcement, Security-Livability, Infrastructure).
- Provides Commissioners with ready-to-use social media packets to extend campaign reach.
- Ensures professional, consistent, and efficient communications across all initiatives.
- Demonstrates accountability and visibility for appropriations.
